#### Those old theater chairs are gone

Gone but not forgotten are the old red theater chairs that once lined the walls of the main hall at Whitepine Grange #102. The chairs had been there for decades, having been re-homed from the old Masonic Temple in Thompson Falls many years ago. Most of the chairs were falling apart and had holes in the upholstery.

We tried selling them on eBay, Craig's List, and Sanders County Online Yard Sale



and had no bidders, even at near give-away prices. Finally we decided to gift them to anyone who'd take them out of there. Maurita Crew, Adventist School principal, offered to take several sets for an old barn she's fixing up on her Trout Creek farm. The remaining chairs were claimed by a man from Libby. It was quite a chore to disassemble them sufficiently to get them out the door. He intends to fix them up, reupholster them in bright yellow, and then...well, he's not sure!

#### "Friends of Whitepine Grange" are valued at times like these

The March 17 "Friends of Whitepine Grange" organizational meeting was, of course, cancelled due to the COVID-19 advisories, but this is only a "pause" button in our ongoing program to rejuvenate Whitepine Grange as a neighborhood community center.

#### Here is the plan to form our group:

- 1. Reschedule an organizational meeting when the time is right.
- 2. Designate officers for our group: a president, secretary and treasurer.
- 3. Accept cash donations to "Friends of Whitepine Grange" and open a savings account under that name.
- 4. Draft a constitution and bylaws
- 5. Apply for 501.c.3 status with the IRS.
- Actively pursue major fund-raising to pay for improvements to the building. These will include things like a new roof, new siding, porch and railing maintenance, interior

painting, installation of LED fluorescent lighting, kitchen remodeling, bathroom reflooring, basement cleaning, new signage, landscaping and more. These will be labors of love funded by donations and completed by volunteers. The result should be the refurbishment of an historic neighborhood building that will serve future generations as it has served preceding generations for many decades.

As a reminder....you don't need to pay dues to be considered a "Friend of Whitepine Grange," as this group is not directly affiliated with the official Grange organization. All you need is an active interest in this community project.

### "So, who actually owns the Whitepine Grange building?"

The building at 9 Faro Lane in Trout Creek is actually owned by the Montana State Grange. Should the Whitepine Grange organization fail to maintain its required minimum membership of 13 paid members per year, the state organization can close the building or simply sell it.

Upkeep and maintenance of the building are the sole responsibility of members of local Whitepine Grange 102. They receive no financial assistance for this from the state or national Grange organization. Because Grange membership has dwindled all over the country in recent years, more and more Granges are "folding." Whitepine Grange 102 still has sufficient membership (barely) to stay active. It is responsible for paying its own insurance, utility bills and maintenance expenses. By national Grange regulation, all current membership dues (\$30/year) go directly to the national organization. No money is retained at the local level. Hence, Whitepine Grange 102 must generate its own income in order to pay the bills. With the building in its current state of disrepair, it's difficult to attract enough renters to even pay the light bill.

Grange. Those classes helped young puppies learn how to get along with other dogs in other environments...excellent developmental training for a guard dog like Artreyu who will grow up to be 180 pounds!

Puppy classes like these at the Grange are on hiatus as we await the end of the COVID-19 restrictions.

Hence the need for a separate supportive group like "Friends of Whitepine Grange." As a "Friend," you can work from the outside, without joining the actual Grange, to raise funds and help with the upkeep and repairs necessary on the building itself.

Working together, we can establish ourselves as a 501.c.3, meaning we can seek and/or make tax deductible donations. The public is always more likely to donate to an organization that has established itself as a legitimate tax-exempt group. Whitepine Grange 102 is NOT a 501.c.3, but "Friends of Whitepine Grange" can easily become one. (See our plan on page 2.) This will greatly enhance our fund-raising efforts and we'll be able to afford those costly repairs that the historic building desperately needs.

The building at 9 Faro Lane is more than an historic landmark. It has "good bones" and can serve another several generations of Whitepine and Trout Creek neighbors if we work together to provide it some TLC.

Until the time when "Friends of Whitepine Grange" becomes a 501.c.3, you can still make donations (they just won't be tax deductible) and send them directly to Whitepine Grange 102, c/o Peggy Carlson, the treasurer. Rest assured your donations will be well spent in a "most needed" priority.
