## **Photography Terms & Conditions**

Effective as of **July 24, 2025**

### **1. Booking & Payment**

A non-refundable retainer of 50% is required at the time of booking to secure your session date and time.

The remaining balance is due 48 hours prior to your scheduled session.

Bookings are not considered confirmed until the retainer has been received and a session agreement has been signed.

### **2. Cancellation & Rescheduling**

If you need to cancel your session, please notify us at least 72 hours in advance.

Retainers are non-refundable, but with at least 72 hours' notice, your session may be rescheduled once at no additional cost (subject to availability).

No-shows or cancellations within 72 hours of the session will result in forfeiture of the retainer.

### **3. Client Responsibility**

It is the client's responsibility to arrive on time and prepared (wardrobe, hair, makeup, props, etc.).

Any delay will reduce the time available for the session without a refund or additional images.

For outdoor sessions, the photographer will make a final call on postponement due to weather at least 4 hours before the session.

### **4. Image Delivery**

Edited images will be delivered in an online gallery within 2-3 weeks of the session.

A set number of edited, high-resolution images are included in each package. Additional images may be purchased at the listed rate.

Raw (unprocessed) files will not be provided under any circumstances.

## **5. Creative Control**

The client agrees to trust the photographer's artistic vision and editing style.

Specific requests may be considered, but the final selection of images and edits is at the discretion of Perspectiva Photography.

Minor retouching (blemishes, lighting adjustments) is included; extensive retouching may incur additional charges.

## **6. Copyright & Usage**

All images are the copyrighted property of Perspectiva Photography.

Clients receive personal usage rights - you may share, print, and display your images for personal, non-commercial purposes.

Images may not be sold, altered, or used for commercial purposes without prior written permission.

Perspectiva Photography retains the right to use images for portfolio, social media, website, marketing, and promotional purposes unless otherwise requested in writing.

## **7. Limitations & Liability**

In the unlikely event of photographer illness, equipment failure, or unforeseen circumstances, Perspectiva Photography will reschedule or refund any payments received.

While every reasonable effort is made to provide high-quality service, we are not liable for circumstances beyond our control (e.g., weather, venue restrictions, late arrivals).

Liability is limited to the amount paid for the session.

## **8. Model Release**

By booking a session, you grant permission for Perspectiva Photography to use your likeness in promotional materials, unless you submit a written request for privacy at the time of booking.

## **9. Agreement**

By submitting payment and booking a session, the client agrees to these terms and conditions. A formal contract reflecting these terms may be signed digitally before the session date.
