# Examples of Single-Use/Disposable/Single-Client Items

This document is an excerpt from the <u>Guide to Infection Prevention and Control in Personal Service</u> <u>Settings</u>. It outlines common single-use disposable items used in personal service settings. These are items that cannot be properly disinfected between uses or it is unsafe to do so. Personal Service	Items
Body piercing and body modification	<ul> <li>Biopsy tools*</li> <li>Closed-ended receiving tools</li> <li>Disposable clamps and forceps</li> <li>Dermal punch*</li> <li>Electrocautery/cautery tip*</li> <li>Implants (silicone, magnetic)*</li> <li>Jewellery (stud earring, hoop, ball or screw)*</li> <li>Marking pen or toothpick</li> <li>Needles and cannulas*</li> <li>Ointment applicators</li> <li>Single-use personal protective equipment (gloves, masks, gowns, eye protection)</li> <li>Receiving cork</li> <li>Scalpel blades for body modification, such as scarification, implants and surface dermals*</li> <li>Swab used to apply skin antiseptic</li> </ul>
Earlobe piercing	<ul> <li>Cartridge*</li> <li>Marking pen or toothpick</li> <li>Opened piercing jewellery (i.e., if a single earring of a pair is used, the second earring is to be given to client or discarded and is not to be reused)</li> <li>Opened unpackaged jewellery*</li> <li>Single-use PPE (gloves, masks, gowns, eye protection)</li> <li>Single-use stud holder*</li> <li>Swab used to apply skin antiseptic and ointments</li> </ul>

Personal Service	Items
Electrolysis and hair removal (including waxing)	<ul> <li>Electrolysis needles*</li> <li>Eyebrow razors</li> <li>Eyebrow-threading threads</li> <li>Lancets and needles used to remove ingrown hairs*</li> <li>Roll-on wax cartridges (to be given to client or discarded after use and not be reused)</li> <li>Single-use PPE (gloves, masks, gowns, eye protection)</li> <li>Single use removable tip/cap</li> <li>Swab/applicators used to apply skin antiseptic and ointments</li> <li>Paper (used to cover the waxing bed and table)</li> <li>Plastic sheaths (used to cover cords)</li> <li>Waxing applicator sticks</li> <li>Waxing strips</li> </ul>
Hairdressing and barbering	<ul> <li>Applicator used to apply styptic powder or liquid to stop bleeding</li> <li>Gloves</li> <li>Hair threading or weaving needles</li> <li>Neck strip</li> <li>Single-use crochet hooks for cap highlights</li> <li>Single-use disposable razors and/or blades</li> <li>Styptic products</li> </ul>
Manicure, pedicure and nail treatments	<ul> <li>Abrasive pads for removing calluses</li> <li>Callus blades (credo blades)</li> <li>Buffing blocks</li> <li>Emery boards (paper or foam)</li> <li>Foam flip flops</li> <li>Orange or wood sticks</li> <li>Pumice stones</li> <li>Single-use PPE (gloves, masks, gowns, eye protection)</li> <li>Sponges</li> <li>Toe separators</li> </ul>

Personal Service	Items
Tattooing and micropigmentation	<ul> <li>Bandages to cover tattoos</li> <li>Cups and liquids used for rinsing between colours</li> <li>Disposable ink caps (see chapter 5.5, Safe Use and Storage of Products Used on Client)</li> <li>Elastic bands used on equipment or instruments</li> <li>Lubricant applicators</li> <li>Needles (purchased pre-packaged or after needles attached to needle bar on site (i.e., soldering))*</li> <li>Needle cartridges*</li> <li>Plastic sheaths (used to cover the tattoo machine, cords, power supply, bottles)</li> <li>Purchased pre-packaged sterile needles*</li> <li>Razors</li> <li>Rinsing cups</li> <li>Single-use needle bars</li> <li>Single-use PPE (gloves, masks, gowns, eye protection)</li> <li>Stencils</li> <li>Swabs used to apply skin antiseptic</li> <li>Top hat grommet</li> <li>Water mixed with tattoo inks</li> <li>Wipes, tissues, and dental bibs used during procedure</li> </ul>
Other personal services (e.g., makeup, facials, tinting, eyelash extensions, colonics, floatation)	<ul> <li>Applicators for tint, makeup, and ointment</li> <li>Bags used for paraffin wax treatments</li> <li>Colonic speculum and tubing (both waste and water)</li> <li>Ear plugs</li> <li>Lancets or needles used for facial extraction*</li> <li>Microblades*</li> <li>Microneedle rollers*</li> <li>Paraffin wax and waxing applicators</li> <li>Single-use PPE (gloves, masks, gowns, eye protection)</li> <li>Slippers or foot covers for client during procedure</li> <li>Unused decanted products (e.g., lotions, creams, wax, eye lashes, makeup)</li> </ul>

\*These items are to be sterile prior to use (packaged sterile or sterilized on-site).
