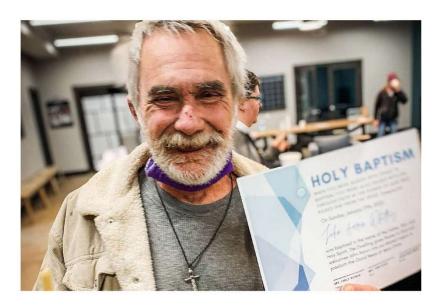

Arlene Dressler for Council (3 years): I moved to Sun City, California June 15, 1993. I became a member of Faith Lutheran Church in December 1993. Retired as a bookkeeper and an accountant from civilian companies in 1990. I have served in many committees here at FLC, Stewardship, Fellowship and as a Greeter. At the present time I am the treasurer of WELCA, and previously served as Co-Vice President and Secretary and President on the WELCA Board. While in Juneau, I attended the University of Alaska, taking classes in Alcohol Studies and counseling. Dear Members of Faith,

The year 2021 has been a year of learning and a wonderful experience for me since Gale Eury and I accepted the roles of Co-Presidents for the church council. Our Council has had a lot of trials, compromise and looking outside of the box for innovative ideas and solutions due to COVID-19. At the beginning of the year, we attended our Annual Congregational Meeting on Zoom. We started the year off with our drive-in services using our FM car radios. We returned to in-person worship starting with half the congregation on May 9th and on June 6th everyone was invited to attend Sunday Service in Church without fellowship. We also started in June to have small group committee meetings in the church. In September we started Fellowship to Go at least once a month and continue with this now.

Three new Ministry Committee Groups were formed this year.

- * 4 Plus 1 Group: Christ being the One (Prayer and generosity-based conversations).
- * Call to Prayer & Worship Group: People who do not have access to a computer, can use the phone for prayer and worship.
- * Remembering and Honoring Group: Meeting with Pastor John to reminisce our loved ones.

We had two new member classes this year. Six new members were welcomed to our church in May: Madison Hamilton, Kally Homchick, Kim "Sarge" Hunter, Patsy Loughboro, Andrew Quinn, and Jean Zeidler. Four new members were welcomed to our church in November: Ron Biggs, Thelma Dyal, Connie Gibson and Diane Swarts.

September's "God's Work. Our Hands" was a success this year. We had volunteers purchase hygiene items and help assemble our kits. We donated 60 Hygiene Kits to the Menifee Police Department to distribute to the homeless in our community.

This year our W-ELCA group had a Christmas Party with a Purpose. We put together homemade gift bags for our homebound members.

A group of us did Christmas Caroling and visited eight of our church members' homes.

Our congregation's members donated \$500.00 in Target gift cards to purchase electronics that were given to a children's home for youngsters who are awaiting foster care.

Thank you to all who served on our committees: Education, Endowment, Fellowship, Finance, Mutual Ministry, Outreach, Property, Service, Stewardship, W-ELCA & Kitchen and Worship & Music. We need new people on all committees. You can help by using your talents to serve or donate time in some way to help Faith Lutheran Church to continue to grow and serve God and our Community.

PASTOR BARTON'S ANNUAL REPORT 2021

She never left the temple but worshiped night and day, fasting and praying. Coming up to them at that very moment, she gave thanks to God and spoke about the child to all who were looking forward to the redemption of Jerusalem.

Dear faithful friends and fellow children of God:

Faith and focus, patience and perseverance.

My message in last year's Annual report was all about God's continued presence in our lives in the face of the pandemic. God's presence continues to remain true and needed in our lives this year as the pandemic has progressed. Fortified by God's promises of accompaniment and hope, our congregation has adapted, innovated, and stubbornly marched on in faith this last year. We give thanks for God's continued presence and we persevere on, continuing to do God's work with our hands. Some highlights of what our congregation has done this year are:

- * Registered our youth and began planning for the National Youth Gathering in Minneapolis, MN July 2022.
- ❖ We adapted our worship style to continue worshiping, transitioning from worshiping in-person in our parking lot to returning joyfully and safely inside to our sanctuary. We had our Reopening Indoor Worship on May 9.
- * We resumed many ministries face to face and drew closer together as we reacquainted ourselves with our fellow faith members as well as new friends including two new member classes.
- ❖ Several members and I participated in a multi-church education program called "Dialogues on Race," where we engaged faith with fellow Lutherans in facing the problem of racism. One of the immediate results has been the reinvigoration of Outreach and how we can be more welcoming to more people.
- ❖ We had two baptisms, the first ones I have presided over. I had the joy and honor of baptizing baby Linus Butler on Palm Sunday and Andrew Quinn on Easter Sunday. I also officiated my first wedding in Arizona in November.

- On Reformation Sunday, we welcomed new members and we heard Martin Luther (who looked very similar to David Moe) read his speech from the Diet of Worms.
- ❖ And we have begun two large, exciting possible ministry opportunities. The first is refinancing our mortgage to make large repairs and improvements to our church property and building. The second is working with our city to explore selling the dirt lot behind the church. The lot would become a park and the proceeds of the sale would allow us to dream and expand current and new ministries.

All of these events, actions, and ministries have proved our perseverance and persistence in faith in the face of the ongoing pandemic. We have proved that the pandemic cannot keep us from praising God or living in ministry. We have chosen to adapt, to change, even to postpone some of our "normal" activities in the cause of loving our neighbors and promoting proper safety. However, even those paused activities are what we are hoping to resume this year, as long as we can do them safely. We hope to take further steps towards normalcy in fellowship, music leadership, and other ministries, which have seen less activity in the pandemic. Faith and focus, patience and perseverance: this is our way. This is what God has taught us and our ancestors in faith, ancestors like the New Testament prophet, Anna.

The story of Anna is seemingly small, only a couple of verses long and nestled into many other, seemingly bigger stories. However, there is much we can learn from those three verses. Namely, after so much happening in her long life, she still praises God and finds her vocation in helping and leading at her house of worship. She does not let widowhood and the loss of her partner distract her. Instead, through faith and focus, she dedicates her life to helping others in faith and, in doing so, she finds her Savior. We cannot all be prophets like Anna; we cannot all live exactly as she did. In fact, we are not meant to live "exactly" as anyone else. But Anna gives us a vision, a prophecy, if you will, for the future our future. Her vision and lessons for you and me today are ones of perseverance, hope, and not letting societal expectations around experience or age or gender or relationship or anything else hold you back from leading and contributing in faith. Anna did not let anyone tell her, "Oh, you're just an old widow who doesn't know anyone or go anywhere; you can't do this job at the temple." No. Anna broke through those barriers. She met new people every day: she learned new ways to help every day, even into her advanced years. And she kept doing it and giving thanks to God and eventually became one of the first proclaimers of the Gospel message that Jesus, the Redeemer of Jerusalem and the world, had arrived on Earth to save us all.

Anna's faith and focus, patience and perseverance pay off, and God rewards her faithfulness with more faithfulness. Anna sees the advent of God's everpresence, Jesus' arrival, the beginning of his time to change and save us all. And so God and Anna are speaking to you right now, offering you the same advice of faith and focus, patience and perseverance as well as the same opportunity which Anna had, to serve in faith and help those around you in new and old ways, in new and old people. This is our vision for the coming year in ministry. Anna proves that at any time in life, you can defy expectations, you can overcome loss and grief, loneliness, and advanced age - to do all of this and do God's extraordinary work with your own actions. As another pastor wrote in response to Anna's story: "God is always faithful. God might call us to a new vocation at any age. God will use the whole path of our lives to help bring in God's kingdom." In this theological mindset, I offer this prayer: O God, give us grace to set a good example to all among whom we live, to be just and true in all our dealings, to be strict and conscientious in the discharge of every duty; pure and temperate in all enjoyment, gracious and generous and courteous toward all; so that the mind of Jesus Christ may be formed in us and all may know that we are his disciples; in whose name we pray. Amen.

God gives us the gifts of faith and focus, patience and perseverance. I believe through these gifts, we can fill this next year with joy, we can satisfy more of our desire to return to normalcy, and we can forge more what faith looks like in our new day and age. In all of this, we ask God to help and guide us.

I continue to give thanks for all of you, for your continued faithfulness, and for the great honor of serving as your pastor. So, until we see each other again: "May the Lord bless you and keep you; may the Lord make his face shine on you and be gracious to you; may the Lord turn his face toward you and give you peace." (Numbers 6:24-26).

EDUCATION COMMITTEE REPORT ANNUAL REPORT 2021

Dear Faith Family,

New Year Greetings from the Education Committee.

We continue educating our church members and youth, as best as we can under the difficult circumstances that we all find ourselves in, with the ongoing pandemic in our world.

You might know that this past Fall we began to hold in-person Sunday School classes for our kindergarten and elementary age children, but we only had classes for a brief period of time. Then, after prayerful consideration, we chose to stop having in-person Sunday School again due to the rise of illness in our local community, as a result of the Covid-19 pandemic. But, we did not abandon our church youth and we have continued to reach out to our young church members by sending various religious educational items via the US mail to their homes. We have sent items such as: Bible based coloring books, Bible word search books, Bible story books, and Advent season calendars and daily devotionals.

We celebrated this past year when another one of our young church members graduated High School, and continued blossoming into a beautiful young adult.

This year, our Church family teenagers have been studying and learning with Roderick Sinclair as their primary teacher, and Amy Sinclair as a substitute teacher on occasion. Beginning this past fall 2021, they have been meeting inperson on Sunday mornings for Confirmation class. The youth in Confirmation class have continued studying with Lutheran curriculum, learning about the Bible, as well as Lutheran theology. Earlier in the year they finished the curriculum handbook "Collaborate Unit 2, Lutheran History and Catechism." They are currently using the "Collaborate Lutheran Confirmation curriculum handbook, Unit 3, The New Testament." We are hopeful that our teenage Confirmation students will finish their studies and be prepared to be Confirmed in the Lutheran Church, sometime within the next year.

Looking forward; we are excited and hopeful about the ELCA National Youth Gathering in July 2022. If the Gathering goes ahead as planned, our church congregation is sending three of our teenagers, along with two adult chaperones to the conference. The Gathering will be held in Minneapolis, Minnesota at the end of July. The students will be conducting fundraisers throughout the spring

of 2022, in preparation for attending the youth conference. We welcome your contributions and hope you will participate as much as you are able.

Our adult education this last year consisted mainly of Pastor John Barton leading twice monthly Bible studies for the whole congregation and teaching the Women of the ELCA Bible study leaders group each month. In addition, the Women of the ELCA Bible study circles have continued meeting monthly, with both inperson and virtual video Bible study groups.

May we all continue to learn and grow in Faith.

ENDOWMENT FUND ANNUAL REPORT 2021

According to Faith's constitution, "the Endowment Fund provides a means for receiving and managing gifts, memorials, and bequests in accordance with the desires of the donor and the constitution and bylaws." The members of the Endowment Board endeavor to be faithful stewards in their decision-making.

The year 2021 was a year of transition for the board. Thanks go to David Moe and Tex Culp for serving as chairperson and treasurer respectively during the first portion of the year. When duties called them elsewhere, the board was reorganized in May with Pat Adams as chairperson; Caroline Ogden as secretary; and Loni Knowles as treasurer. Pastor Barton continued serving as an ex officio member without vote. In order to bring the financial records up to date, Loni spent considerable time researching past records and consulting with other knowledgeable individuals. Mike McGavran developed a spreadsheet for tracking the finances efficiently. At the October meeting, he educated the entire board on the working of the system. Mike's helpful presentation was recorded so that current members could review it and so that future members could benefit from that information.

In July, the board awarded a total of \$2500 in scholarships to two students at Pacific Lutheran Theological Seminary: Charbel Zgheib and Samantha LaDue. By applying to the Congregational Partners in Education Program for matching funds, the board was able to have that amount doubled. Looking ahead to the 2022-2023 school year, the board made plans to spread the word about the online scholarship form found at Faith's website.

Continuing in transition mode, the board benefited from the expertise of Lisa Higginbotham, the ELCA Region 2 Gift Planner, who gave presentations about

investment choices regarding gift planning and endowments. Since Thordis Moe was considering the invitation to join the board, she attended those meetings also. Plans were made for Lisa to return in 2022 to share information about best practices and legacy giving.

The board remains grateful to Faith members who made contributions to the Endowment Fund during 2021. Going forward, the congregation is reminded of this stewardship opportunity.

FINANCE COMMITTEE ANNUAL REPORT 2021

We started the year thinking it would be a slow climb out of the COVID hole until normalcy returned in the Fall. Sadly, we learned that a return to full normalcy is still in our future. However, progress has been made with in-person Worship services resuming in mid-June. As a congregation, we've learned to adapt, and our faith has not waivered.

Last year's budget anticipated a deficit of over \$16,000. And, while we had some months where our income was below our budget, the faithfulness of our current members and the generosity of those no longer with us have made it possible to end the year with a surplus of more than \$8,900 for the year! We hope to continue this momentum into the new year, as we work to expand our ministry here at Faith.

Each month, the Finance Committee has met to review our financial reports, and to look for opportunities to improve what we do and how we do it. My thanks to Gale Eury, Kandie Hulme, Sarge Hunter, Bea Olsen and Pastor John for their time and attention to detail throughout the year, and to Evelyn Bosinger for her help with some special projects. As a result, here are a few things we got done.

- Developed procedures for handling Memorial gifts.
- Applied for and received a matching funds grant of \$850 from the Synod to upgrade our technology in support of our ministry during the pandemic.
- Implemented a Contracts Administration process to ensure no important dates or obligations are missed.
- Identified and implemented replacement software for recording member donations as part of the Financial Secretary transition from Ken Borchmann to Jean Miles.
- Begun work to create a "Book of Motions" in which all important Council/Congregation decisions which have long-term implications are recorded so they are not overlooked in future years.

Financial Report

Balance Sheet Fund Balances – These 2 pages show the ending balances for our various fund accounts for the year just ended, the previous year, and the change.

- 1000.08 New Pastor Reserve Fund Originally set up to cover moving/startup costs with Pastor's Call, the unused monies are being used for special projects. The \$1,062.32 amount was used for various small needs, such as Bibles for new members, etc.
- 2000.02 Property Fund This account is used for various property related needs, such as the recent bush/tree trimming. It's also used to pay the

property taxes on the Cell Tower while we wait for reimbursement from Verizon.

- 2000.03 Prop'ty Long Term M't This account is used for significant property expenses, such as replacing A/C units, etc. It is where half of the Verizon Cell Tower income goes until the balance reaches \$20,000, at which point all of the Verizon income goes into the general fund. The increase in the balance was due primarily to a special gift from a former member.
- 5000.04 Youth Fund The \$1,200 expense is the deposit for the National Youth Gathering scheduled for July, 2022, in Minneapolis.
- 91000.0 Provident Bank Checking This is our regular checking account.
- 9000.03 Camp/Min-Div Plus This Thrivent investment account is being used to supplement our general fund account. Congregational approval allowed \$10,000 to be taken from the Campus Ministry monies held in these investments to help with the expected Budget deficits.

2021 Financials / 2022 Budget - These 4 pages show the 2021 Budget and 2021 Actuals (and the 2022 Budget, discussed in the next section).

- 4100.01 Offering Envelopes As you can see, our member giving was over our budgeted amount by over \$5,500 for the year. Well done!
- 4100.02 Special Offerings This account is used for special offerings such as Lent, Easter, Thanksgiving, Christmas, and other gifts such as bequests from member's estates intended for the General Fund. We budget for the special offerings, but not for bequests.
- 4100.08 Other Cash Received As previously approved, this includes the \$10,000 to be taken from the Campus Ministry investments to supplement our General Fund.
- Total Income was over budget by almost \$22,000 for the year. A significant portion of the extra income came from the estates of members who are no longer with us.
- Total expenses were over \$3,100 below budget, so combined with more income than expected, overall, we had a surplus (Net Operating Income) of over \$8,900 for the year instead of the expected loss of over \$16,000. As a result, we did not need to borrow from the Endowment fund in 2021.

2022 Budget

The Council recommends approval of this budget which was built on the following assumptions:

- Income (Envelope and Plate) is based on 100% of 2021 Actuals for Jan-Jun, 102% of 2021 Actuals for July-Oct, and 103% of 2021 Actuals for Nov-Dec.
- We're hopeful that normal Fellowship activities will resume around May.
- The Cell Tower contract calls for a 10% increase in the lease payment from Verizon in June, which is reflected in the Cell Tower income account.
- All known major Property expenses in 2022 are planned to come from the new loan proceeds. Since the long-term property account balance is over \$20,000, the entire Cell Tower payment from Verizon goes into the general fund.
- There is no money for Staffing additions in this 2022 operating budget. The intent is that such ministry expansions would be funded from the possible sale of our unused land to the City.
- Most expenses are based on 2021 Actuals. Some expenses have been adjusted based on various factors, including expenses that were abnormally low due to no in-person Worship during the first part of the year (ex. Utilities, Flowers, etc.).
- Staff raises are reflected in the budget based on employee anniversary date. The Executive Committee recommended up to 3% for Pastor and up to \$1/hr. for the Office Administrator. The Executive Committee will determine actual increases, if any, based on our financial condition at that time. If no raises are approved, the budget deficit would be reduced by about \$2,200.
- The 2022 budget contains a deficit of just over \$13,000. Approval of this budget means you approve borrowing undesignated monies from the Endowment Fund as needed, as previously approved at the 2019 Annual Congregational Meeting.
