Congress has failed miserably to be a good steward of our tax dollars. My tax-plan puts "**consent of the governed served**" in the equation. *We the People* must take control of our tax dollars to save the USA. We as a nation are heading for a Titanic calamity at the hands of the drunken sailors in D.C.

Out of Control Government Spending

Let me start by invoking the most sacred founding text, the **Declaration of Independence**, to remind Americans about the glorious founding of this great nation. "When in the course of human events, it becomes necessary for one people to **dissolve the political bonds** which have connected them with another..." don't you think America, that the time has come for *We the People* to **dissolve the political bonds which have connected us to our representatives?** As a nation, we have gone from **no taxation without representation** to **high taxation with representation**.

Our representatives are NOT our friends. Get it?

We can no longer trust our supposed "representatives" (Republican or Democrat) who sell us out to lobbyists at every chance they get. These slick-talking-do-nothing politicians pitch *We the People* against one another, while getting rich at taxpayers' expense. **Are we really that stupid to not see it?** Unlike the 1700s, we now have the technology to help us represent ourselves as individuals. The time has come – are you ready? - for **a new tax revolution: No Taxation Without SELF Representation.**

Abuse of Article 1 Section 8 of the U.S. Constitution has rendered the entire Constitution moot. The section states, "**The Congress shall have Power To lay and collect Taxes, Duties, Imposts and Excises, to pay the Debts and provide for the common Defence and general Welfare of the United States; ...**" The general welfare clause, coupled with Congress' ability to incur debt and subsequently levy taxes to pay off those debts, renders *We the People* defenseless against a tyrannical ruling class. **The 16th Amendment of the U.S. Constitution must be repealed.**

We the People will have to work together – nationally - to elect the right candidates, **starting with yours truly**, who would be willing to hand over (won't be easy, but doable) the spending power to *We the People*. To the

naysayers of my tax revolution, I say, "so glad you weren't there at the **Boston Tea Party** in 1773 and the **Crossing of the Delaware** in 1776 or we would not have this great nation."



An old documentary made by Peter Schweizer and Steve Bannon, [Boomtown](#) that was aired on Hannity in 2013 should convince you to be a part of our new tax revolution. You can scan the QR code to watch this unbelievable exposé. Things have gone much further south since this documentary aired a decade ago. The [U.S. National Debt](#) was approx. \$16 Trillion in 2013, and stands at more than \$32 Trillion in 2023. As an immigrant to this great nation, I am asking AMERICANS to wake up before it is too late. **We need to stop feeding the monster!**

Under my proposed tax plan, Congress will continue to pass spending bills as authorized in the Constitution. However, *We the People* will have the power to approve each spending item through our tax filings. This will be a radical departure from how the establishment controls our money. *We the People* also need a referendum to define the real "general welfare". Common defense and general welfare clause should be limited to the US Armed Forces, DOT, national parks, the DOJ and a temporary safety net for the needy **CITIZENS** (not for illegals) residing in the U.S. The poor are not the problem, the greedy crony rich, who are feeding off of the government, are the real problem.

Highlights of the Proposal: No Taxation Without SELF Representation

Step One

- ★ Bill must cite a Constitutional provision for passage.
- ★ Any spending bill must be written by Congress on a stand-alone basis.
- ★ Bills cannot be more than 10 pages long in a traditional format.
- ★ The title of the bill must match the content of the bill.
- ★ The vested parties, including lobbyists, elected representatives, and beneficiaries, must be clearly identified along with compensation (direct or indirect – campaign contributions) they (family and friends included) received from the vested parties. There must be **SEVERE** criminal penalties for failing to disclose ties to lobbyists.

Step Two – Time Frame

- ★ All expenditure bills must be passed by House/Senate/President by December 31st.
- ★ IRS will be required to compile expenditure bills by January 31st of the following year in a chronological order. Process automation will save time, money, and resources.
- ★ Taxpayers will then get to either approve expenditures and pay for them through their tax filing on April 15th or disapprove and reject the expenditure items.

- ★ Unapproved bills will sunset (become null and void) on June 30th.

Step Three – Taxpayer Participation

- ★ Taxpayers will be able to select either to opt-in or opt-out of each or all proposed expenditure.
- ★ Only those who **opt-in** for a proposed expenditure will be required to pay taxes for it. Those who **opt-out** of a proposed expenditure will not be required to pay taxes for it.
- ★ A minimum threshold of willing "opt-in" taxpayers' taxes must be met for a given expenditure to pass. For e.g., a \$ 100 million expenditure, capped at \$ 1,000/per taxpayer must have 100,000 opt-ins for the expenditure to pass. $\$1,000.00 \times 100,000 = \$ 100 \text{ million}$.
- ★ Opt-ins will be required to pay those proposed taxes at the time of tax filing. If the minimum thresholds are not met, the money will be refunded back to them, without interest.
- ★ For process automation to work, **only eFilers** will be eligible to participate in approval/disapproval of expenditure items. Paper filers will be automatically recorded as rejecting all expenditure.
- ★ Late filers will not be eligible to approve/disapprove expenditures.
- ★ Each new active expenditure bill will have to be presented to the taxpayers for approval every year and restart the process.

Advantages to the Taxpayers

- ★ This plan will force the federal government to **prepare budgets** in advance.
- ★ Will **eliminate baseline budgeting** as each department will have to live within the means of their allocated budgets.
- ★ Many **bloated federal bureaucracies** will be eliminated or consolidated.
- ★ Will eliminate the need for **short-term spending resolutions**.
- ★ Prevent a last-minute **"financial crisis."**
- ★ We can start the process of paying down the **national debt**.
- ★ Personal income tax should be limited to a **10% flat tax** with only mortgage deductions (including principal) allowed.
- ★ From the 10% flat tax, the federal government will have to **fund only the common federal expenditures**. States will pick up the tab for state spending. Local needs must be met locally.
- ★ Maxtaxtomy™ puts the spending power back where it belongs, with *We the People*, **NOT the lobbyists**.
- ★ **Repeal** of Maxtaxtomy™ should be possible only with 90% of the citizens willing to give spending power back to the representatives.
- ★ Without money and power to the crooked representatives, we will automatically dry the swamp and get **TERM LIMITS**.
