General Information

Matrix AMS is a specialized formulation of water conditioners designed to enhance the performance of many herbicides. **Matrix AMS** is designed primarily to be applied with herbicides which utilize glyphosate as the active ingredient. **Matrix AMS** is also suitable and effective for most pesticides and nutritional products which can be used with water conditioner type adjuvants. **Matrix AMS** can positively affect both pesticide spray application and pesticide efficacy. **Matrix AMS** can eliminate the antagonistic effects of hard water on herbicide efficacy. Contains 4 lbs of ammonium sulfate solution per gallon.

Directions for Use

FOR USE WITH HERBICIDES REGISTERED FOR: AGRICULTURAL, FORESTRY, INDUSTRIAL, MUNICIPAL, ORNAMENTAL, RIGHTS-OF-WAY, TURF, NONCROPLAND AND OTHER USES.

Matrix AMS may be applied by ground, or aerial spray equipment.

Glyphosate tank mixes: 2.5-5% v/v or 2.5-5 gallons per 100 gallons of spray solution.

Other tank mixes: 1-3 quarts per acre. 3 quarts is equal to 3lbs. of dry Ammonium Sulfate.

Rates may be adjusted as water conditions vary. The use of pH measuring device is recommended to determine a suitable **Matrix AMS** rate. Do not add adjuvant at a level that would exceed 5% v/v of the finished spray volume.

Mixing

1. Fill spray tank one-half full with water and begin agitation.
2. Add **Matrix AMS** first and continue agitation.
3. Add pesticides and/or fertilizers as directed by each product label or in the following sequence:
 - a. Micronutrients and fertilizers
 - b. Dry flowables and water dispersible granules
 - c. Liquid flowables
 - d. Water soluble pesticides
 - e. Emulsifiable concentrates
 - f. Glyphosate
4. Continue agitation and complete filling of the spray tank.
5. Do not mix **Matrix AMS** with undiluted pesticides.
