

## Cornhole Idaho - Release of Liability

Release executed by:

**BOTH** PLAYERS OF REGISTERED TEAM, hereinafter referred to as “Releasor(s).”

In consideration of being permitted to participate in the Cornhole Idaho, Corn Ho Ho Hole cornhole tournament. Releasor(s), for [himself/herself] and [his/her] personal representatives, heirs, and next of kin, releases, waives, discharges, and covenants not to sue Cornhole Idaho, its officers and members from all liability to the Releasor(s), [his/her] personal representatives, assigns, heirs, and next of kin for all loss or damage, and any claim or damage therefor, on account of injury to the person or property or resulting in death of the Releasor(s), whether caused by the negligence of Releasees or otherwise while the Releasor(s) is participating in the Tournament.

Releasor(s) agrees to indemnify the Releasees and each of them from any loss, liability, damage, or cost Releasees may incur due to the presence of Releasor(s) in or around the property known as the Fairview Tech Building (8740 Fairview Ave, Boise, ID 83704) including the parking lot adjacent thereto, whether caused by the negligence of the Releasees or otherwise.

Releasor(s) assumes full responsibility for and risk of bodily injury, death, or property damage due to negligence of Releasees or Fairview Tech Building (8740 Fairview Ave, Boise, ID 83704) including the parking lot adjacent thereto, and/or while competing, officiating in, working, or for any purpose participating in the Tournament.

Releasor(s) agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Idaho and that if any portion of the agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Releasor(s), being of lawful age, in consideration of being permitted to participate in the Tournament, does for [himself/herself], [his/her] heirs, executors, administrators, and assigns, hereby release and forever discharge Cornhole Idaho, its officers and members from any and every claim, demand, action, or right of action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death, and/or property damage resulting or to result from any accident which may occur as a result of participation in the Tournament or any activities in connection with the Tournament, whether by negligence or not.

Releasor(s) further states that [he/she] has carefully read the above release and knows the contents of the release and signs this release as [his/her] own free act.

Releasor(s) further releases all officials and professional personnel from any claim whatsoever on account of first aid, treatment or service rendered [him/her] during participation in the Tournament.

This release contains the entire agreement between the parties to this agreement and the terms of this release are contractual and not a mere recital.

Release of liability will be in affect from the date/time of registration until after close of tournament.
