- (a) We ask for two traveling party contact numbers in case of loss/theft/low battery. We have found that when on holiday, parties often turn off their work phone, whereby we are unable to make contact.
- (b) On occasion, the person making the travel arrangements is NOT the person(s) being chauffeured. If the booking is to be invoiced to a company, please provide this information at **2. Contact details** on the form.
- (c) Only the number of passengers stated on the booking form can travel during the outbound/inbound journeys. Additional passengers are NOT covered on our insurance policy. Any amendments to the booking for can be made up to 48 hours before travel, this must be confirmed by email by the company, to validate the insurance.
- (d) In the UK, while the general law requires all children to use an appropriate car seat until they are 12 years old or 135cm tall, there are specific **exceptions for licensed taxis and private hire vehicles (PHVs)**, including chauffeur services.

Legal Obligations for UK Chauffeur Businesses

- **No Obligation to Provide:** Chauffeur (private hire) companies are not legally required to provide child car seats or booster seats, although it is strongly recommended for safety.
- **Driver Responsibility:** The driver is legally responsible for ensuring passengers under the age of 14 are correctly restrained in accordance with the law, using available equipment.

Safety experts emphasize that using a child car seat is considerably safer, and offering or requiring clients to bring car seats is vital for safety.
