Please see the AKC Regulations for Agility Trials for current class descriptions. Dogs must be entered only in Regular Classes or Preferred Classes with no crossover between them allowed at the same set of trials.

Dogs Eligible to Enter / Participate

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs disfigured as the result of accident or injury but otherwise qualified shall be eligible provided that the disfigurement does not interfere with functional movement. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible. Blind means without useful vision and deaf means without useful hearing. No dog shall compete if it is taped or bandaged or in any way has anything attached to it for medical purposes.

Bitches in season shall not be eligible to participate. Entry fees for bitches in season may be refunded at the Club's option. The premium list must state whether refunds will be issued for bitches in season. Please see **Refund Section**.

Measuring and Height Card Information

If your dog does not have a Temporary o Permanent Height Card, or if your dog has turned two years of age, since getting your Temporary Height Card, your dog NEEDS to be measured.

All dogs competing in agility must possess an official AKC Jump Height Card. Dogs that do not have a valid Jump Height Card <u>must</u> be measured by a judge of record for that trial and will only be effective for that set of trials, excluding the dogs jumping in the 24-inch division.

If an official measurer is present, all dogs that have not been issued a Permanent Jump Height Card or Temporary Jump Height Card (yellow form) must be measured for a Jump Height Card regardless of the jump height entered.

If there is not an AKC Field Rep or VMO in attendance, all dogs that have not been issued a Permanent Jump Height Card or Temporary Jump Height Card (yellow form) may still compete; however, they must be measured by a judge of record for the trial, prior to running at each trial. The judge's measurement will be valid for this trial or back-to-back trials only.

If a dog is measured by an AKC Field Rep or VMO and is now eligible to jump in a lower height class, the measurement is effective <u>immediately</u> for any <u>future runs</u>. <u>This</u> does not apply to a challenged measurement for a Permanent Jump Height Card.

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process.

It is the sole responsibility of the Exhibitor to have their original, official Jump Height Card or Temporary Jump Height Card (yellow form) at each trial to present upon request. Additionally, if a measurement is necessary, it is the Exhibitor's responsibility to have their dog measured prior to running. Regulations for Agility Trials, Chapter 2, Section 4.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge or barred from competition by action of Trial Committee. If because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or to complete the trial, no refund of entry fees will be made.

REFUNDS: There shall be no refunds for entries withdrawn in the event a dog and/or handler is absent or dismissed from competition, regardless of the reason for such dismissal. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or complete the show, no refund of entry fees will be made.

Withdrawals after the closing date due to change in judge will receive a full refund per Chapter 1, Section 9 in the Regulations for Agility Trials

BITCHES IN SEASON are not eligible to participate. Entry fees will be refunded subject to a \$5.00 processing fee. Written verification from a Veterinarian is required. Notification for refund of bitches in season must be RECEIVED no later than 48 hrs. after end of the trial. A Veterinarian's note AND final trial confirmation for dog must accompany any such refund.

Refunds after closing date are permitted if the club is offering a waitlist. If a withdrawn entry is replaced by a waitlisted entry, a full refund will be issued for the withdrawn entry. If the withdrawn entry after closing cannot be replaced, no refund will be due.

Trial Regulations Notice to Exhibitors

THE TRIAL will be open from 7:00 a.m. until 30 minutes after the last run of the day. **TRIAL COMMITTEE** will use due care and diligence for the welfare of dogs and Exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or Exhibitors participating in this show.

THE SAFETY OF THE DOGS is our primary concern. By entering this trial, Exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all the obstacles safely.

DOGS MAY ARRIVE any time prior to judging, if the dog does not need to be measured. Otherwise, they must be available for measuring before their class begins.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

Practice Jump: A practice jump may be provided for Exhibitors to warm up
Course Walk Throughs: Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings, may request to walk with a height group other than the one their dog is entered in if a conflict is imminent. Umbrellas are not permitted during the walk-through

Exhibitors should follow their Veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

According to New York State Law, Rabies vaccination and dog license are mandatory.

For example, dog jumps 24" at one trial, then 26" in the next trial.) Then, please review your confirmations carefully to ensure that your requested changes have been made.

For overnight delivery, signature waiver - Please remember to check the No Signature Required box <u>AND</u> sign that spot where you authorize them to deliver.

Move-Up Deadline: Remember that the move-up deadline for your first day of a weekend trial is ALWAYS **Monday at 6:00 pm**. Please send those move-ups in right away.

Move-up Clarification

As per Chapter 1

Section 20. Move-ups. Move-ups prior to a set of trials: Dogs shall be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is made in writing to the Trial Secretary not later than 6:00 p.m. on the Monday preceding the set of trials for trials starting on a Thursday-Sunday.

Day-to-Day Move-ups: Move-ups from day-to-day at a set of back-to-back agility trials shall be at the discretion of the club. The request for moving up must be made in writing at the trial site to the Trial Secretary not later than the day preceding the event.

Novice Information: Dogs having attained their first AKC Agility title (STD, JWW, <u>T2B</u>, or FAST) must be moved to the Novice B class (STD, JWW, or FAST) for all trials for which entries have not closed. If entries have already closed on the date the dog obtained its title, the dog shall remain in the class in which it was originally entered or be moved up in level (i.e., Novice to Open) at the request of the owner; subject to the move-up criteria, except as stated in Chapter 1, Section 21 regarding Novice A entries.

Section 21. Entry of Ineligible Dog. A dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from a Novice "A" class to the Novice "B" class.

Day-To-Day Move-Ups: The club is accepting Day-to Day Move-ups for this Trial. The request for moving up must be made in writing at the trial site to the Trial Secretary not later than the day preceding the event.

EMAILED MOVE-UPS: When emailing a move-up, please provide the following information. **TRIAL NAME**, Owner Name. Dog Call Name, Move up for what days (from – to etc.), Move up for what classes, (from- to) (PLEASE include STD, JWW)

Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day. A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On

Fix and Go On (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

For Exhibition Only

Entering For Exhibition Only (FEO)

As of January 1, 2020, and amended on July 1, 2024, **Section 21. For Exhibition Only.** At the option of the club, a handler may choose to change <u>any class entry</u> into a For Exhibition Only (FEO) run. The handler must notify the scribe and the judge as they enter the ring prior to the start of the run that they are doing an FEO run. The scribe sheet shall be marked "FEO", no time "NT", and "E" for an excused, non- qualifying run. <u>Maximum Courses Time for FEO shall be 45 seconds for all classes, except for FAST which will use the set FAST course times</u>. Allowing FEO runs is at the option of the club. <u>Clubs must allow ALL classes to be run as FEO if they choose to offer this option</u>. It must be stated in the premium and any pre-trial publications. <u>Participation in FEO is non-qualifying</u>.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring (Toys must be non-audible, may not leave the handler's hand, and toys that roll freely cannot be used)
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time.
