Please see the AKC Regulations for Agility Trials for current class descriptions. Dogs must be entered only in Regular Classes or Preferred Classes with no crossover between them allowed at the same set of trials.

Dogs Eligible to Enter / Participate

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes. Dogs disfigured as the result of accident or injury but otherwise qualified shall be eligible provided that the disfigurement does not interfere with functional movement. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible. Blind means without useful vision, and deaf means without useful hearing. No dog shall compete if it is taped or bandaged or in any way has anything attached to it for medical purposes. Bitches in season shall not be eligible to participate. Entry fees for bitches in season may be refunded at the club's option.

Entries and Fees Information

ENTRY FEE: 26.00 for the first entry of a dog; \$20.00 for the second entry of a dog, \$16.00 for each additional entry of the same dog. This includes \$3.00 AKC recording fee for each run plus \$.50 fee for each dog)

MAKE CHECKS PAYABLE TO: SUFFOLK COUNTY KENNEL CLUB.

OPENING DATE: Tuesday, September 21, 2021 at 8:00 am at the Trial secretary address listed. Each trial is LIMITED to 330 runs.

CLOSING DATE: Friday, November 17, 2021 at 6:00 p.m., after which entries cannot be accepted, cancelled or substituted except as provided for in Chapter 11, Section 6 of the Dog Show Rules and in Chapter 1, Section 13 of the AKC Agility Trial Rules and Regulations.

MAIL ALL ENTRIES to SCKC c/o Long Island Trial Services, 250 River Ave Apt 161, Patchogue, NY 11772. If you send overnight delivery, please remember to sign the signature waiver. Envelopes/transactions cannot have entries for more than (10) dogs maximum.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee. If because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or to complete the trial, no refund of entry fees will be made.

REFUNDS: Please see the special section on COVID-19 policies and procedures for more information. **Withdrawals after the closing date due to Change in judge will receive a full refund per Chapter 1, section 9 in the Regulations for Agility Trials**

BITCHES IN SEASON are not eligible to participate. Entry fees will be refunded subject to a \$5.00 processing fee. Written verification from a veterinarian is required. **Notification for refund of bitches in season must be RECEIVED no later than 48 hrs. after end of the trial. A Veterinarian's note AND Final Trial Confirmation for dog must accompany any such refund.**

Refunds after closing date are permitted if the club is offering a waitlist. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. If the withdrawn entry after closing cannot be replaced, no refund will be due.

ERRORS ON ENTRY BLANKS-Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellation of entries after trial has closed.

ACKNOWLEDGEMENT OF ENTRIES will be made as soon as all entries are processed and entered into the computer. This could take 2 weeks after opening date. Preliminary confirmations will be via email either as an attachment or in the body of an email to all exhibitors who provide their email address. If you do not have an email address and want a preliminary confirmation, please send a stamped self-addressed envelope. **Final confirmations will be emailed out about one week before that trial. Consult final confirmation for the judging schedule.**

INVALID ENTRIES: (the following are considered invalid and will not be accepted)

- ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules attached.
- ENTRIES RECEIVED PRIOR TO OPENING DATE AND TIME
- UNSIGNED ENTRIES
- ENTRIES RECEIVED WITHOUT FEES
- Envelopes/transactions that have entries for more than (10) dogs
- ANY ENTRY WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.
- ENTRIES SENT WITHOUT A COVID-19 WAIVER
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. A CHARGE OF \$25 WILL BE MADE FOR EACH RETURNED CHECK.

Trial Regulations Notice to Exhibitors

THE TRIAL will be open from 7:00 a.m. to 7:00 p.m.

TRIAL COMMITTEE will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

THE SAFETY OF THE DOGS is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all the obstacles safely.

DOGS MAY ARRIVE any time prior to Judging, if the dog does not need to be measured. Otherwise, they must be available for measuring before their class begins.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

Practice Jump: A practice jump may be provided for exhibitors to warm up

Course Walk Throughs: Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent. Umbrellas are not permitted during the walk-through

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

According to New York State Law,
Rabies vaccination and dog license are mandatory.

ALL EXHIBITORS MUST PICK UP AFTER THEIR DOGS!!

Wait List Information

A wait list is being offered to fill openings created by withdrawn entries, either before or after the trial's closing date/time. A maximum of 30 entries per day, will be accepted for the wait list. All entries, including wait listed entries must be received by the Trial Secretary prior to the closing date. Any entries withdrawn by 6pm, Friday 12/3/21, will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. If the withdrawn entry after closing cannot be replaced, no refund will be due. Any wait listed entry that does not move off the wait list into the trial, checks will be shredded

Notes From the Trial Secretary

- **PLEASE USE EITHER THE ENTRY FORM WITH THIS PREMIUM OR THE ENTRY FORM FROM THE AKC WEBSITE!**
- Remember to check the box if your dog needs to be measured. If you forget this will default to "no", does NOT need to be measured.
- Reminder, please DO NOT send me your height card, it will make more work for me to just throw it out.
- Mixed Breeds - Remember to mark your breed as Mixed Breed, no hybrid.
- For overnight delivery, please remember to sign the signature waiver.
- Double and triple check your entry form, and your payment. Any entry received with the improper funds constitutes an invalid entry.
- Please make checks out to **Suffolk County Kennel Club**
- Please make sure you enter your dog in the proper height class, I hate getting notices from the AKC of Qs that are removed for dogs running in the wrong height division.

DATA ENTRY AND CHANGES TO YOUR INFORMATION

Data entry mistakes happen. That is why we ask everyone to **READ** their preliminary confirmation and final confirmation. For the majority of entries, dog and owner/handler information remains the same. However, if you have a: New email address, New Titles, New Handler, New address and phone, New jump height (including jump height changes from trial to trial. For example, dog jumps 24" at one trial, then 26" in the next trial.) Highlighting ANY of these changes on entry forms would be especially helpful so that these changes can be updated in our database. Then, please review your confirmations carefully to ensure that your requested changes have been made.

For overnight delivery, signature waiver - Please remember to check the No Signature Required box AND sign that spot where you authorize them to deliver.

Move Up Deadline - Remember that the Move-up Deadline for your first day of a weekend trial is ALWAYS **Monday at 6 pm**. Please send those move-ups in right away.

Novice Exhibitors – please read the section on the move-up form or under Move-ups about when you need to change from Novice A to Novice B and also read the section under classes to determine whether you should enter Novice A or Novice B level classes.

Email Correspondence

I ALWAYS acknowledge all entries with an email. You will either get a preliminary confirmation or waitlist email. If you do NOT receive an email from me DO NOT assume you didn't get into the trial. You NEED to assume I didn't get your entry. And please allow two weeks after opening for me to process the entries.

Show Site Information

Doggie U is a heated / air conditioned building. Crating space is **VERY** limited; **NO Ex-Pens allowed, crates must be stacked, unentered dogs may not take up any space of entered dogs. Due to COVID-19, no spectators or their dogs are permitted at any time during the trial.**

There is no parking for oversized vehicles, or overnight parking on site. You will receive detailed information about parking with your final confirmation.

Exhibitors are expected to clean up after their dogs at the trial site.

FOOD

There will be no hospitality offered at this trial.

DIRECTIONS

Suffolk County Kennel Club (SCKC) Agility Trial Guidelines and Procedures

December 4th and 5th, 2021

Agility trials are important to all of us in the agility community. Exhibitors enjoy the camaraderie, the training, the exhibiting their mastery of their skill sets, and earning titles. Due to the COVID-19 virus pandemic, we have had to change many things in our daily lives, and the same is true for agility. The club has been planning, evaluating and researching ways to safely hold our agility trial. We will be complying with Governor Kathy Hochul's guidelines for opening New York State and for gatherings as well as the procedures set forth by Doggie U K9 Academy.

SCKC wants all of their exhibitors, workers, and judges to be in a safe environment. As a result, there will be changes to our trial format and we will be imposing new guidelines and restrictions. While agility is not a contact sport, we believe that the fluid Covid-19 environment demands protocols beyond governmental and AKC guidelines and those are outlined below. Exhibitors not complying with these guidelines and restrictions may be excused from the trial without a refund. **All exhibitors will have to sign a Covid-19 Waiver and include it with their entry for the entry to be considered a valid entry.**

If you are feeling ill for any reason, please STAY HOME! If we suspect an exhibitor is ill, the exhibitor will be asked to leave.

General Procedures

1. Please use a check for your entry fees. If the trial has to be cancelled for any reason, your check will be shredded.
2. When you arrive at the facility, please wait outside until SCKC personnel call you in to the building. Exhibitors must wear a mask and maintain a 6 foot social distance between people while they are waiting.
3. Upon entering the building, a temperature check WILL be performed. If your temperature is normal, you will be issued a wristband that is to be worn for the day to indicate that you have had your temperature taken, Please be sure to wear this wristband all day so that no issues arise. Please be patient when you enter as this will take time.
4. **At this times, if you are vaccinated, masks are not required. You must provide proof of vaccination to receive a wristband to remain unmasked. If you are not vaccinated, masks are mandatory at all times in the building including when you are running your dog. Please bring your own masks. If you are outside and cannot maintain social distance, masks would be required. We recommend bringing multiple masks.**
5. Exhibitors should bring their own food and water for themselves and their dogs. There will be no hospitality at this trial.
6. Please wash your hands using the CDC approved procedure frequently. There are no-touch soap dispensers in the rest rooms.
7. Please bring your own hand sanitizer or hand wipes. Although the facility has no-touch hand sanitizer dispensers available throughout the facility, you may not always be near one.
8. Please refrain from touching dogs that are not your responsibility.
9. Please **check in before you walk the course to limit congestion around the gate board as the scribe sorts their sheets.**
10. If you think you will need a pen or a pencil, bring your own!!!
11. Course maps will be posted outside the building. It is recommended that you use your phone to photograph the map. **NO Paper Copies will be provided.** Please maintain social distancing when looking at the course maps.
12. The only people in the ring area will be the judge, the ring crew, the timer and scribe, the score runner, and 1-2 dogs on deck.
13. Doggie U has a PA system that will be used to announce the running order and the speaker will be outside the building so exhibitors know when they are coming up. It will also be used to announce walk-throughs. The Remind app will be used throughout the trial for status updates.
14. Walk-throughs – The walk-throughs MAY have a limited number of people at any given time. The secretary will determine the walk through splits and these will be published in the final confirmations. Each group will get an eight (8) minute walk through. While walking and when exiting, please maintain social distance – no congregating around obstacles, no touching obstacles, etc.
15. Please do not congregate at doorway, the ring or the ring gate while waiting to run.
16. While moving towards the ring, please maintain proper social distance.
17. Crating and spectating by entrants of the trial will be allowed indoors with proper social distance. Please only crate in the indicated spaces so that proper social distance can be maintained.
18. When waiting to run, please maintain social distance from the other people in the room.
19. At this time, exhibitors and dogs will be allowed in the facility.
20. No unentered dogs or observers will be allowed in the facility.

THESE GUIDELINES ARE SUBJECT TO CHANGE AT ANY TIME PRIOR TO OR DURING THE TRIAL. CHANGE NOTIFICATIONS WILL BE SENT VIA EMAIL.

Entering a Mixture of Regular and Preferred Classes

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day. A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On

Fix and Go On (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

For Exhibition Only

Entering For Exhibition Only (FEO)

As of January 1, 2020, For Exhibition Only may be offered at the option of the host club. FEO will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment.

Competitors must enter in T2B and/or FAST. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring (Toys must be non-audible, may not leave the handler's hand, and toys that roll freely cannot be used)
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and/or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time.

Measuring and Height Card Information

If your dog does not have a Temporary or Permanent height card, or if your dog has turned 2 years of age, since getting your temporary height card, your dog NEEDS to be measured.

All dogs competing in agility must possess an official AKC Jump Height Card. Dogs that do not have a valid Jump Height Card must be measured by a judge of record for that trial and will only be effective for that set of trials, excluding the dogs jumping in the 24-inch or 26-inch height division.

If an official measurer is present, all dogs that have not been issued a permanent Jump Height Card or temporary jump height (yellow) form must be measured for a Jump Height Card regardless of the jump height entered.

If there is not an AKC Field Rep or VMO in attendance, all dogs that have not been issued a permanent Jump Height Card or temporary jump height (yellow) form may still compete; however, they must be measured by a judge of record for the trial, prior to running at each trial. The judge's measurement will be valid for this trial or back- to-back trials only.

If a dog is measured by an AKC Field Rep or VMO and is now eligible to jump in a lower height class, the measurement is effective immediately for any future runs. This does not apply to a challenge measurement for a permanent jump height card.

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process.

It is the sole responsibility of the exhibitor to have their original, official jump height card or temporary jump height form at each trial to present upon request. Additionally, if a measurement is necessary, it is the exhibitor's responsibility to have their dog measured prior to running. *Regulations for Agility Trials, Chapter 2, Section 4.*

HEIGHT DIVISIONS

Owners/Agents are responsible for entering the proper height divisions. All height divisions will be offered in both the standard classes and the jumpers with weaves classes.

Regular Exhibitors may choose to enter their dog in a higher height division than required by AKC, but not in a height division lower than the AKC mandated height

Preferred The following jump heights **must** be used in all Preferred Classes.

	REGULAR	PREFERRED
Dogs 11 inches and under at the withers	8 inches	4 inches
Dogs 14 inches and under at the withers	12 inches	8 inches
Dogs 18 inches and under at the withers	16 inches	12 inches
Dogs 22 inches and under at the withers	20 inches	16 inches
Dogs over 22 inches	24 inches	20 inches

Dogs may be entered at 26" height at their owner's discretion.

Move up Clarification

As per Chapter 1

Section 20. Move-ups. Move-ups prior to a set of trials: Dogs shall be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is made in writing to the Trial Secretary not later than 6:00 p.m. on the Monday preceding the set of trials for trials starting on a Thursday-Sunday.

Day-to-Day Move-ups: Move-ups from day-to-day at a set of back-to-back agility trials shall be at the discretion of the club. The request for moving up must be made in writing at the trial site to the Trial Secretary not later than the day preceding the event.

Novice Information: Dogs having attained their first AKC Agility title (Std, JWW, T2B, or FAST) must be moved to the Novice B class (Std, JWW, or FAST) for all trials for which entries have not closed. If entries have already closed on the date the dog obtained its title, the dog shall remain in the class in which it was originally entered or be moved up in level (i.e., Novice to Open) at the request of the owner; subject to the move-up criteria, except as stated in Chapter 1, Section 21 regarding Novice A entries.

Section 21. Entry of Ineligible Dog. A dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from a Novice "A" class to the Novice "B" class.

Day- To- Day Move- Ups: The club is accepting Day-to Day Move-ups for this Trial. The request for moving up must be **made in writing at the trial site** to the Trial Secretary not later than the day preceding the event.
