



## BSTD REGISTRATION FORM



It is a part of the registration process that

- 1) **A copy of the competitor's public liability insurance** which covers timed arena competitions be submitted along with
  - 2) **A signed copy of the current Rule Book** (signature section on the last page only) and
  - 3) **A fully completed Registration Form** along with
  - 4) **The correct fee** which must be paid by BACS or cheque.
- Those registering must send all the relevant documents before they drive at their first event.
  - **COMPETITORS MUST SOURCE THEIR OWN PERSONAL PUBLIC LIABILITY INSURANCE for competing in timed events.**
  - Registration forms may be downloaded from the website [www.scurryandtrials.co.uk](http://www.scurryandtrials.co.uk) or requested by email, post or telephone. Competitors must complete the form so that we know your details for communication.
  - The registration period runs from 1st January to 31st December in the same year.
  - Multiple drivers in one family and residing at the same address must all sign this document.
  - You must agree to abide by the rules contained in the Official BSTD Rule Book ©.
  - All competitors must agree to be bound by the BEF Equine Anti-doping and Controlled Medication Rules and the BEF Anti Doping Rules for Human Athletes as amended from time to time, copies of which can be found on the British Equestrian Federation Website at [www.bef.co.uk](http://www.bef.co.uk).
