Gobert asked to address the Fairgrounds resolution. She understands why Forest County wants to cut ties with the property but, there is a concern for the taxpayers now. She asked that the County consider a "Right of Refusal" for the resolution.

Cheryl Hobbs – 108 S. Lake Ave., Crandon, Wisconsin

Hobbs asked to address the Fairgrounds resolution. Her concern was once the land is gone and if the Ag Society dissolves does the land come back to the County. She has a non-profit "Helping Hands of Forest County" and she is looking for land for community projects. She said if the Ag Society goes back on their word, her non-profit could take the expense and use of the land for community services.

Amy Kuebler – 5923 Buck Road, Crandon, Wisconsin

Kuebler asked to address the Fairgrounds resolution. She told the Board she is the head of the Horse and Pony 4-H. She works with children with disabilities; some have their own horses and some do not. She had a horse show that was separate from the Fair presented by the Ag Society and it was well attended and they filled the Fairgrounds. The program they have is wonderful and they help many children and in her profession she sees the bad side of children who are depressed and the program is very helpful for these children. If the land would come back to the County, could it be leased or purchased?

PERSONAL APPEARANCES

Visit Forest County- CEO

Shafer started by thanking everyone that attended the golf outing. The Kentuck Days went great, the music fest put on by the Ferris' (Mark and Julie) went great and checks were handed out to the clubs to help with the bad winter they had for snowmobiling, last year. Shafer met with the Lt. Governor on August 7th and talked a lot to her about issues. Footstock just got over and Art in the Square will be held on September 20th with moving the vendors to Madison Street because of the construction on sight at the Courthouse. Next week is the Brush Run and the Labor Day parade, it will start with fly-over and there will be a Drone show at the track. Discover Wisconsin will be here for the week of September 6th. He talked about the BEAD grant and that it was sent back for a re-write and when they did that they went for the whole 72.4 million and they just found out they were awarded the full 72.4 million for the Broadband project.

Amber Rehberg – Digital Navigator Grant

Rehberg and Watson were both present to report on the NDIA grant and its success in Forest County. Their program will continue but, it will be taken over by another grant from Human IT and it will cover several counties.

Chairpersons Report

Zoning – Karl

Permits are down but, still ahead of normal years. Things have really slowed down as the season is winding down.

Forestry – The park's numbers are down but, the money is okay. There are several things that need to be updated at the park in the next budget year, one being the grass needs attention. The department put out two (2) timber sales that they took back; none are active right now.

Sheriff & Justice – Marvin

The department is applying for a PSAP grant for about \$545,000, which is a 90/10 grant for the Dispatch Center.

Highway – Short S is complete and Long S as well. Thank you to the Potawatomi for all the help they have given the Highway department.

Building – Lukas

There are three (3) projects being worked on right now. The security doors, West Entryway and Parking lots. The Entryway is in full swing. The Parking, he was not sure when they would be done.

ADRC/Aging – Miller

The committee is considering closing the Alvin meal site because the participation is not happening. By closing it the department can save around \$12,000 a year. The department has been having fundraisers and the recent bake sale brought in \$300, which will fund sixty (60) meals. They are planning two (2) more bake sales this year.

Human Services – Karl

Right now, they are working through some issues and trying to make some changes but, they are moving along.

Skallerud – Personnel and Finance is kicking off the 2026 budget work.

Conley (Treasurer) – The tax season went really well. They had a problem with the mail again where they had letters mailed on July 29th not received by the County until August 18th. This is a real problem and she is asking all of the Towns to do online payments.

RESOLUTIONS/DECLARATIONS

Resolution 44-2025 Offered by Personnel

NOW, THEREFORE, BE IT RESOLVED, that the County of Forest hereby amends its Employee Handbook by adding language in the section entitled "D. Funeral Leave. Upon hire, in the event of the death of an immediate family member, the regular full-time employees shall be entitled to:

- three (3) days, up to 21 hours of paid leave for 35-hour per week schedules
- three (3) days, up to 22.5 hours of paid leave for 37.5-hour per week schedules
- three (3) days, up to 24 hours of paid leave for 40-hour per week schedules
- to attend the funeral or services for purposes of this policy only," and last sentence of the paragraph to be amended to, "In the case of a family member, friend, partner, or significant other not listed about, the employee will be allowed to use:
- one (1) day or up to seven (7) hours per day for 35-hour per week schedules
- one (1) day or up to seven and $\frac{1}{2}$ (7.5) hours per day for 37.5-hour per week schedules
- one (1) day or up to eight (8) hours per day for 40-hour per week schedules of leave for the purpose of funeral."

Motion by Landru to approve the resolution as presented, second by Peterson. All present voting AYE (17); Absent (2) Augustin, Fulcer. Motion carried.

Resolution 45-2025 Offered by Building and Public Property

NOW, THEREFORE, BE IT RESOLVED, that the Forest County Board Chairman shall sign a deed gifting and transferring the real estate commonly referred to as the Forest County Fairgrounds to the Forest County Agricultural Society, Inc.; and

BE IT FURTHER RESOLVED, that the conveyance of real estate referred to above is contingent upon Forest County being released from the restrictive covenants associated with the real estate; and

BE IT FURTHER RESOLVED, that the money remaining in the fair reserve account after paying the real estate closing expenses and 2025 non-budgeted, under budgeted expenses shall be given to the Forest County Agricultural Society, Inc.; and

BE IT FURTHER RESOLVED, that any previous resolutions associated herewith are hereby null and void and replaced by this resolution.

Motion by Weber to approve the resolution as presented, second by Marvin. All present voting AYE (17); Absent (2) Augustin, Fulcer. Motion carried.
