Article 29 Section 2 The Fire Inspector will not be considered turn personnel. The Fire Inspector will not be used in a capacity to be included in daily staffing levels.

Article 30 Section 3 - Inspection members will not be included in minimum staffing levels for suppression

Article 31 Section 6 – Minimum manning 14 in suppression. Must fill openings within 60 days or can't use part-time firefighters.

Article 35 Section 5 – employer agrees to schedule a minimum of three (3) full-time firefighters per shift.

Article 40 Promotions – will fill opening in 14 days if there is a promotion list, in 90 days if testing required.
