The Board of Liberty Township Trustees met in Regular Session at the township administration office on Monday, June 9, 2025 at 6:00 p.m. with the following members in attendance, Mr. Arnie Clebone, Mr. Devon Stanley, and Mr. Gregory Cizmar presiding.

Fiscal Office Matthew Connelly was absent but provided a written financial report to the Board. The May bank reconciliation is complete. Matthew is working on the 2026 Alternate Tax Budget which is due by July 25th to the County. He said there are a few grant applications outstanding we are applying for and receiving. The new ambulance was purchased without financing because of an insurance claim and our own budgeting funds from the Ambulance/EMS fund. Our property & Casualty Insurance increased, he added, from the previous year. Lastly we are being audited by the State of Ohio for the Ambulance ARP Grant received in 2023 and 2024.

Reports:

Administrator Martha Weirick reported Trustee Arnie Clebone, Road Superintendent Wayne Hickman and she attended the annual Eastgate Regional conference. The guest speaker discussed the housing shortage throughout the region and offered some ways to improve the shortages. Martha reminded everyone Music in Churchill Park starts Thursday with the Youngstown Vegas Band performing.

Fire Chief Doug Theobald reported graphics are currently being put on the new squad. Chief Theobald discussed the home explosion that occurred this weekend. At the time of the explosion, a lieutenant was at the local Walmart a short distance away, heard the explosion and was first to arrive. He found multiple victims with life threating injuries. At the same time a call came to the station of a house fire, but quickly it was discovered that the house on E. Montrose had exploded with multiple victims. Along with our safety forces, Girard, Hubbard, Howland, Weathersfield, the Air Base, the Youngstown Bomb Squad, ATF and the State Fire Marshal all provided aid. Nearby homes were evacuated for a period. Paramedics were able to provide aid, LPD officers were able to secure the scene, and roads were barricaded by the Liberty Road Department. A search began in case any victims remained in the structure, until the State Fire Marshal deemed the home not safe. Later, it was determined no one else was in the structure. Evidence was collected by agents from the ATF, Bomb Squad, and State Fire Marshal. It appears occupants were possibly manufacturing homemade fireworks. The blast blew out the front, side and back of the structure. One of the victims has since passed away, with two remaining in critical condition. The Trumbull County Building Inspector and State Fire Marshal have declared the structure unsafe due to structural defects.

Police Chief Toby Meloro asked if anyone had questions regarding his written report. Chief Meloro wanted to thank the neighboring communities who offered mutual aid, as well as the other agencies who helped during this weekend's disaster, including the State Fire Marshal, the Youngstown Bomb Squad, and the Bureau of Alcohol, Tobacco, Firearms & Explosives. "It was good to see so many organizations come together and collaborate making our jobs easier during this difficult crisis."

Trustee Clebone added to those in attendance. "If you see something, say something."

Road Superintendent Mr. Wayne Hickman briefly reviewed current projects. The Center Park Project is moving forward with plans being drafted. Currently, he said, both parks are open. The road crew is busy with drainage issues, as well as all aspects of maintaining township roads.

Zoning and Code Enforcement Director Mr. Jim Rodway was absent.

WHEREAS, the Board of Trustees of Liberty Township, Trumbull County, Ohio, on behalf of Liberty Township, is the owner of two vacant parcels of land on Churchill Road, Permanent Parcel Nos. 21-063870, and 21-063880 totaling approximately 1.83 acres, (hereinafter the "Property"); and

WHEREAS, Pursuant to R. C. 505.10(A)(6) the Township agrees to sell, and Reel Holdings, LLC, the neighboring property owner, has agreed to purchase the Property for the sum of Twenty-Four Thousand Dollars (\$24,000.00) with the buyer to pay all costs of the sale, including a survey if required; and

WHEREAS, the Trustees have determined that it is in the best interests of the Township and its residents to sell the Property to Reel Holdings, LLC, the neighboring property owner, to be used for soccer fields;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Liberty Township, Trumbull County, Ohio as follows:

RESOLVED, that the Board agrees to sell, and Reel Holdings, LLC agrees to purchase the Property and pay Liberty Township the sum of Twenty-Four Thousand Dollars (\$24,000.00) in accordance with the Purchase and Sale Agreement. The Chairman of the Board of Trustees, Greg Cizmar, is hereby authorized to sign the Purchase and Sale Agreement and the Quit-Claim Deed, on behalf of Liberty Township.

BE IT FURTHER RESOLVED that the Board finds and determines that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements.

Citizen remarks: A resident continued his discussion with the Board regarding a property located at 985 Tibbetts-Wick Road, once a gas station and currently owned by private individuals who have plans to upgrade the property sometime in the future. Although the structure is sound and not eligible for demolition, the trustees will consider adding the property to the grass/weed abatement. In addition, Law Director Cherry Poteet suggested the zoning inspector send an enforcement letter requiring the owners paint the exterior, replace or repair the decorative facade where multiple panels are missing, and the replacement of the windows rather than boarding up under Property Maintenance Codes.

The same resident commended the Road Department for their efforts to crack seal roads, street sweep the roads, and maintain the grass and weeds along the right of ways.

A resident complained about various areas on Belmont Avenue, including the abandoned gas station, the vacant building - formerly a Subway, and trash. She wanted to bring to the Board's, a home on Fifth Avenue, where trash is everywhere and has a fenced in drive. She objected to a home on the corner of Breeze Knoll and Ravine, where multiple cars park in the drive and on the road making it difficult to see to turn onto Ravine. Lastly, she reported she had called the administration building back in May, where she reported hearing three large booms and had asked the person she spoke to report her concerns to the police.

A resident spoke to the Road Superintendent about repairs to a drain in the front of his property.

Trustee Arnie Clebone reported a successful Bike Belmont. He was pleased to see how well the local businesses supported the event. He received good news that the grant he submitted several years ago may bring in some ARPA funds. He thanked Mr. Stoyak who worked hard to locate the owners of the Tibbetts-Wick property discussed earlier and his efforts to bring his concerns to the Board.

Trustee Devon Stanley asked the Board to considering hiring a Cemetery Sexton, should we find it necessary.

Trustee Greg Cizmar said we had another successful auction. He met several contractors regarding cement around the gazebo. He also said he met with our insurance company, to review all township buildings.
