The Board of Liberty Township Trustees met in Regular Session at the township administration office on Monday, September 8, 2025 at 6:00 p.m. with the following members in attendance, Mr. Arnie Clebone, Mr. Devon Stanley, and Mr. Gregory Cizmar presiding.

Fiscal Officer Matthew Connelly reviewed the Cash Summary of Funds and working on reconciling July & August bank statements. Mr. Connely mentioned the Belmont Park Cemetery takeover is coming along and that the Admin staff, Road Dept and our Attorney have played integral roles in this transition. Matthew reported the Township was audited by Budget Management for grant funds received and passed the Audit. He concluded his report by stating that we did not get a Cemetery grant applied for, Budgeting process for 2026 is beginning over the next month and that he has made application for unclaimed funds from the State.

Fire Department Chief Doug Theobald stated that this is Grant season and is starting it off by applying for a Marc's Radio Grant as well as a \$14K Grant for Hoods and gloves. The new rehab hospital inspection is underway. He completed the inspection of the new Hotel and it is good as of 9/8/25. Doug also shared a story about one of our firefighters/paramedics reviving a man back to life and that an award is coming for that and when received he'll present it at a future meeting. He concluded his report stating they continue to have above average runs.

Police Department Captain Ray Buhala presented his report and added that his officers are spending a lot of their time and effort watching for speeders in the residential neighborhoods around the township of the 80 they have pulled over, 48 were residents and their focus is on emphasizing to residents the importance of not speeding.

Road Superintendent Mr. Wayne Hickman reported that the 2025 OPWC road project is completed. Wayne said a big thank you to all in the township for support in all of the projects being done right now. He is seeking quotes for the Center Park drainage project. The Belmont Ave sidewalk project is done from Churchill Rd to Giant Eagle. He addressed the utility projects going on in the township at the same time from Lumos fiber and Enbridge gas line and equipment replacement. He asked that the Trustees start thinking about the new gas tanks from Lyden Oil for Road, BPC and Fire Dept. Crack sealing is completed, GT Crack Sealing did 4 miles of road. He concluded that the road crew are busy with catch basins, ditch cleanouts, pot hole patching and other road work.

Zoning and Code Enforcement Director Mr. Jim Rodway left his report with the Trustees before retiring on August 31, 2025.

Section 2: Notice shall be given to the owner(s) of the Property and any lienholders (Parties in Interest) by certified mail or as otherwise provided in R.C. 505.86, of the Township's declaration of nuisance and demand to abate said nuisance by demolition, and of their right to request a hearing.

Section 3: If the Property Owner or other Party in Interest fails to request a hearing before the Board within twenty days or provide for the demolition said structure within thirty days of issuing notice, the Board authorizes the Township Administrator to enter into contracts with private contractors or the Trumbull County Land Bank for the demolition of the structures on the Property.

Section 4. The total costs incurred for the demolition and removal of the structure and abatement of the nuisance, including all associated site restoration work, and the costs incurred in providing notice may be certified to the county Auditor who shall place the costs upon the tax duplicate to be a lien upon such lands from and after the date of entry.

The total costs incurred for the demolition and removal of the structures and abatement of the nuisance, including all associated site restoration work, and the costs incurred in providing notice may be certified to the county Auditor who shall place the costs upon the tax duplicate to be a lien upon such lands from and after the date of entry.
