Discussion: Fire Chief Doug Theobald said the abandoned Belmont Avenue Gas Station, he believes, still has underground tanks and is working on estimates. The Board and Chief reviewed the furnace and flooring replacement bids received, resulting in the above Resolutions (23-142 and 23-143). He has been working on the 2024 Budget with the Fiscal Officer , including the removal of the fuel tank and paving of the parking lot. The Shadey Road siren has additional wire damage done by squirrels. He spoke of further issues with the EOne Rescue which is out of service again. The 1992 Pierce is at A & E for repairs with what appears to be a head gasket problem and difficulty locating parts. They discussed an application to possibly purchase a used ladder truck resulting in Resolution 21-144 above. The department interacted with the schools during fire prevention week. He is working with Chief Hickey and another community to apply for an Air Pack Grant. Chief relayed an occurrence in which off duty Liberty Firefighter Nick Foard was at Eastwood Mall where a disturbance caught his attention. Upon investigation, he came across an unresponsive male with no pulse, began CPR, directed bystanders to call 911 and retrieve a defibrillator. With the help of bystanders, the Niles Police and Niles Firefighters, they were able to obtain a pulse on the individual, before transporting him to the hospital. Chief Theobald hopes to present awards to a several firefighters at the December 11<sup>th</sup> board meeting. Liberty Strong!

Fiscal Officer Matthew Connely has been meeting with Department Heads working on 2024's budget. Matt assessed some additional revenue sources including the rental of the pavilions and found the fees to be adequate. He reviewed the cemetery fees, as well, and found them to be in line with what other communities charge. Matt feels, however, we are undercharging for reports. Matt will have a price increase suggestion for next Friday's meeting. He hopes to keep us in line with other communities. He discussed options with the Board for the Firefighters Work Force Relief Incentive program.

Police Chief Toby Meloro thanked Walmart for their generous donations to the departments and community. The Chief reviewed last Wednesday evening's events where a Highway Patrol helicopter was flying over Liberty Township streets. The Youngstown PD, the State Highway Patrol, and a State Highway Patrol helicopter were performing a "saturation patrol" inside the City of Youngstown. As it happened, several juveniles fled from YPD causing a high-speed chase throughout Youngstown, ending in Liberty Township. The car stopped near the golf course and Redfern Drive where the youth fled on foot. However, were quickly apprehended by Liberty Police Officers. Liberty Strong!

Trustee Stanley apologized for missing last week's meeting because of Walmart's grand reopening where they presented generous donations to the Police and Fire Departments, along with a donation to the Community and Historical Society.

Trustee Greg Cizmar visited the newly purchased Veterans Outreach building on Colonial. They've done a lot of work but there is still a lot that needs to be done, he relayed. Greg hopes the letter of support he sent on behalf of the Board of Trustees to the Trumbull County Commissioners will help to secure some much-needed funds.

Trustee Arnie Clebone also thanked Walmart for the generous donations and their constant support for our community. The landbank has the opportunity to receive federal funds to tear down with a 25% match.

Trustee Clebone said in addition to the properties listed above, he asked the Board Members to consider adding additional properties to the list, which could be removed from the list later. He suggested even if those properties have not been declared as unfit, he wanted to include them on the list. The other Board members felt more discussion was needed as some of the homes referred to would still be considered habitable. Trustee Clebone continued the discussion of hiring help for the zoning department. He mentioned the Boards intent to send a request to the Zoning Commission to review other communities' codes and offer suggestions. Trustee

Devon Stanley said he had proposed hiring another person for zoning when first elected. Because he is the prosecutor at Girard Court, he has prosecuted zoning violators. However, he feels we need to reach out to people who need a helping hand before it gets out of hand.

A resident complained about issues on his street, like trees down, a container in the front of the house, and debris in yards. The trustees are aware of those homes who have received multiple citations from Zoning.

A resident had a complaint about other people dumping on his property. He put up cameras, only for them to be stolen. He posted not dumping signs, only for them to be taken. The Board will look into erecting no dumping signs near his property.
