Trustee Cizmar thanked Zoning Inspector Jim Rodway for getting over 600 tires removed from an abandoned gas station on Belmont Avenue and is in the process of securing the building.

Trustee Clebone received a call from a concerned citizen regarding parked landscaping trucks and trailers obstructing the view of drivers along Logan Way, a county road. The resident believed this creates a hazard for vehicles line of site. Police Chief Meloro explained whenever they receive this type of complaint, the officer requests the landscaper move the vehicle to a safer location. Chief Meloro asked Trustee Clebone to have the resident get in touch with him.

Chief Gus Birch reported the annual hose testing has commenced, making sure the hoses are in compliance with fire regulations. Med 34 will be going to the body shop next week to address exterior paint issues while the vehicle is still under warranty.

Chief Toby Meloro thanked the Board of Trustees for allowing Hubbard Township to purchase the old tasers, no longer needed by LPD for \$1. The tasers are still functioning however, parts are no longer available. It is nice to help your neighbor, if possible.
