The Board of Liberty Township Trustees met in Regular Session at the township administration office on Monday, September 9, 2024 at 6:00 p.m. with the following members in attendance, Mr. Arnie Clebone, Mr. Devon Stanley, and Mr. Gregory Cizmar presiding.

Fiscal Officer Matthew Connelly presented his report by reviewing the Cash Summary Repots and reported on the revenue received. Matt explained the by-annual audit is nearly complete. He completed his public records training requirements for his new term. He is pursuing a dot.gov grant as well as other grants. Matt announced the change in employee health insurance with a savings of over \$210,000.00. Matt explained he went to Cleveland with the Fire Chief to learn about the new Medicaid State Program which will allow the fire department to keep not only the 30% collected transport fees but the remainder 2/3rds fees for Medicaid transports.

Administrator Mrs. Martha Weirick reported on past and upcoming events. Neighborhood Trick or Treat will be October 31^{st} from 5 p.m. to 7 p.m. with a police department open house on the same day from 4:00 p.m. – 5:00 p.m.

Fire Chief Doug Theobald also spoke of the opportunity to pursue the state grant for Medicaid transports. He applied for the Ohio One Jobs Network Grant. He currently has two new hire who are enrolled in paramedic classes with the understanding the program will reimburse them fully. The eligibility is 2 times a year for this program. Gary Sinise grant is underway. The supplies are been delivered to the station and the class will be Saturday Sept 27th withal surrounding departments invited to attend including the air base. Construction continues with the hospital and hotel allowing him to review the installation of fire prevention before they are walled in. The department reached out to ODOT requesting access to I-80 from Tanglewood for emergency vehicles which would drastically reduce the response times to the highways from station 35. ODOT was very interested and will be sending paperwork to the station. One of the power cots was recalled and they replaced it with a completely new cot. Fire Prevention Week starts October 6th.

Police Chief Toby Meloro gave his report and asked if there were any questions. He announced Coffee with a Cop will be Wednesday, October 2nd from 9 a.m. – noon at Duncan Donuts.
