Discussion: Troy Rhodes, First Energy's Regional External Affairs, introduced himself to the Board of Trustees. He is the contact person for most of NE Ohio.

Road Superintendent Wayne Hickman said once he receives the final invoice for the 2023 Road Project, we can close that program. Now that the Board has awarded the 2024 Road Project to RT Vernal, we will start the process of getting the contract signed and set up a preconstruction meeting with them. At the very least, we should be able to do the infrastructure this year and if RT is available and the weather cooperates we may knock out the paving too. If not, we should at least get the drainage done this year.

We are working towards the 2025 Road program. For the Community Development Block Grant Townsend Project, there's a meeting at the Planning Commission on Monday. Wayne said he is meeting GPD Group next week regarding Center Park. He hopes the Crack Seal program will begin again at the end of the week. The Scrap Tire Grant Program is this weekend and is set up at the upper parking lot next to the police department. On Monday our road guys will load all the tires onto the semi that has been placed at the site per the recommendation of Geauga Trumbull Solid Waste. The Road guys will continue with repairing catch basins, drainage work, and road department related work.

Fire Chief Doug Theobald said the fire line at the new hotel is complete, but he still has concerns about water pressure in that area. The Chief spoke of a possible burning ban because of the severe drought we are experiencing. There have been massive delays at the local hospitals, due to backups at the ER. In some cases, they leave one medic with the patient at the hospital in order to continue ambulance services. The next two weekends they will be conducting the Gary Sinise Grant controlled burn. Afterwards, we will keep the structure for future training purposes. Chief inspected the fire hydrants that were mentioned at the Monday Meeting. In the one case the hydrant was damaged and reported to the City of Girard. The other hydrants were checked from Belmont to Tibbetts Wick. 2 hydrants are clocked at 90 degrees off — one in front of the Teddy Bear Lounge and the other at 845 Tibbetts Wick. The big bill regarding the 2019 Fire Truck to fix the leaky radiator, Greg suggested they go to guy in Hubbard who repairs all types of radiators to see if he can fix it rather than be at the mercy of the manufacturer who is the only one who can customize the radiator.

Fiscal Officer Matthew Connelly discussed a continuation of a previous grant (we received \$20,0000 previously that was put towards payroll), and the potential to receive an additional \$11,000 from Work Force Grant. The extra ASPP Medicare funds we could potentially receive could be between \$90,000 and \$110,000 with 10% going to the 3rd party billing company.

Police Chief Toby Meloro reminded everyone Coffee with a Cop is October 2nd at Dunkin Donuts from 9 – noon.

Trustee Greg Cizmar said the auction is almost done.
