Chair, Deb Drum, called the meeting to order at 12:11 PM.

II. Public Comment

There were no comments from the public.

III. Old & New Business

A. Old Business

- 1. Review and approval of October 16, 2023, Initiative meeting minutes and corrected June 12, 2023 minutes
 - Jim Davis moved to approve the <u>October 16, 2023</u>, meeting minutes and Pat Magrogan seconded the motion. The motion passed with unanimous support.
 - Albrey Arrington moved to approve the <u>June 12, 2023</u>, as amended, and Jim Davis seconded the motion. The motion passed with unanimous support.

B. New Business

1. FY25 Legislative Request & House Update Appropriations Request Update

- About half way through the legislative session
- A discussion of potential funding was held
- The LRPI three recommended projects are all under \$1,000,000 which should increase the chances of funding
- Problem with Everglades funding in the Senate, push and pull, and the Loxahatchee River funding is not in there right now
- C-43 is one of the projects allowed to spend money on
- PBC County project \$180k funded half, officially in play; in the House, working with Rep Snyder trying to get \$90k increase
- Chair Deb Drub encouraged everyone to please go back to respective agencies and make sure you are coordinating with each other (municipalities/ agencies/ etc. with counties) so there is a collective and coordinated effort
 - 1. Same talking points
 - 2. Talking points will be sent out to the Board
- Reminder: any agency that will have a lobbyist in Tallahassee is asked to please let Ed Chase/ PBC know so they can coordinate on timing and messaging

2. FY24/25 Voting Member and Selection of Officers

- Pat Magrogan motioned to keep the same slate of officers, and Jim Davis seconded the motion. The motion passed with unanimous support.

3. Agency Updates

a. PBC ERM – update on Loxahatchee Slough resources and Pal Mar acquisition efforts

- TJ Wilkerson (filling in for Melissa Tolbert) from PBC DERM gave a presentation on Phase I
- Update on Pal-Mar acquisition
- Update on Loxahatchee Slough
- 434 relatively small parcels between 1-1.2 acres
- PBC acquired 38 acres of land
- An additional 15 parcels are under contract
- Total of 199 parcels with 359 acres
- \$4M ARA funds allocated for environmentally sensitive lands
- Loxahatchee Slough habitat restoration driest portion
- Cleared out coco plums and palmettos and asked to leave mosaic
- They have found rare orchids monitoring in collaboration with Florida Atlantic University, Pine Jog orchids
- One more hydric hardwood hammock
- One very rare long claw orchid only six known in the population, and the pollinator is unknown; set up camera to try to help determine, but so far, no

luck

- Jingle Bell orchid and Ghost orchid threatened species in pond apple slough

 have seen some
- Partnership with Avian Research and Conservation Institute and Palm Beach Zoo and Conservation Society
- Loxahatchee Slough natural area pre-mitigation showed data on roost peak counts going up
- Showed tagging in action tag and release Swallowtail Kites all tagged in natural areas; winter grounds in South America and come back to same trees
- Deb discussed the link between what we're doing here and seeing the biodiversity of plants and birds and the improvement amazing graph shows over 10 years of data
- Albrey discussed wading birds known in the area; is there any indication that growth is because the areas are gone or because of what we're doing?; The answer- not just relocating them; they're seeing all roosts have more birds
- Snail Kites tagging nomadic go where the snails are
- Avian Research Institute has a lot of knowledge
- Hydrology seems to play a part
- We have significant habitat in the watershed that is important
- Short sighted to do a money grab for one part of the Everglades, really important to the entire Everglades
- Snail Kite roost definitely using the Loxahatchee Slough for foraging; trying to get snapshots of the banded ones

b. Town of Jupiter – Amanda Barnes

- i. Pennock Park design 90% complete; planning on finalizing and going out to bid in June; contractor November when it starts drying up, easier to get the work done
- ii. Bush Road SW Project 90% design and will bid as one project; grant agreement with FDEP is fully executed
- iii. Sims Creek finalizing agreement; target March 19th Council meeting for approval; initial design meeting set up in anticipation
- iv. Jones Creek vegetative trimming (primarily mangroves)– contractor still expects to be complete by March
 - 1. Contractor worked from the southwest to the northeast
 - 2. Very dense at the south end of the project
 - 3. Amanda will bring in a presentation until the work is done
 - 4. Project will include trimming a 30 foot wide corridor clearing; there is a ten (10) year contract in place for biennial (every two years) trimming, collected as a non-ad valorem assessment on the tax bill for adjacent property owners

c. Village of Tequesta – Marjorie Craig

 Dover Ditch – joint project with TOJ (40% TOJ, 60% VOT) – assigned a grant manager by FDEP; FDEP agreement for the grant is fully executed; final design review complete with a few comments; permitting continues; Army Corps permit will be the critical path

d. Martin County – Elizabeth Kelly

- Just acquired 250 acres in Pal Mar negotiated acquisition and close next week; \$10,000 an acre
- Used remaining money for acquisition (DC Saxon??:)
- Two weeks from now have another potential funding mechanism; ½ cent for 10 years , bond \$140M for four priority areas
 - 1. Pal-Mar
 - 2. Loxalucie
 - 3. Blueways (local small holdings)
 - 4. Indian River Lagoon south (part of CERP)

e. Jupiter Inlet District – Tom Howard

- Update on dredging and 6 mile oxbow
- Living shoreline Tom Howard coordinated living shoreline reached out; previously did a project with ERM in the 1990's, so will soon be overgrown if not proactive
- Dredging planned for the spring and planning to move to the left due to the increase in deposit volumes experienced
- Mile Gap Oxbow Restoration project funded through the LRPI finishing plans and specs

4. Other Business

- Discussed April LRPI meeting and potential agenda items
 - Marjorie told the group that she will not be able to attend the April meeting, if one is held, due to a conflict
 - Deb said she can send out email with updates on funding and projects that were updated, if needed
- June applications in; we'll know where we stand
- Possible future presentations:
 - Sawfish Island (was a ribbon cutting)
 - Seagrass
 - JID dredging projrects and 6 mile oxbow
 - Living shorelines?
- Deb Drum will distribute PowerPoint presentations and for now plan on having an April meeting, however, we won't meet if there are not agenda items
