II. Public Comment

There were no comments from the public.

III. Old / New Business

A. Old Business

1. Review and approval of August 8th, 2022 initiative meeting minutes John Maehl made a motion to approve the August 8th, 2022 meeting minutes and Deb Drum seconded the motion. The motion passed with unanimous support.

B. New Business

1. Legislative Update and Calendar

Ed Chase informed the committee that a Reorganization Session will be held November 21st and 22nd. He also reported that a Special Session of the Legislature is anticipated to occur either the first or second week of December. At the next LRPI

meeting, Ed will introduce the committee to the new Legislative Director for Palm Beach County, Kasey Denny.

2. Agency Update

Mike Dillon, South Indian River Water Control District (SIRWCD) shared a public information video produced by SIRWCD to illustrate the purpose and function of the water management system of the District.

Albrey Arrington asked that the link to the SIRWCD's video be shared with Jenny for distribution to the committee members.

3. Revision of Guidelines for voting by proxy verbiage

Deb Drum noted the committee approved edits to Article IV., F. 3. of the LRPI Guidelines at a meeting held on April 21, 2014; however, the changes were not incorporated into an updated LRPI guidelines document. The language modifications approved in 2014 guided members to submit their votes to the Chair and Secretary. The committee moved to update the guidelines with the requirement to submit votes to the LRPI administrative staff. Deb Drum motioned to approved amending the language to remove "Chair" and "Secretary" and replace with "LRPI administrative staff". David Brown seconded the motion. The motion passed with unanimous support.

Jenny Smith, SFWMD, will provide an updated copy of the LRPI Guidelines for distribution to the committee and upload to the LRPI website.

4. Approval of 2023 Calendar

A copy of the 2023 calendar was passed around. Albrey asked Jenny Smith to review the calendar to ensure there are no meetings occurring on religious holidays.

5. Other Business

Deb Drum noted that Palm Beach County submitted a resiliency grant application made to enhance the Corbett Area <u>levee</u> with the intent to maintain the water level in the natural area.





Cypress Creek

Martin County included in its Capital Improvement Plan a project to construct a
weir along Ranch Colony Canal and create a stormwater treatment area in the
old grove area next to the proposed weir location. This project, and others, could
be discussed among a "Loxahatchee River Watershed Restoration Working
Group" as suggested at the last Loxahatchee River Management Coordinating
Council meeting. Martin County plans on submitting this project for LRPI grant
consideration in August 2014.

Public Access

- Vehicle Access Authorizations being issued for access through the vehicle gate on Gulfstream Citrus and Hungryland Gate 9 (into Culpepper Ranch). Recently there has been an issue with both of these gates being left open. Action is being taken to prevent the problem from continuing.
- In early May (originally scheduled for March, but water levels were too high) a
 volunteer group is planning to install trail markers on the multimodal trail system
 in the Cypress Creek natural area.
- This past (4/19-20) weekend volunteers began scouting multimodal trails in the eastern sections of Pal Mar East.

Kitching Creek

- The County has contracted with Arbor Tree and Land, for the construction of the Kitching Creek project, in the amount of \$2,526,210.
- Martin County staff and Martin County Utilities' consultant has started permitting
 efforts in pursuit of filling the old South County Land Fill Site with the inert clean
 debris from the Kitching Creek project site.
- Construction commenced on January 13, 2014 and is scheduled to be complete
 in April 2015. Construction has progressed with the clearing and grubbing of the
 site, screening and burning of the vegetative debris and excavation of the lakes.

GUIDELINES

Proposed Revision to Article IV Meetings, F. Voting, 3. Proxies

Article IV. Meetings.

F. Voting

- Quorum. A quorum shall consist of a simple majority of the members of the LRPI, and every
 action and decision rendered by the LRPI must be approved by the quorum. All agenda items
 shall be discussed. A motion shall then be made to vote on the item. If a motion fails, discussion
 may continue.
- 2. Alternates. Each member may designate an alternate for informational purposes only but who will not have voting authority for that member.

3. Proxies. All voting members should be present to vote. No proxies will be permitted. In the event a member cannot attend the committee meeting in person, a member may submit the vote electronically to the Chair. Votes must be submitted one business day in advance of the vote.
