## 2021-2022 Singer's Contract

I understand that as a singer with Meritage Vocal Arts Ensemble, I am responsible for payment of \$225.00 as annual dues for the 2021-22 musical season. I understand that these dues are necessary to help offset some operating costs for Meritage. I also understand that I am committed to regular, on-time attendance at all rehearsals, weekend workshops, music festivals, dress rehearsals and concerts as scheduled by the Artistic Director, unless the Director excuses my participation. In the event that I am excused from a concert and/or its rehearsals, I understand that my absence does not alter the amount required for annual dues. I understand that I am expected to sell at least two tickets to each performance, as outlined in the Singers Handbook. Furthermore, I agree to abide by all the rules and conditions outlined in the Singers Handbook found on the website at [Meritage-VocalArts.org](http://Meritage-VocalArts.org).

**This contract, signed by each singer, is due on or before September 14, 2021 to Wendy Stokes, Meritage Vice-President.**

### ***The following are options for payment:***

1. **Single payment of \$225, due by October 4, 2021 \_\_\_\_\_ (initial)**

*NOTE: Students currently enrolled in an accredited institution get an automatic 50% scholarship with a printed proof of registration. If the singer opts for the payment plan, each payment will be \$25 on the assigned dates below. Attach the proof of registration to this application.*

2. **Four payments each due as indicated below : \_\_\_\_\_ (initial)**

- (1) \$75 – due October 4, 2021
- (2) \$50 – due December 7, 2021
- (3) \$50 – due February 1, 2022
- (4) \$50 – due April 5, 2022

3. **Nine monthly payments of \$25 beginning September 7, 2021 \_\_\_\_\_ (initial)**

4. **Single donation of \$1000, due October 4, 2021 \_\_\_\_\_ (initial)**

With this tax deductible option your annual dues are waived, you receive two tickets to all concerts of the season, 2 tickets to our annual fundraising event, donor recognition in the program, and donor ad in the program if desired.

5. **Single donation of \$2500, due October 4, 2021 \_\_\_\_\_ (initial)**

With this tax deductible option your annual dues are waived, you receive four tickets to all concerts of the season, four tickets to our annual fundraising event, donor recognition in the program, donor ad in the program if desired, and donor recognition by the Artistic Director at a concert of choice.
