# HSE and industry guidance

HSG's and industry guidance give practical advice

#### **HSE** and industry guidance

- Issued by the HSE and industry organisations, trade associations.
- Not legally enforceable but give <u>practical advice</u> on how regulations can be complied with.
- Following the advice in HSE guidance ensures enough is being done to comply with the law.

#### Health and safety acts

2.3.2 The table below shows a summary of the **Acts** applicable to the procedural control of temporary works:

#### The Health and Safety at Work etc, Act 1974

- Under section 2, employers have the duty to provide:
  - a safe environment
  - a safe system of work
  - Relevant training
  - Safe equipment
  - an assessment of risks in the workplace
- Under section 7, employees have corresponding duties
- Section 6 relates to designers, manufacturuers and suppliers
- Section 20 provides powers to HSE inspectors

# Corporate Manslaughter and Corporate Homicide Act 2007

- Companies can be found guilty of corporate manslaughter due to a gross breach of a duty of care.
- Clarifies the criminal liabilities of companies including large organisations where serious failures result in a fatality.
- Corporate bodies will be prosecuted, not individuals.
- Individuals, members, can also be prosecuted under health and safety law
- On 15 February 2011, a jury at Winchester Crown Court found <u>first company guilty of</u> <u>corporate manslaughter</u>.

#### Health and safety regulations

2.3.3 Temporary works designers and co-ordinators are provided with copies of the above legislation and Approved Codes of Practice and guidance publications. Employers and the self-employed should ensure that they take appropriate steps keep employees, including temporary works designers and co-ordinators, updated of any changes to relevant legislation and revised guidance material.

## 2.3 Summary of law and guidance

2.3.4 The table below shows a summary of the **regulations** applicable to the construction industry relating to the management, design and build of temporary works and those reflected in the **fifth edition** BS 5975-1:2024 Part 1.
