### **RADAR & LIDAR Instructor Certification**

Thank you for your interest in a 40-hour **RADAR & LIDAR Instructor Certification** course of instruction by Law Enforcement Services, LLC. This course meets and exceeds all National Highway Traffic Safety Administration (NHTSA) standards and has been taught to hundreds of police and military personnel throughout the United States, Canada and Europe. The cost of this course may be covered by charging a basic tuition fee for each student or by contracting a set fee that may be paid through training budgets. The basic cost of this course is \$6,500.00 for up to 20 students.

Therefore, officer tuition of \$325 per officer with 20 officers will cover this cost. The hosting agency is responsible for collection of all tuition fees and for paying Law Enforcement Services, LLC with a single check at the completion of the course of instruction. The hosting agency may elect to send additional personnel for an additional fee of \$300 per officers up to 25 officers maximum. In the event the hosting agency does not have 20 officers registered for this course, the course may still be held provided the hosting agency accepts the costs of the course: \$3,000 plus student manuals, instructor Flashdrives, final exams and travel expenses. (\*Note: Travel and lodging prices vary from location to location and may account for an additional expense.)

The hosting agency shall be responsible for providing a training facility (classroom), complete with audio and video capabilities for PowerPoint presentations. (Law Enforcement Services, LLC, can provide a projector and sound system for an additional fee in the event this equipment is not available at your facility.)

#### **Required Equipment:**

Each officer is required to have a basic scientific calculator capable of trigonometric functions (sin, cos, tan), such as a Texas Instrument TI-30. (These calculators cost about \$20.00.)

All officers are encouraged to bring the radar and lidar equipment their department currently uses.

Law Enforcement Services, LLC will bring the latest in radar and lidar technology.

#### **Student Prerequisites:**

Since this is an instructor certification course, all officers are required to have prior experience operating radar and must have their department's support. Prior lidar experience is not a prerequisite.

All officers will receive the book **Understanding Police Traffic RADAR & LIDAR** written by the owner of Law Enforcement Services, LLC. This 200 page training manual is continually updated with the latest in radar and lidar technology and case law.

Each officer will also receive the **Instructor Flashdrive** that contains 602 slides, 30 audio clips, 59 video clips, 4 GIF files, and closely follows the student manual. Instructors also receive a copy of the **final exam**.

Each officer must demonstrate their teaching skills by giving a 15 to 20 minute presentation before the entire class, on a chapter of ***Understanding Police Traffic RADAR & LIDAR***.
