

Participant Waiver, Release of Liability, and Assumption of Risk

THIS WAIVER MUST BE COMPLETED FOR PARTICIPATION

I, the undersigned Participant (including parents or legal guardian of Participant, if Participant is under 18 years of age), desire to voluntarily participate in the Scotty Pippen Jr, Basketball Camp hosted by the Memphis Sports & Events Center (“Memphis S&E”)

_____ and/or its affiliated organizations. The activity will be held at the Memphis Sports & Events Center on July 31 – August 1, 2025. Participants of the event may elect to take part in various physical activities, including _____, and other social activities (each an “activity”).

Participants voluntarily elected to participate in the activity. Participant understands that Memphis S&E does not guarantee Participant’s safety during participation in the activity and that there are inherent risks of property damage and personal injury to Participant and others that may result from participation. The specific risks may range from minor injuries (e.g., scratches, bruises, or cuts) to catastrophic injuries (e.g., paralysis or death). Participant understands that injuries or outcomes may arise from Participant’s own or others’ actions, inaction, or negligence; conditions related to any travel or other aspects of participation in the activity; or the condition of the location or premises where the activity is taking place.

I also acknowledge that Memphis S&E reserves the right, at its sole discretion and without prior notice, to deny or terminate my (or my child’s) participation in the Camp for any reason, including violations of Camp rules or behavior deemed unsafe or disruptive..

Participant voluntarily assumes the risks related to infectious disease, personal injury, or property damage by voluntarily participating in this activity. Participants also acknowledge that it is Participant’s responsibility to take precautions to safeguard Participant’s health and safety. Participant understands that the rules and regulations of the activity and Memphis S&E are designed for the safety and protection of all participants, and Participant hereby agrees to abide by these rules and regulations.

Furthermore, in consideration of Memphis S&E offering this opportunity to participate in this activity, Participant agrees to and hereby does release from fault and discharge Memphis S&E and its trustees, agents, officers, employees, representatives, and servants (the “Parties”) against loss (including reasonable attorneys’ fees), from claims, demands, rights, or causes of action of any kind or nature (“Claims”) to the extent arising from the negligent acts or omissions of Memphis S&E and relating to Participant’s participation in the activity. Without limitation, Claims include those at any time made or brought by Participant, or by any other person having a legal interest thereof, arising from or by reason of known or unknown, foreseen and unforeseen bodily or personal injuries, damages to property and consequences thereof which may be

sustained by Participant as a consequence of any accident or injuries in connection with the activity. Further, Participant agrees to indemnify and hold harmless the Parties from Claims relating to participation in the activity.

Participants attest that they are physically and mentally capable of participating in the activity. If the Participant suffers an injury or illness while participating in this activity, or any other activity associated with the event, they authorize the party to use their discretion for transportation to a health care facility, while the Participant takes full legal and financial liability for such action and the payment of all care they may receive. The Participant further grants and conveys to Memphis S&E any right, title, and interest in all photographic images, video, or audio recordings, and all copies thereof made of them by Memphis Sports & Events Center during participation in the activity, including but not limited to any royalties, proceeds, or other benefits derived from such photographs or recordings. The Participant understands that Memphis Sports & Events Center and/or More Than Basketball may use such images or recordings for promotional purposes.

This agreement is intended to be broad and inclusive as permitted by the state of Tennessee. If any portion of this agreement is held to be invalid, then any such holding shall not affect the validity of the valid portions. This agreement will be construed per Tennessee law, and Participant agrees to submit to jurisdiction and venue in the state courts of Shelby County, Tennessee.
