| Dec. 3 | Depart from Chicago or Miami Airport. Arrive in Mexico City. Transfer to hotel. |
| Dec. 4 | Tour the Shrine of Our Lady of Guadalupe . |
| Dec. 5 | Visit the Cathedral Metropolitana and Church of San Francisco, where St. Juan Diego brought his tilma to the Bishop, in the Ancient Mexico City Center. Time permitting, take a ride on Trajineras, or “Floating Garden” boats on the river. Pray at the tomb of Blessed Conchita Cabrera de Armida. |
| Dec. 6 | Visit the Teotihuacan Pyramids: See how Our Lady conquered the pagan gods of the sun, moon, and the Old Stone Serpent, putting an end to a brutal culture of death. Afterwards, witness an “agave presentation” to see how many things, including St. Juan Diego’s tilma, can be made from an agave plant. Also, visit the church where St. Juan Diego’s uncle was healed. |
| Dec. 7 | Tour historic Church approved sites of St. Michael’s Well and Our Lady of Ocotlan in Tlaxcala. |
| Dec. 8 | Visit Holy Family Jesuit Church with the remains of Blessed Miguel Pro. Feast of the Immaculate Conception . Return to the Basilica of Our Lady of Guadalupe. Visit the Plaza of Three cultures where St. Juan Diego was baptized. |
| Dec. 9 | To airport for return flight, arrive in U.S.A. P.M. |
