# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to https://thescentsociety.info, and The Scent Society and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Scent Society include https://thescentsociety.info. The The Scent Society website is a News, Information, Home Decor & Health tips site. By using the The Scent Society website, you consent to the data practices described in this statement.

# **Collection of your Personal Information**

In order to better provide you with products and services offered, The Scent Society may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. # **Use of your Personal Information**

# **Sharing Information with Third Parties**

The Scent Society does not sell, rent or lease its customer lists to third parties.

The Scent Society may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to The Scent Society, and they are required to maintain the confidentiality of your information.

The Scent Society may disclose your personal information, without notice, if required to do so by

law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on The Scent Society or the site; (b) protect and defend the rights or property of The Scent Society; and/or (c) act under exigent circumstances to protect the personal safety of users of The Scent Society, or the public.

#### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by The Scent Society. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the The Scent Society website.

#### **Use of Cookies**

- SSL Protocol

# **Right to Deletion**

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
