## **Privacy Policy**

This Privacy Policy describes how Domo Pets USA ("we," "us," or "our") collects, uses, and shares personal data of users ("you" or "users") who access or use our website, https://domopetsusa.com/ (the "Website").

#### 1. Information We Collect

We collect several types of information from and about users of our Website, including information:

### • Directly Provided by You:

- Account Information: If you create an account, we may collect your name, email address, username, password, and any other information you provide during the registration process.
- **Profile Information:** You may choose to provide additional information for your profile, such as your picture, biography, location, and interests.
- Content You Submit: We collect the information you post, upload, or otherwise make available on the Website, such as comments, messages, articles, and other content.
- Communications: When you contact us directly, we may receive information such as your name, email address, phone number, the contents of your message, and any attachments you may send us.
- Transaction Information: If you make purchases through our Website, we collect information necessary to process the transaction, such as your payment card details and billing information.

## • Automatically Collected Information:

Log Files: Like many website operators, we gather information that your browser sends whenever you visit our Website ("Log Data"). This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Website that you visit, the time and date of your visit, the time spent on those pages, and other statistics.

- Cookies and Similar Technologies: We use cookies, web beacons, and similar tracking technologies to collect information about your activity on our Website. This information may include your browsing patterns, preferences, and interactions with the Website.
  - Cookies: Small data files stored on your device.
  - **Web beacons:** Electronic images that allow us to count users who have visited certain pages or opened certain emails.
- Device Information: We may collect information about the device you use to access our Website, including the device type, operating system, and unique device identifiers.
- Usage Data: We collect information about how you use our Website, including the pages you visit, the links you click, and the actions you take.
- Location Data: We may collect information about your general location (e.g., city, state) based on your IP address.

#### 2. How We Use Your Information

We use the information we collect for various purposes, including:

- To Provide and Maintain the Website: To operate, maintain, and improve our Website and its features.
- **To Manage Your Account:** To create and manage your account, provide you with access to the Website, and personalize your experience.

### 3. Sharing Your Information

We may share your information with third parties in the following circumstances:

- Service Providers: We may share your information with third-party service

  analysis, email delivery, payment processing, and customer support. These
  service providers are contractually obligated to protect your information and only
  use it for the purposes for which it was disclosed.
- Other Users: When you share content or interact with other users on the Website, your information may be visible to those users. For example, if you post a comment, your username and comment will be visible to other users.
- **Affiliates:** We may share your information with our affiliates, which are entities that control, are controlled by, or are under common control with us, for purposes consistent with this Privacy Policy.
- **Business Transfers:** In the event of a merger, acquisition, or sale of all or a portion of our assets, your information may be transferred as part of the transaction. We will notify you of any such change in ownership or control of your data.
- **Legal Compliance:** We may disclose your information to law enforcement agencies, government authorities, or other third parties if required to do so by law or in response to a valid legal request, such as a subpoena or court order.
- **Protection of Rights:** We may disclose your information if we believe it is necessary to protect our rights, property, or safety, or the rights, property, or safety of others.
- With Your Consent: We may share your information with third parties with your consent.

# 4. Your Choices and Rights

## 5. Data Security

We take reasonable measures to protect your personal data from unauthorized access, use, or disclosure. These measures include:

- **Encryption:** We use encryption to protect sensitive information transmitted online.
- Access Controls: We restrict access to your personal data to authorized personnel only.
- Security Monitoring: We monitor our systems for potential security breaches.

#### 6. Data Retention

We will retain your personal data for as long as necessary to fulfill the purposes

outlined in this Privacy Policy, unless a longer retention period is required or permitted by law. The criteria used to determine our retention periods include:

- The length of time we have had an ongoing relationship with you.
- Whether there is a legal obligation to which we are subject, or
- Whether retention is advisable in light of our legal position (such as regarding the enforcement of our agreements).

### 7. Children's Privacy
