

DISECTING THE FALSE ABC 13 NEWS REPORT:

Items to understand:

- Our accountants, and personnel never questioned and the expenses they are referring to, where later proven to be items that were spent on the health and welfare of employees, such as daily breakfast and lunch served to all employees, car, training, education, living and insurance paid to employee benefit. These items are never mentioned.
- There are no expenses that can be shown outside of the agreements, business operations and full approval of the board.

Now the actual report:

- ABC 13 woke my Autistic son by intruding on our property, which created three days of seizures and issues.
- ABC 13 filmed my property and vehicles, mis-stating fact.
- ABC 13 edited and doctored footage they used to benefit the false narrative.
- Used NASCAR connection to sensationalize story
- False statement #1: "...A former professional race car driver is accused of pulling a fast one on unsuspecting victims to steal their money for his "personal enrichment...." But offers zero proof, in fact there was no personal enrichment and quite the opposite, funding aspects of the accusers life, education, recovery and subsistence. There was no validation of the sources.

- False statement # 5: "...The alleged victims got nothing in return..." No victim statements or interviews, no clue what she is referring to in this statement, as this is absolutely untrue and goes against thirty years fo proven business without a single complaint, and over 900 public testimonials. Usually there is a bandwagon pile on, so where is it? Outside of the 106,000 documented social media and false reporting messages to places like RIPOFF Report, and know dark web extortionary tactic, where are all the complaints? - False statement # 7: "... sold as an investment deal.... took hundreds of thousands of dollars..." Absolutely untrue and have no proof of this. No investigation, no questions and see attached documents.
