1. I am familiar with and accept that there is the risk of serious injury and death in participation, whether as a competitor, student, official or worker, in all forms of motor sport and in particular in being allowed to enter, for any reason, any restricted area; and
2. I have satisfied myself and believe that I am physically, emotionally and mentally able to participate in this TRACK, and that My protective clothing, gear and equipment is fit and appropriate for my role as a participant in the TRACK; and
3. I understand that all applicable rules for participation must be followed including the 2021 NAPA Sportsman Tech Rules and the NAPA Sportsman Procedures, regardless of my role and that at all times during the series the sole responsibility for my personal safety remains with me; and
4. I acknowledge that I have read the 2021 NAPA Sportsman Tech Rules and agree to be bound by them. I understand and accept that I am solely responsible for ensuring that I fully comply with the Rules and Procedures; and
