- Scott Wingo, who is with OIG in Ann Arbor, will be a presenter.
- Henry Ford College and Northwestern Michigan College have reported receiving “official” high school transcripts from suspected fraudulent applications. Some are even being sent from official sources like Parchment and Student Clearinghouse.
- Washtenaw reported a really good “fake” id came into them. Somebody brought it in-person but left immediately when Public Safety was called.
- Washtenaw has purchased handheld scanners to scan ID’s. Scan works on either images or real id in person. Scanners cost about \$20 and verifies if the info matches. Here is a [link](#) to the scanners that Pete bought at Washtenaw.
- Mott Community College has a draft flow chart of dealing with Fraud. (see attached)
- Delta is working to terminate contract with SAFE. They report Macomb is doing the same thing.
- NMC and Washtenaw only refund money to the credit card that was originally charged.

### **Guest Student Process**

- KVCC is going to start requiring transcripts for guest registration. Students use the regular Kellogg CC app. KVCC heavily uses guided self-placement for allowing guest students to register.
- NMC only requires their own app plus an unofficial transcript. Students must list what courses they wish to take as a guest student. They enter waivers to allow students to register for approved classes.
- Monroe manually register guest students. They require an unofficial copy of their transcript. Students use MCCC’s regular admissions app.

- Mott still uses the Michigan Uniform Guest App. Manually register students.
- NMC requires a new guest app every semester.
- Schoolcraft & Washtenaw – both use their own admissions app for Guest students who are admitted are allowed to reg for two years.

### **Dual Enrollment**

- NMC requires new dual app for every semester.
- LCC moving towards requiring a new dual app for every semester.
- Jackson moved dual app to CRM. Only require one app while in HS for dual enrollment, but require a new info update form every semester to collect updated info.
- Schoolcraft and OCC also moving toward only one dual app during high school career. Add a hold on student records to prevent reg after their expected HS grad date.
