OKLAHOMA SECRETARY OF STATE

We, the undersigned legal voters of the State of Oklahoma respectfully order that the following proposed amendment to the constitution shall be submitted to the legal voters of the State of Oklahoma for their approval or rejection at the next regular general election (or at a special election as may be called by the Governor), and each for himself or herself says: I have personally signed this petition; I am a legal voter of the State of Oklahoma; and my legal first name, legal last name, zip code, house number, and numerical month and day of my birth are correctly written on this form. The time for filing this petition expires ninety (90) days from ____. The question we herewith submit to our fellow voters is: Shall the following proposed amendment to the Constitution be approved?

Be it enacted by the People of the State of Oklahoma that Article V, Section 30A of the Oklahoma Constitution be adopted to read as follows:

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1 AMENDATORY 68 O.S. § 2890 IS AMENDED TO READ AS FOLLOWS:

A. Beginning with tax year 2027 and thereafter, every homestead qualified under the laws of this state shall be entitled to an exemption from all ad valorem taxation as follows:

- 1. For tax year 2027: an amount equal to thirty-three and one-third percent (331/3%) of the full assessed value of the homestead;
- 2. For tax year 2028: an amount equal to sixty-six and two-thirds percent (663/4%) of the full assessed value of the homestead;
- 3. For tax year 2029 and all subsequent tax years: an amount equal to one hundred percent (100%) of the full assessed value of the homestead.
- B. The exemption shall be the greater of any current exemption for homesteads or that provided in subsection A and shall apply uniformly to every qualifying homestead within the State and shall supersede any lesser exemption provided by prior law.
- C. Notwithstanding any provision of this section, the exemption shall not apply to ad valorem taxes levied for the payment of principal or interest on any valid bonded indebtedness incurred by any school district, county, municipality, or other political subdivision prior to December 31, 2026.

SECTION 2 IMPLEMENTATION

The Oklahoma Tax Commission shall promulgate rules and provide all forms necessary to implement the incremental exemptions set forth in Section 1 no later than Dec 31, 2026 County assessors shall apply the applicable percentage exemption automatically to all properties currently receiving the homestead exemption.

SECTION 3 EFFECTIVE DATE

This act shall become effective January 1, 2027, and shall first apply to ad valorem taxes payable in calendar year 2027.

SECTION 4. RESTRICTION ON AMENDMENT OR REPEAL

This act, having been enacted by vote of the people, shall not be amended or repealed except by a vote of the people of the State of Oklahoma at a subsequent statewide election.

GIST OF THE PROPOSITION

This measure eliminates ad valorem taxes on owner-occupied homesteads in three equal steps: 331/3% of assessed value exempt in 2027, 661/3% in 2028, and 100% in 2029 and thereafter. Taxes needed to repay bonded debt issued before December 31, 2026 remains collectible. Effective January 1, 2027. Only voters may later amend or repeal this act

Fiscal impact:

Approximately \$400 million reduction of ad valorem revenue in 2027, \$800 million in 2028, and \$1.2 billion annually beginning 2029.

SUGGESTED BALLOT TITLE

(Final version set by the Attorney General)

Shall the following be approved?

A law enlarging the homestead exemption from ad valorem taxation in three equal annual increments (331/3% in 2027, 661/3% in 2028, and 100% beginning in 2029), preserving taxes for pre-2027 bonded debt, effective January 1, 2027, and which may be amended or repealed only by vote of the people.
