- 1. Administrator:** Dealer Loyalty Protection, Inc. PO BOX 457 Mahwah, NJ 07430.
- 2. Dealer:** The dealership that installed the **Product** on **Your** vehicle to protect **Your** vehicle's catalytic converter.
- 3. Coverage:** In the event the registration number installed on the catalytic converter(s) of the vehicle fails to prevent the catalytic converter(s) from being stolen and recovered within thirty (30) days, the **Warrantor** agrees to provide a credit of the selected benefit of either Limited Warranty Plan A or Limited Warranty Plan B to the repair facility. Coverage is provided up to the amount needed to replace the stolen catalytic converter(s). If no selection is made, **You** will receive coverage under Limited Warranty Plan A.
- 4. Cancellation:** The **Registration Number** is permanently on **Your** catalytic converter(s); therefore, this Limited Warranty is non-cancellable and non-returnable.
- 5. Claims Procedure:** Administrator will provide information on **Your** claims options and claim settlement. Replacements must be installed by an authorized repair facility. To qualify for coverage under this Limited Warranty, the following **Claim Procedure(s)** must be followed:
  - a)** If **Your** catalytic converter(s) is stolen, **You** must file a claim with **Administrator** within thirty (30) days or **Your** claim will be denied.
  - b)** **You** must provide **Administrator** with a copy of the police report **You** obtained regarding the theft.
  - c)** **You** must provide **Administrator** with this Limited Warranty.
  - d)** **You** must obtain prior authorization before any replacements are made. Any work completed without prior authorization will be denied.
- 6. Eligibility:** To be eligible for this Limited Warranty, the catalytic converter(s) attached to **Your** vehicle listed above, must have the **Registration Number** listed above installed on the vehicle's catalytic converter(s) by the **Dealer**. This Limited Warranty is a Product Warranty and is not insurance.
- 7. Exclusions:** **You are not entitled to recover from Us any consequential damages, damage to property, damages for loss of use, loss of time, loss of profits, or income, or any other incidental damages. Total Vehicle theft; catalytic converter thefts prior to the Product Purchase Date.**
- 8. Registration Number/Product:** The identification number marked on the catalytic converter(s) of **Your** vehicle.
- 9. Term:** Either **Your** choice of thirty-six (36) months or sixty (60) months depending on the selection **You** make at the time of purchase. If no selection is made, a thirty-six-month **Term** will apply.
- 10. Transfer:** This Limited Warranty is not transferable.
