FRIDAY, JUNE 18, 2021

The 88th Annual Session of the Grand Guardian Council and 52nd Annual Session of the Grand Bethel of Wyoming was held on June 18 and 19, 2021 at Green River High School in Green River, Wyoming.

The Grand Bethel meeting was held at the Green River High School. The Grand Council meeting was held at the same time.

GRAND COUNCIL BUSINESS MEETING **Friday, June 18, 2021 morning**

Grand Guardian Marge Christiansen and Associate Grand Guardian Terry Wiekhorst welcomed all present and call the meeting to order.

The American Flag was presented by Grand Marshal Artha Smith followed by the singing of the National Anthem and Pledge of Allegiance. An invocation was given. Grand Marshal Artha Smith made the proclamation to open the business meeting.

Introductions of Past Grand Guardians, Past Associate Grand Guardians, Bethel Guardians and Associate Bethel Guardians, Council Members.

Grand Secretary Kathy Wiekhorst moved that the minutes of the 2019 Annual Session be approved as sent in the proceedings. Motion was seconded and passed.

Grand Guardian Report

When we started our year on June 15, 2019, in Cheyenne I would have never thought what would happen in the next two years. Our motto was "Each step leads to a new adventure". It has been quite an adventure. Our Grand family was Indica as Grand Bethel Honored Queen, Natalee as Miss Wyoming, Jessyka as Miss Congeniality, and Avey as Junior Miss.

I worked on the Jobie to be program and gave each bethel supplies to invite daughters to start coming to fun events and join when they could. I also made T-Shirts for Daughters who signed a petition for a new initiate. Many t-shirts were given out.

We had a delightful time at Summer Camp at Camp Story, there were beautiful Forget-me-nots blooming which was amazing. We made steppingstones which were great fun, played games and of course had a few shenanigans in the cabins. The night ended with a campfire, rededication, and s'mores. The next day we left after having a short church service. Thanks to Susie, Craig, and company for a great time.

We were then off to Supreme in August in very hot Kansas City. We enjoyed the Zoo and an outdoor dinner and theater presentation of The Wizard of Oz. What a fun time. Natalee did well in the Miss International Competition and the supreme team competed also. Natalee was Supreme Bethel Sr. Princess, along with Isabel as Supreme Bethel Representative to Ohio, Avey Jespersen Supreme Representative to Sao Paulo. The following girls had positions and were installed for the 2020-2021 Supreme Bethel Representative to Arizona Morgan, PHQ #50 and Supreme Bethel Representative to Montana Isabel PHQ, #2.

Due to the grand family not yet returning from Supreme, Susie Miner VGG, Craig Henderson AVGG and Jessyka Grand Bethel Senior Princess represented us at the Order of Eastern Star Grand Chapter in Cheyenne. Thank you.

We then traveled to Sheridan to attend Grand Lodge the next day after we returned from Supreme. We were presented with checks for the daughters. The end of the week we traveled to Douglas and participated in the State Fair Parade. We had the daughters from Bethel #1 join us.

In September we traveled on our first Adventure to the UW Football Game and then traveled to Cheyenne in the fog and had a Grand Bethel Meeting. It was great fun and not too cold.

In October the visits began at each visit I presented either an explanation of the bethel flag or the robe to educate the daughters on our symbols. We asked the Daughters what their favorite thing was about being a job's Daughter, a word to describe their bethel and to share any concerns they had. I also presented new initiates with a yellow rose and the rose bud poem. The Daughters gave me the name of the most positive girl in their bethel, and they were presented with a porcelain job's daughter and the Honored Queens also received a doll.

We started our first visit with Bethel #20 of course the traditional wasps were entertaining us at their visit. They initiated two daughters. Bethel 20 is a strong bethel and council; many daughters participate in sports and most events take place around their busy schedules. Unfortunately, many do not attend state events.

We then traveled to Bethel 1 they initiated three and had the Majority Ceremony for Cassie Cole. They are growing even through the pandemic but as many they need more adults to help. Unfortunately, I was not able to attend their last initiation due to Supreme not allowing travel to other bethels.

In November we then traveled to Sheridan. They have 4 members and initiated one. The Guardian and Honored Queen live in Worland which is touch. After Covid hit the Guardian moved and the Honored Queen moved for College. Spencer Morris is working hard to find daughters and adults to help. Susie Miner and I have had a few meetings to work on finding a female to help with the bethel.

In December we visited Bethel #7. They have 7 members and had 1 absent. There was no initiate, but I was informed that there were some petitions out. They continue to have great adult help but due to the daughters living in several different towns it can be difficult to get everyone together. They did have some zoom meetings and now have met in person.

2020 began and we had our first visit began with Bethel #50. The weather decided to not cooperate, so I-80 closed and Terry, Indica or Jessyka were unable to attend, but the GBHQ from Colorado was in attendance. Bethel #50 continues to be strong with many adults helping. They had 12 members present and one initiate at the visit. They continue to need parents to helping and have lost some daughters and others only meeting virtual.

Bethel #28 was next, there are 5 members and they initiated three daughters. The most adults that help are not parents which has become an issue. It was very difficult to get the daughters together and the council tried many different days and times with little success. Since the pandemic we have four daughters left with the other quitting due to being busy with other activities.

At the end of February, we traveled to Bethel #19 in Evanston. The daughters did a good job with many of them doing multiple positions. Concerns with the Bethel as they need new members as many daughters are getting older.

The next day we were supposed to be in Green River but with an approaching storm we cancelled their visit and headed home, thank goodness as there was a devastating wreck on I-80.

Bethel 3 was next, roads again got in the way of everyone being at the visit. Of course, they did excellent ritual work, but again limited adults and not a lot of parents helping. There were 3 initiates. We had a great hummingbird cake in honor of Indica and my mascot. Since the shutdown they are struggling with girls to attend.

Then the unthinkable happened and our "adventures" ended for over a year. The rules were suspended, the majority age extended to 21. The CAV rules continue to be in effect.

Everything then went virtual, and we finished our visits with Bethel #48 being on Zoom with 1 initiate. Wow things were different. Green River continues to have good adult support and have had several initiates through the last year.

We had an "adventure" planned to Thermopolis for a fun weekend, Grand Bethel Meeting and reopening Bethel #17. We also had an adventure planned to go to Denver and go to the Aquarium. Everything went virtual, we could only have online meetings and events. We became creative but all of us missed each other. Then in the fall of 2020 Supreme had very strict regulations but we were starting to be able to meet some but to no avail. In December everything was again shut down until March when in person meetings started again. We have had online fun with our neighbors from Colorado and tried to stay positive through this time. The Supreme Trustees have continued to have townhall meetings each month with the jurisdictions to discuss new developments, several of the Executive Guardian Council have attended regularly.

The Executive Guardian Council has had several meetings to discuss the best way to continue to support the adults and daughters around the state, we felt that having at least a modified Grand Session is the best plan, to move forward will hopefully give some new ideas and council members new positions to jump start the order.

To have a Grand Session that is more than one day with a sleep over component the Grand Bethel had to pay \$5000 to have an overnight event. This money will be held for three years to ensure that there are no legal issues due to Covid. We also must wear masks inside. This money was paid from a money market account that Grand Bethel had. In turn the Grand Bethel Cheerleaders event for Shrine Bowl was cancelled due to having to spend another \$5000 for the daughters to participate.

I want to thank each and every one of the adults for their support and dedication to the order and to continue having the daughter's best interest at the heart of every decision that is made. The safety of the daughters is the most important thing and I appreciate all

that you have done this last year. Of course, I have many concerns about the future of the organization, I would not be lying if I told you that the last year has been easy, but I have been honored to lead this great organization through the last 2 years. We truly do have the fairest in the land.

Even though it might have been on zoom, the girls looked forward to favorite animal show and tell, scavenger hunts, drop off goodies, ect. This is how we keep our order going forward in spite of unforeseen happenings. Thank you all!!

This year, as we began to plan for Grand Session we were confronted with strict Supreme guidelines. Your Executive Grand Council and Board of Trustees, met with the Supreme Board of Trustees and Executive Council concerning the fact that because we are the land of wide-open spaces, a one-day event was not going to be feasible. We had to pay \$5,000.00 to Supreme for permission to hold a two-day event. This money will be held by Supreme for three (3) years, accruing interest as long as no one contracts the virus here and sues us. These are very different times. We also were encouraged to secure a Directors and Officers Policy to cover our Officers. Several of our Board and Council Members were encouraged about this as they had experienced this in other avenues of their lives; and supported this action.

The packets will be available today with your council certificates. Also, those of you wanting to pick up financial or minute books, I have them with me. This will save you postage fees when you need them.

I do so appreciate those of you, who in spite of the pandemic continued to contribute to the 2/3 project and even more. You are the glue that hold us together.

Thanks to everyone who has helped throughout this transitional period. Thanks to Margie for working the credentials table. Thanks to Mike James for auditing Joan and My books. We once again balanced to the penny! Joan we are a great team!! Thanks for the opportunity to serve Wyoming Job's Daughters!!

Grand Treasurer's Report 2019-2020

Grand Guardian Marge, Associate Grand Guardian Terry, and Members of the Grand Guardian Council:

As of May 31, 2020, all outstanding bills have been paid and the Grand Treasurer's books balance with the Grand Secretary's books. The books have been audited.

The ending balance in the Grand Guardian Council Checking Account was \$17,026.03 as of May 31, 2020, as shown on the Financial Spreadsheet for the period of June 1, 2019, to May 31, 2020. This is a substantial increase over the previous year. To put this into perspective, I reviewed the checkbook balance for the prior 12 years and we averaged only \$6,854.97 per year. The same is true of the balance in the General Fund. This year, there is a positive balance of \$6,205.92. Again, when I reviewed this account for the same time period, 7 out of 12 of those years had a negative balance in the General Fund.

The following are the most significant one-time events that made the most significant contribution to this year's increase in the Grand Guardian Checking Account:

After many attempts to revive itself, Bethel 2, Laramie, decided to close due to a decline in membership and adult participation. In the fall of 2019, the Bethel closed and the balance in their checking account and certificate of deposit which totaled \$4,032.97 was turned over to the Grand Guardian Council.

Normally, HIKE Donations are pretty nominal. However, this year we received a check for \$2,000 from Widows Sons Wyoming Foundation, a Masonic organization. We are extremely grateful for this generous donation. The balance in the HIKE Donations account was sent to the HIKE Coordinator to provide hearing devices for children.

You may recall that in 2018-2019 we received a donation of \$2,000 in honor of Margaret Mickelson, PGG and Jim Mickelson, PAGG. These funds were deposited into an account established within the Grand Guardian Checking Account entitled "Wyoming Supreme Travel Fund". The Mickelson family requested that the funds be used to help the daughters attend Supreme Session. After a lengthy discussion at the 2018-2019 Grand Session, it was decided that the Grand Treasurer should look into options for the funds in order to keep the funds available for this purpose and to also earn interest. In September, an interest-bearing savings account was established at Platte Valley Bank with a beginning account balance of \$2,050. During the year, an additional \$1,450 was donated by the Mickelson family. That balance will be transferred to the savings account at Platte Valley Bank.

During the year, we also received a check for \$2,300 from the Scottish Rite Masons and deposited it into the "Miss Wyoming Supreme Account" account of the Grand Guardian Council Checking Account. The Scottish Rite had established an account many years ago that was controlled by Charlie Moore, PGM, to help Miss Wyoming Job's Daughter each year with expenses arising from having to attend Supreme Session. With Charlie's passing, the Scottish Rite decided to turn the funds over to the Grand Guardian Council. Another savings account will be established with these funds.

There were other increases in our income accounts that contributed to the larger than normal balance in the checking account for the 2019-2020 year. While it is very encouraging to have such a successful fiscal year, we cannot predict or depend on events such as these in the future. We will continue as we have in the past to be prudent with the use of our funds.

We were pleased that this year to be able to make a disbursement of \$500 from the Educational Fund (Educ Fund on the Financial Spreadsheet) to award a scholarship to one daughter. It is gratifying to be able to assist our daughters in furthering their education.

The daughters should be encouraged to apply for this scholarship. The eligibility requirements are outlined in the Wyoming-Standard Operating Procedure -GGC-3 Educational and Promotional Funds. Two \$500 scholarships will be awarded annually, and we have the funds to support this scholarship program.

For those of you who shop at Amazon online, if you have not already done so, please designate Wyoming Job's Daughters to receive a portion of your purchases that will be

rebated to a charity of your choice by signing up for AmazonSmile. We continued to receive small quarterly payments again this year.

As you can see, we had a great financial year. However, we do need your help and support to keep on tract for the upcoming year.

In closing, I would want to thank Marge Christiansen, Terry Wiekhorst, Kathy Wiekhorst, the Executive Council, and Mike James and the Finance Committee, for all the support and assistance you have given me. Thank you again for the opportunity to serve as your Grand Treasurer.

Grand Treasurer's Report 2020-2021

Grand Guardian Marge, Associate Grand Guardian Terry, and Members of the Grand Guardian Council:

As of the fiscal year ending May 31, 2021, all outstanding bills have been paid and the Grand Treasurer's books balance with the Grand Secretary's books. The Grand Treasurer's books have been audited by Mike James, Chairman of the Finance Committee prior to Grand Session.

This has been a challenging year for Wyoming Job's Daughters due to the Pandemic that wreaked havoc over the entire world. We ended the year with a balance of \$5,082.23 in our Grand Guardian Council Checking Account. Although this is a considerable decrease from the 2019-2020 balance of \$17,026.03, this is a respectable ending balance considering the unforeseen events that began in March of 2020. Looking back over a 12-year period, the average ending balance in the checking account has been \$6,854.97. In light of the world events, I believe we did fairly well.

The only real concern I have is that the General Fund had a negative balance of \$6,148.28 as can be seen on the enclosed Financial Spreadsheet for the period of 6/1/2020 – 5/31/2021. For 7 of the 12 years reviewed, the General Fund was negative at year end. Hopefully, the balance in the General Fund can be corrected in the next year.

If you review the Profit & Loss Statement for the year, the reasons why the General Fund is a negative amount will become very clear. There were two major events that took place this year that never occurred in the past.

First of all, the Grand Guardian Executive Council made the decision to pay the Annual Report fees of \$3,720.28 to the Supreme Guardian Council from the existing funds in the Grand Council Checking Account instead of collecting the members' dues from the bethels that was reported on their Annual Reports. Since the bethels were not meeting or rarely meeting in some cases, the Executive Grand Guardian Council members felt it was unfair to collect these fees from the daughters. Therefore, there is only an Annual Report Expense with no offsetting Annual Report Income shown on the Profit & Loss.

Another source of income that is noticeably missing is the dues paid by the adult members of the Grand Guardian Council. Since Grand Session was cancelled in 2020, Grand Guardian Council did not collect or receive dues from its members. Recently, the Grand Secretary sent a letter to the Grand Guardian Council members reminding them to pay dues for the upcoming year and to consider paying the previous year's dues.

Adding to the decrease in the checking account balance, there was a drop in the income received in both the Education Fund and Promotion Fund as seen on the Financial Spreadsheet. We received half of what we received in 2019-2020, \$455.20 as opposed to \$909.60. These are funds derived from the required Honored Queen's two-thirds projects. As stated earlier, most bethels were either not meeting at all or rarely met during this period of time.

By now, most of you know about the Other Income and Other Expense of \$5,000 as shown on the Profit & Loss. Because of Covid-19, Supreme recommended that no jurisdiction hold overnight events but gave the jurisdictions the option to be able to do so. With the distance between the cities and towns in Wyoming, the welfare of Wyoming Job's

Daughters, and the business that needed to be transacted, Wyoming elected to hold a two-day Grand Session. In order to hold a two-day Grand Session with an overnight stay, Supreme Council required a \$5,000 deposit to provide monetary assistance to JDI against any claims that could occur from an overnight event. The funds will be returned with interest at the end of a three-year period as long as no claims arise. The Supreme Council also required a Letter of Understanding be signed by the members of the Supreme Guardian Council and the Executive Grand Guardian Council. With the suspension of all rules and regulations, the Grand Bethel Trustees voted to use Grand Bethel funds for this purpose. The funds were transferred from Grand Bethel to Grand Council and the funds sent to the Supreme Guardian Council.

As was the case with all Grand Officers, Susan Miner and Craig Henderson remained as Vice Grand Guardian and Associate Grand Guardian for a second year. They took their responsibly very seriously. Since they repeated these offices for another year, they held a second Vice Grand Guardian's project. The two pasta sales fundraisers yielded \$1,288.40 for the Grand Guardian Council.

You may remember that during the 2019-2020 fiscal year we received a check for \$2,300 from the Scottish Rite Masons for the purpose of helping Miss Wyoming Job's Daughter each year with expenses arising from attending Supreme. To separate these funds from the operating funds of Grand Council and to be able to make additional deposits to this account, an interest-bearing savings account was opened at Platte Valley Bank with interest accruing quarterly.

Everyone did a great job in encouraging the daughters of the bethels to apply for the Wyoming Job's Daughters Scholarship. We were pleased to be able to award scholarships to two deserving daughters this year. Thanks for spreading the word.

The Grand Treasurer's basement was overrun with several storage bins filled with years of back-up documentation. The Grand Secretary contacted the Executive Director at the Supreme Office to determine what to keep and what to safely shed. I am happy to report that I had well over 100 lbs. of paper shredded at a cost of only seventy-five cents a pound and can now walk through the basement.

In closing, a special thanks goes to Marge and Terry for taking these last two years out of their busy lives to serve a second term as Grand Guardian and Associate Grand Guardian. I also want to thank Kathy Wiekhorst, Mike James and the Finance Committee and the Executive Guardian Council Members for working so well together for the good of Wyoming Job's Daughters.

And last but not least, I want to thank Grand Council for allowing me to serve as Grand Treasurer again this year.

Council Recommendation Report 2019-2021

2019-2020 Council Recommendations did not happen, due to the COVID pandemic and fluctuating Supreme requirements, as well as bethels' inability to meet in person. Most councils and even most line officers chose to remain in place.

As the 2021 recommendations approached, some bethels were beginning to meet in person, while some daughters still chose not to come to in-person events. Since bylaws were still suspended, Susan asked the EGGC if she could try something new – a survey type poll for the girls to submit their council recommendations. This would allow participation from all daughters, whether at the in-person meetings or not, ensuring anonymity as well as verification from bethels.

I used survey monkey for this and chose the step above free membership, which allowed for exporting data so results could be analyzed more easily. I (Susan) am not a super tech savvy person, but with help from Ray for data extraction, was able to do this. At first, I had designed a survey, listing all eligible CAV persons in that bethe's area, but was reminded that it would be leading the girls. So, I redid the survey with no CAV names.

The results came in with only one bethe not completing the survey at all. I communicated via email with Bethel Guardians, and they were very responsive and that was a great blessing! I let guardians know how many surveys I had received within a day or two of their meeting and they were able to nudge a few more girls to complete the survey in a timely fashion.

Once those results were compiled, I completed a separate letter for each bethe council and emailed that, as well as the Exec Meeting form to all Guardians. Most of those forms came back to me on time (several emailed and followed in mail). Girls' choices were very compatible with council choices, and I communicated with Kathy Wiekhorst, Grand Secretary. She is completing certificates for distribution at Grand Session.

I'd appreciate feedback from Guardians about how this process worked for them. Should we continue a more modernized collection from the girls at least?

Then all our lives changed when COVID - 19 broke out and we had to cancel our Spring Grand Bethel event. We held a meeting via Zoom on May 2, 2020. Although this wasn't the way we all envisioned our year to pan out we all made the best of it. The GGC and GBT meet via Zoom throughout the 2020 - 2021 year to keep up to date with new changes that were sent from Supreme

to ensure the safety for our daughters and adults were at the forefront of our minds. Indica, Grand Bethel Honored Queen held Zoom meetings periodically throughout the next few months but attendance was sporadic and sometimes defeating. Grand Bethel held another Zoom meeting on February 21, 2021. Attendance was again low but Indica did a great job leading a meeting over Zoom. I personally purchased gifts for the officers and reps that we able to attend and sent fifteen of them out through the mail to ensure that daughters felt they were appreciated.

Other events that the state held were: Shrine Hospital visit and Shrine Bowl Game, Summer Camp, Supreme, Grand Chapter, Grand Lodge, and Grand Visits throughout the state.

This year we had the following recipients nominated for the first Spirit of Job's Daughters award: Marge Christiansen Maria Criswell, Jerri Crompton, Margie George, Cindy Henderson, Mike James, Joan Means, Charlie Moore, Harry Oberg, Jan Poppe, Eric Ramirez, Karen Stapleton, Troy Swartz, Terry Wiekhorst. Although not all of them were able to attend in person, we did have a virtual component and will offer the ceremony to the other recipients next year or the following year as the bylaws reflect that they have three years to accept their award.

We also had three nominations to receive the Degree of Royal Purple award. Two were in attendance and one attended virtually and her medallion and flowers were delivered to her after Grand Session: Mindy Grice, Ashley Kiernan, Jesi Skretteberg

The Grand Bethel Trustees had many things that they wanted to work on this year but that was changed slightly by a worldwide pandemic.

A few things Indica, Grand Bethel, and the Trustees worked on this year were:

1. Giving Charlie Moore the Spirit of Job award even though he had passed away as he is one of the primary reasons the award was created.
2. It was moved to have the GBSP test have the option for an open book Constitution and Bylaws portion of the test.
3. Bylaw change for sashes to be purchased for the GBSP and GBHQ each year.
4. Bylaw change for the Grand Treasurer to receive monthly payments of \$200.00 each month beginning July 1, 2020.
5. Spirit of Job Medallions were discussed to ensure the daughters were okay with the way they looked.
6. Spirit of Job Certificate was created for each of the recipients to receive during the ceremony.

After a whirlwind of events taking place on Zoom and then the rules being lightened we were able to meet in person for a short time and then promptly directed back to meeting on Zoom. Multiple meetings with the GGC and the GBT where held to discuss recommendations and considerations from Supreme about what actions we as a state wanted to take in order to move forward. It was decided to transfer \$5000.00 from Grand Bethel treasury to Grand Guardian Council treasury to be able to send a check to Supreme so that Grand Session could be held. This money will be sent back to the state after 3-years to cover any legal issues that might arise from holding an in-person event during COVID-19. It was also determined for Grand that daughters could attend the Grand Bethel

meeting virtually and still accept a Grand Bethel Officer or Representative position. Thank you to Monica Ramirez for pro-teming Grand Bethel Guardian for me at Grand as I was unable to attend Grand secondary to being in clinicals for school.

One daughter submitted her letter of intent for Grand Bethel Senior Princess. She participated in a written test that was given by Kathy Wiekhorst prior to Grand session taking place. With only one daughter she was selected as Grand Bethel Senior Princess 21-22 and will advance to Grand Bethel Honored Queen at Grand in Gillette Wyoming in June of 2022.

I purchased two sashes from the Sash Spot for the Grand Bethel Senior Princess and Grand Bethel Honored Queen and was reimbursed by Grand Bethel \$107.47. Maria Criswell usually makes the sashes for the state and this year decided that she was unable to complete making these secondary to health concerns.

Thank you to all of the Trustees (Monica Ramirez, Ray Miner, Stephanie Aaron-Ludwig, Linda Cole, and Paul Lincoln) for your help, support, advice, and encouragement these past two year. I couldn't have done it without you.

Thank you Indica for being a wonderful and dedicated Grand Bethel Honored Queen who was always spot on with all your ritualistic work which you know is a pet peeve of mine 😊. The last three years with you have been amazing, thank you for your patience as we grew together through this process.

Kathy Wiekhorst thank you so much for helping me through everything that has taken place throughout this journey and always making sure everything was done.

Regis thank you for taking this journey with me and helping with everything along the way. I couldn't think of anyone better to have by my side then you. You always knew when I needed help and were there to offer a hand.

Mom, thanks for always being there when I needed you, listening to me going crazy, and continuing to be in the organization with me. I know it has been a whirlwind but glad we have been able to do it together.

Shrine Bowl Cheerleaders Report Monica Ramirez and Ray Miner

The Shrine Bowl activities for 2020 were canceled. The Shrine Hospital visit for 2021 was also canceled.

Ray and I had the girls, and their parents download the Band app so that we could get them information, have videos of the cheers, and attach files as needed. This worked very well. For 2021 we used the app, made a separate Facebook page, Facebook Messenger and email.

For the 2020 activities we had 14 girls that were going to participate. Those 14 were excited to be able to have the chance to still be a part of the activities for 2021. Unfortunately, we had 7 girls who could not participate this year. One was due to age, a few had other plans, one I never heard from, and another did not want to participate again because of how she was treated in 2019 at the banquet and game by some of the Shriners.

In planning for this year, we needed to make sure that the girls could participate in the activities and get permission from Supreme. If we wanted to do the banquet on Friday night and the events on Saturday, the Grand Council would have to pay \$5000 to Supreme and parents would have to sign a waiver. This was not something that the Grand Council could do. As a Trustee Board and EGGC it was decided that we would ask the girls if they still wanted to come for the one day of Saturday events. This was met with very mixed emotions from the girls. All of them understood that the rules given by Supreme had to be followed but wearing a mask for the entire day and while cheering was extreme. The other concerns brought up were the heat and wearing the masks; will the crowd be able to hear us; what are we getting out of it; and practice time. Generally, the girls have the night before the hospital trip, the afternoon before the banquet and before the parade. This year they would have only had about an hour and 45 minutes to practice, which they felt was not enough time to look polished. It was finally decided by the Trustees that because of the restrictions and concern for the health of the girls we would not participate in this year's Shrine Bowl events. Ray and I drafted an email and sent it to the executive director of the Shrine Bowl board and the cheer liaison.

This year was very challenging as we were on a very rushed schedule. Communication with the executive director and cheer liaison was slow as were responses to questions. This was also the first year we worked with the cheer liaison. We did not hear from her for 2020 only the executive director. I received information less than a month of when it was due. Our girls are amazing and most of them sold an ad and got their pictures in on time. In emailing with the cheer liaison, we both voiced our concerns and agreed that communication was lacking. She had many questions: how Shrine Bowl Cheerleaders, when are they chosen, what Shrine Bowl events did they participate in, when they arrived in Casper for the banquet and game, if the girls were actual cheerleaders outside of Jobies, when they practiced, what jobs do they have at the banquet and Saturday events, what our bylaws say, and if there was any interaction between the players and Shriners. I told her everything the girls participated in and that the only interaction we had with the players and Shriners is if the girls knew them.

In the past few years, the expectation of the girls has increased, and the girls have not received the recognition they have in the past. When emailing the executive director, it

was made clear that they would only pay for 10 cheerleaders, they must wear their cheer uniforms to all events except the banquet, and they must cheer the entire game and only break at halftime. Dress was also a major issue he addressed. At the banquet they cannot wear spaghetti strap, no undergarments can be showing, and the dresses must be below the knees. The dress expectations for the banquet are what we would expect our girls to wear to any meeting. I did explain that during the parade if it is cold out the girls have worn nice jeans and their Shrine Bowl shirt and if the weather is nice they have worn capris or shorts and Shrine Bowl shirts. I also agree that the girls need to cheer the entire game, however taking a quick break for water and sunscreen is a must.

While there has been talk about not participating in the Shrine Bowl events, I believe it is an experience they girls love and look forward to each year. I think that if both sides sit down and work through issues, expectations, and timelines it will be a better experience for the girls. We need to encourage the other girls to tryout and participate in something that will have lasting memories. Thank you, Alex and Erin, for being amazing leaders as captains. I know this is not how we wanted it to turn out. Ray and I would like to do something in the fall for the girls.
