




This chart shows the total general purpose revenue The Heights Charter expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for The Heights Charter is \$3,687,133.00, of which \$3,153,016.00 is Local Control Funding Formula (LCFF), \$444,515.00 is other state funds, \$49,142.00 is local funds, and \$40,460.00 is federal funds. Of the \$3,153,016.00 in LCFF Funds, \$95,305.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



The actions were effective in providing a safe and well maintained learning environment. Based on the facility needs analysis for 2021/22 it was determined that additional space was needed to accommodate all students that wished to attend on site activities. In March 2023 we were able to finalize a lease for an additional 4300 square feet. This will allow us to accommodate 100% of the students that wish to attend on site activities. Needs will continue to be assessed periodically and, if determined necessary, a search will begin to expand facilities. As an independent study charter school, we attempt to provide space for all students that wish to attend on site instruction.

Per the CAASP tests administered in the Spring of 2023, 47.56% of the students met or exceeded state standards. This is in comparison to 49.65% on the last CAASP test that was administered 2019. This shows a substantial increase from the 2022 test score of 40.24%. While we have not quite returned to pre-CoVID levels, we have exceeded our goal of 45%. Temporarily prioritizing tutoring and intervention over extra-curricular activities is proving beneficial.

The 2023 CAASP tests showed 62.81% of the students met or exceeded state standards in English language arts, as compared to 63.2% on the 2019 CAASP tests. This shows that the actions we have taken have continued to mitigate learning loss suffered during CoVID and we have made progress toward meeting our goal of 65%.

The Heights has begun using Aristotle K-12 to monitor what the children are doing on their electronic devices. The IT Manager has programed it to identify activity that meets certain criteria and flag it for a teacher or administrator to follow up with the student and parent in an attempt to curtail any cyber-bullying that is occurring.

The Heights Charter is a K-8 independent study school located in the rural foothills of San Diego County. We provide an alternative educational venue to families in the eastern portion of San Diego County serving families from seventeen communities that come from distances up to 30 miles away.

In school year 2023/24, 16.8% of the students were socio-economically disadvantaged and 13.3% were special needs.

The Heights Charter was founded to allow each student to reach their fullest potential by developing individualized learning plans.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

The Heights' offered both on site instruction and home schooling learning tools including multiple on line learning platforms. Data was regularly analyzed to identify struggling students as quickly as possible and provide them with additional tutoring. We concentrated on basics in an attempt to maintain the learning level in the core classes. As a result, per the CDE Dashboard Indicator Report, we were able to maintain ELA scores and increase math scores by 9.9%

Our testing rates were high, with participation at 99.4% in ELA, 99.4% in Math, and 100% in 8th grade science.

The input from educational partners influenced the academic strategies and decisions that were made to optimize meeting each student's academic and socio-emotional needs. Not only was this seen in the classroom, lesson plans, and interventions, but also in the professional development offerings to the staff.

An area of concern mentioned by multiple segments of the educational partners was the potential for cyber-bullying that students face. Aristotle K12 was purchased to monitor all of the activity on the school-owned electronic devises that students used even when that devise was taken home for use on lessons during independent study and homework. It encompasses student-centric filtering and reporting and student behavior analytics.

 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.

• 11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)

• This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).

• 12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)
