**APPROVE MINUTES**: A motion was made by Mr. Barnhart with a second from Mr. Mullen to approve the minutes of the January 6, 2025 meeting and the motion carried with all in favor.

## **PUBLIC COMMENTS**: None

**REPORTS**: Roadmaster: Mr. Sholtis gave his report for the month. They have completed snow removal and worked on snow equipment. The 2020 Peterbilt truck that was wrecked is at Hunter's with over \$177,000 in damages. They have been working on trucks, plows and have ordered some equipment for the plows, too.
