**MINUTES OF MORGAN TOWNSHIP
October 7, 2025**

CALL TO ORDER: At 4:00 p.m. Jeff Sholtis, Chairman, called the regular monthly meeting of the Morgan Township Supervisors to order in the municipal office building located at 1019 Third Street Extension, Mather, Greene County, Pennsylvania. The meeting opened with the pledge to the flag.

ROLL CALL: Supervisors Jeff Sholtis, Shirl Barnhart and David Novak were present. Also attending the meeting was David Saunders, Susan Nelson, David Brichetti, Cheryl Semonick, Code Enforcement Officer Mark Gordon, Solicitor Dennis Makel and Secretary/Treasurer Relda Litten.

APPROVE MINUTES: A motion was made by Mr. Barnhart with a second from Mr. Novak to approve the minutes of September 2, 2025 meeting and the motion carried with all in favor.

PUBLIC COMMENTS: None

REPORTS: Roadmaster: Mr. Sholtis gave his report for the month. The township spent a few days helping Greene and Cumberland Township's with their oil and chipping projects. Side deck mowing and mowing along roads has been done. Two deer crossing signs have been placed. Mowing was done at the Mather Park for the Mullen Walk, trees have been removed from various roads, roads have been prepped for oil and chip and the fog seal will be placed on those roads soon. Clean Up Days were held and he thanked Mr. Makel and Jeffrey Coneybeer of Jefferson Borough for their help as well and the township supervisors and workers. And the slip at Prison Road has now been taken care of.

CODE ENFORCEMENT OFFICER: Mr. Gordon gave his report for the month. He has filed 25 citations this past month, with numerous citations filed against the same individuals. He has sent five violations out and attended one hearing and one Common Pleas hearing. Four upcoming hearings scheduled for this month have been continued to a later time.

ORDINANCES, RESOLUTIONS AND LOT SPLITS: A motion was made by Mr. Novak, seconded by Mr. Barnhart to adopt the Resolution 03-2025 to have William Grimm and Associates audit the 2025 records of the township and the motion passed with all in favor.

A motion was made by Mr. Barnhart, seconded by Mr. Novak to approve the DeJohn Subdivision of 1-Lot and the motion carried with all in favor.

UNFINISHED BUSINESS: A proposal has been completed for the new security cameras and will be submitted soon.

NEW BUSINESS: A motion was made by Mr. Barnhart, seconded by Mr. Novak to have Trick or Treat on Friday, October 31st from 5 to 7 pm and the motion carried with all in favor.

Due to Election Day falling on the regular meeting day next month, a motion was made by Mr. Novak, seconded by Mr. Barnhart to move the November meeting to Wednesday, November 5th and the motion carried with all in favor.
