

RESOLUTION NO. 05 of 2022

MORGAN TOWNSHIP
GREENE COUNTY, PENNSYLVANIA

A RESOLUTION OF MORGAN TOWNSHIP, GREENE COUNTY, PENNSYLVANIA, SETTING FORTH A FEE SCHEDULE FOR VARIOUS COSTS INCURRED BY THE TOWNSHIP PURSUANT TO VARIOUS TOWNSHIP ORDINANCES, RESOLUTIONS, ETC.

WHEREAS, Morgan Township has by motion authorized various fees for permits, applications, etc. over the past number of years; and

WHEREAS, Morgan Township believes that the aforesaid fees should be set forth in a fee schedule for the purpose of accessing knowledge thereof; and

WHEREAS, Morgan Township believes that the fees set forth herein are commensurate with the costs incurred by the Township for the services rendered; and

WHEREAS, it is in the best interest of the health, safety and welfare of the residents of Morgan Township to adopt this Resolution setting forth this schedule of fees; and

NOW, THEREFORE, pursuant to the authority of the Second Class Township Code the Board of Supervisors hereby declares as follows:

(A) BE IT RESOLVED, that the fees set forth herein are commensurate with the costs incurred by the Township for the services rendered and the Township reserves the right to amend this Resolution to reflect the contemporaneous costs incurred from time to time.

(B) BE IT FURTHER RESOLVED, the following fee schedule is adopted:

SECTION 1. FEES.

| Holding Tank | \$1,500.00 – applications for nonresidential holding tanks (non-refundable) |
| Administrative Fee | A minimum of \$50.00 and additional time expense for the actions of the Township Code Enforcement officer to enforce Township Ordinances |

SECTION 2. ADDITIONAL FEES.

The Township reserves the rights to assess additional fees for expenses, costs, labor that are in excess of the fees set forth herein.

SECTION 3. ENGINEERING FEES.

In addition to the following fees set forth herein, the Township will bill the applicant for the cost of application review by the Township engineer, other consultants etc.

SECTION 4. ISSUANCE OF PERMITS.

Any and all fees as set forth herein shall be paid prior to the issuance of any/all permits.

SECTION 5. SEVERABILITY.

In the event that any provision, section, sentence or portion of this Resolution shall be held invalid, such invalidity shall not affect or impair any of the remaining provisions of this Resolution, as the provision are severable and would have been enacted had not such invalid provision been included herein.

SECTION 6. REPEALER.

All Resolutions or parts of Resolutions that are inconsistent herewith are hereby repealed.

SECTION 7. EFFECTIVE DATE.

This Resolution shall take effect and be enforced from and after its approval as provided by law.


