



Artists:

The application for the annual Reinbeck Art Festival is now open. We want you to apply and to encourage others to apply to our juried event to be held on Main Street on September 21, 2024 from 9 – 3pm. This outside festival will include art vendors; a car show that includes cars, tractors, motorcycles, and pickups; a fun photo booth, the Glampers, a beautiful display of quilts, live music, a magician, children’s art activities, and much more!

Our juried show features many of the areas finest artists. We are interested in a variety of mediums including, but not limited to, paintings, ceramics, charcoals, metal, repurposed items, drawing, fiber, and more art to intrigue the buyers!

Special incentive: After you get juried into our show for 2024, if you get a new artist to apply (Who has never applied to our show before) and that person gets juried in and lists your name as the person who got them to apply, you will receive a **finder’s coupon** the day of the festival. That 10 dollar coupon can be used to buy at the festival or turned into cash at the end of the day from the staff.

Application form:

1. Complete the required information
2. Include 3 or more digital images (ipg or pdf format) on a disc or email them or send photos. **Images need to represent 95% of what you plan to sell. If you want us to use previous photos, let us know.** We have 3 new judges this year.
3. Include a short artist statement.

Application fees:

Early Bird Special: (on or before April 1st)

Jury fee \$10; Booth fee \$25 for one space

Regular Application fee: (April 2 – July 31)

Jury fee \$10; Booth fee \$30 for one space

Late Application: (August 1 – August 31)

Jury fee \$15; Booth fee \$40 for one space

After September 1st jury fee \$30 booth space \$60 for one space.

Notification: We will try to notify each applicant within 3 weeks after receiving the application/check if they are juried in or not.

Sharing a booth? If you apply to share a booth, each applicant must be juried and accepted. Each person must pay a jury fee; the booth fee does not increase.

Enclose checks: a non-refundable jury fee, a second check for the booth fee.

Exhibitor Rules and Regulations: All work must be original & created by the artist/crafter. Kits, imports, & mass produced items are not acceptable. Your submitted images should represent 95% of your items. Any items not represented in the juried process many need to be removed. If your work is not juried in, your booth fee will be returned, the jury fee will not be returned. Bank fees: A \$25 bank fee will be charged on all returned checks. The check amount plus the bank fee is payable with a money order, cashier's check or cash. Taxes: Each exhibitor is responsible for collecting the State Sales Tax and filing a report with the Department of Revenue. Reinbeck's rate is 7%. We are required to submit names and addresses of all vendors.

Cancellations: Vendor cancellations must be in writing by mail, fax, or email at least 30 days prior to the event to get a booth fee refund.

FYI: Vendor will leave their exhibit space clean after the show. Ask festival staff to cover your booth if you need a break. The vendor's space needs to be occupied by 8:30 or it will be considered a "no show", the space will be forfeited, and there will be no refund. Please do not take up any additional space without the consent of the show staff. All vehicles must be removed from the show area by 8:30. You may park in the 3rd block and beyond of Broad and/or Blackhawk, or in the 5th block of Main Street. We want to leave ample space for shoppers!! Please do not tear down your exhibit until three, as that is your commitment to the festival. There are volleyball and soccer tournaments in town, with flyers at both stating we will be open until 3. Please aim to be completely torn down before 5pm.

You are responsible for making your booth sturdy and weighted (you will be on pavement, so you will need weights not stakes) against the wind, mild rain, etc. The City of Reinbeck/The Reinbeck Art Festival is not responsible for lost, damaged, or stolen property. Vendors will be responsible for any damage caused by unsecured tents. Volunteers will be available at 6am and return at 3pm if you request assistance the day of the show. Event staff reserves the right to make final interpretations of all rules and regulations.

Tables: We are not able to rent tables this year. You may contact the Reinbeck Hardware store at 319 788 2411 and make your own arrangements to rent from them.

Food: This is a new concept this year. Each “juried in” artist will receive a \$10 voucher to buy food from: Beans & Blooms, Dig Inn, El Camino, Nana Rosa’s, Thirteen Bricks or Trunck’s Deli or spend it buying art. The coupon is good only until 3:00pm the day of the Festival; September 21, 2024. (This means we will not be delivering food as in the past years).

Judges: We have 3 new judges this year.

Participant understands that any mass-produced item on display can cause expulsion from the show or future shows. There are no rain dates. There will be no refunds or credits if a show is canceled due to rain, floods, hurricanes, or any other forces of nature. There will be no refunds on artist cancellations. Credit will be issued if the City of Reinbeck/Reinbeck Art Festival is notified in writing at least (60) sixty days prior to the event. Exhibitors are responsible for full payment of the show fee if canceled less than 60 days prior to the event. Event staff reserves the right to disqualify any exhibitor causing any problems to fellow exhibitors or event staff. Failure to comply with the rules and regulations included in this application may result in expulsion from the event and future events. The event coordinator reserves the right to make the final interpretation of all rules. The undersigned understands that if this application is not accepted, booth fees will be returned by mail. If accepted, the City of Reinbeck/Reinbeck Art Festival has my permission to reproduce my artwork, through the images or prints I have submitted, for the purpose of advertising and marketing the Festival. The City of Reinbeck/Reinbeck Art Festival also has my permission to publish photographs or videos taken of my booth, my work and me during the Festival for purposes related to the promotion of the Festival, past or future.
