1. STUD DETAILS

- Stud Dog: 918BFC Lakesides' Empire
- Breed: American Bully
- Registry: ABKC (if applicable, insert reg. #)

2. STUD FEE OPTIONS

- Option A (Cash Paid in Full): \$1,250 due prior to breeding.
- Option B (Pick of the Litter): Stud Owner receives Second Pick Puppy from the resulting litter.
- Option C (Lock-In + Balance): \$250 non-refundable deposit to lock in stud service, with \$1,500 due at time of breeding.
- Note: Stud fees do not include semen collection, artificial insemination (AI), or shipping costs.

3. BREEDING & AI TERMS

- A minimum of three (3) live puppies at 48 hours old constitutes a litter.
- If fewer than three (3) puppies are produced, the breeding may be repeated once at no additional stud fee (original female only).
- If the original female fails to conceive, a rebreed will be granted on her next heat cycle, or the Bitch Owner may substitute a different approved female.

4. SEMEN COLLECTION & SHIPPING

- All semen extractions and shipments are the sole financial responsibility of the Bitch Owner.
- Shipping fees must be prepaid before shipment.
- The Stud Owner is not responsible for delays, mishandling, or failures once semen is shipped.

5. ON-SITE BREEDING OPTION

- Bitch Owner may bring the female to the Stud Owner's facility at: 901 N 12th St, Henryetta, OK 74437.
- Boarding Fee: No charge.
- Required Costs: \$10 per Al kit (as needed).
- Owner must provide food and any required medications for the female during her stay.
- The Stud Owner agrees to care for the female in a safe and professional manner but is not liable for illness, injury, or death outside of gross negligence.

6. FEMALE REQUIREMENTS

- Female must be in good health, free from parasites, and current on vaccinations.
- Proof of negative Brucellosis test within 14 days of breeding is required.
- Stud Owner reserves the right to decline any female not meeting health, temperament, or pedigree standards.

7. REGISTRATION & LITTER RIGHTS

- Both parties agree to complete and sign necessary litter registration forms upon successful breeding.
- No puppies may be sold without registration paperwork unless mutually agreed in writing.
- Bitch Owner agrees not to falsely represent puppies as sired by Empire if another stud was used.

8. MINIMUM ADVERTISED PRICE (MAP) - PUPPY SALES

All offspring sired by 918BFC Lakesides' Empire must be advertised and sold for no less than \$2,000 per puppy.

Exception: Puppies born with clear and agreed-upon defects (structural, health-related, or genetic) may be sold below this amount, provided:

- Both Stud Owner and Bitch Owner agree in writing on the defect.
- Said puppy is sold without breeding rights and with a spay/neuter agreement.

Enforcement: Any violation of this pricing rule will be considered a breach of contract. Breach may result in:

- Revocation of registration paperwork for the litter.
- Public notice of breach to protect the reputation of Empire's lineage.
- Legal action and damages pursued by Stud Owner.

9. LIABILITY DISCLAIMER

Stud Owner will take all reasonable precautions to ensure a successful breeding. Stud Owner is not responsible for:

- Failure of female to conceive.
- Loss of litter due to natural causes, illness, or accident.
- Veterinary expenses incurred by the Bitch Owner.

10. ENTIRE AGREEMENT

This document constitutes the full agreement between parties. No other verbal or written promises are binding unless attached as an addendum signed by both parties.
