### INTRODUCTION







Understanding that the center of a child's formation is the family, Candlewood Foundation exists to provide educational opportunities that build faith and equip individuals with life skills, empowering them to have a meaningful impact in their communities.

At Candlewood Foundation, we believe the family should be the greatest influence of a child's formation and unfortunately, this is not what most children experience today.

Children spend much of their childhood away from their parents in traditional educational institutions. To change that, we must provide a new model and give families more options. The Biblical worldview holds parents responsible for raising their children in the fear and admonition of the Lord. The Church has subscribed to society's worldview, which fails them in this mission, by actively working against it.

At the Candlewood Foundation, we envision a future where individuals are empowered with the academic and life skills necessary to thrive and become self-sufficient. We will accomplish this through various programs.



# WHY CANDLEWOOD FOUNDATION?

The American Psychological Association reports that 24% of children ages 5-11 have a mental health disorder. The American Academy of Pediatrics 2023 study states 14 million children annually are diagnosed with childhood obesity. The National Center for Educational Statistics reports 39% of Georgia 4th graders have a reading level below 3rd-grade level. These statistics are unacceptable. Conventional logic would lead us to believe that if the children are not scoring well they need more time in school; however, the opposite is true.



The average student in a traditional education model will spend 16,000 hours in school away from their families between the grades K-12. We believe there is an obvious connection between the mainstream education model and the many challenges children are facing today, and experts agree.

The local schooling options for children in our rural community are limited and the homeschooling community is growing, showing no sign of slowing down. Even with this growth, families feel underresourced and are looking for tangible support and encouragement.



- When parents have a greater understanding of their child's development, their parenting skills improve, their families flourish, and their children thrive.
- When children and adults understand the nutritional benefits of whole foods and learn how to raise and grow their own, obesity rates will decrease.
- When children are introduced to academic lessons in an environment that meets their individual needs in small, supportive groups, reading levels will rise.





The Candlewood Foundation aims to build programs that give parents better options to reclaim their God-given role in the lives of their children. We are ready, willing, and able to step in and make a difference in our community through the programs we offer, starting with **The Evergreen School**.

The Evergreen School is a comprehensive Christian homeschool hybrid program with resources to benefit the family and community, including:

## THE EVERGREEN SCHOOL

We strongly believe that children are designed by God to be active learners. Their natural curiosity and sense of wonder cannot be fully realized sitting in a classroom all day with their peers. We understand that children do not all learn at the same pace or in the same way. Education should not be focused on producing conformity but should encourage individuality. For young children, play is a critical part of learning.

At the Evergreen School, children will thrive as they learn together in our one-room schoolhouse and outside on the farm. Like a family, we will have children of mixed ages learning together naturally. Mastery of a subject is much more important than a pre-determined schedule for advancement. Executive functioning skills,



including time management, organization, and problem solving, are acquired by facing challenges and working towards a goal. Farm life is a perfect laboratory for children to advance in these skills as they learn to grow food, care for animals, and help maintain the farm.

Our lead teacher, Fonda London, is not only a highly qualified teacher, but has successfully homeschooled her own children for eight years. She graduated from UNG with a Physical Education degree and holds certifications in K-5<sup>th</sup> and special education. Like all our Board members, she and her family are active homesteaders.




