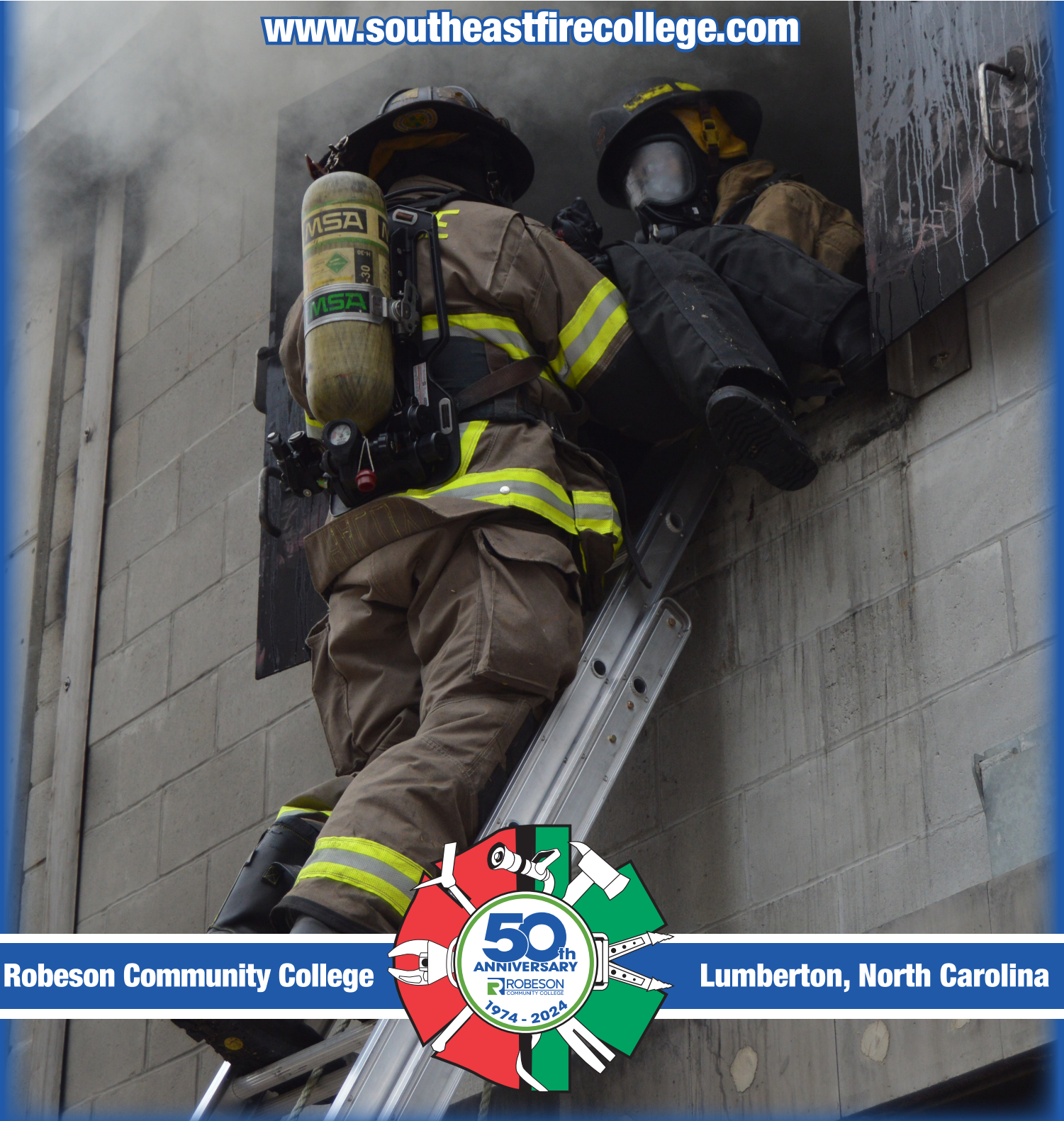

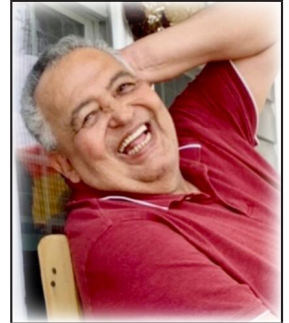

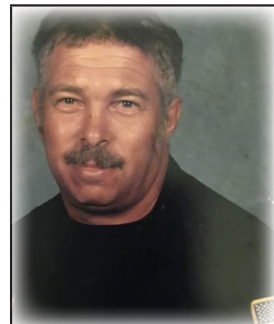

REGISTRATION INFORMATION

\$35 for NC Emergency Services Personnel – all classes

Out of state/non-affiliated students must pay an additional fee. See below:

\$70 for classes 24 hours or less.

\$125 for classes over 24 hours.

Registrations are to be mailed with accompanying payment. Mail to SEFRC, Post Office Box 1404, Lumberton, NC, 28359. Checks and money orders are to be made out to Robeson Community College. We no longer accept credit or debit cards.

When completing the registration form, use the class number to indicate your choice of classes. You can pick up to four choices. We will not accept registration forms by email or fax. Walk-in registrations are accepted with proper payment.

Class Check-in: Room assignments will be posted at the registration desk in building 13, the student center. All classes, with the exception of a few, will be held on main campus. You must be present the first day of class in order to register.

Certificates: The college does not issue attendance certificates. Certification class grades will be submitted to NC OSFM and should show on your transcript within 30 days of course completion. Students who fail a course will be notified by letter.

Emergencies: During class hours, dial (910) 272-3338.

Refunds will not be given for **any** reason with the exception if your requested class(es) do not make. If you cannot attend, another student may attend in your place provided you call ahead and notify us of the change at (910) 272-3330.

NOTICE TO STUDENTS

Effective July 1, 2019, all students participating in live fire training are required to be eighteen years of age and have met the minimum requirements for NFPA 1403. The chief or training officer of the department will be required to sign off on students who have met the minimum requirements before they can participate. A copy of the required form is located on the back of the registration form.

All students attending classes for certification through the NC Office of State Fire Marshal are required to have proper identification with them, as verification is required before being administered a certification test.



SPECIALTY NON-CERTIFICATION

1. BEING PREPARED DOESN'T MAKE YOU A PREPPER, IT MAKES YOU ACCOUNTABLE (24 hours)

Are you ready to be that firefighter? When the task needs to be done, will you sink to the level of your training or rise above and perform? Learn new skills and refine those you already have to be sharp on the fireground. Make the effort, no excuses. Class limited to 50 students.

2. UAS DRONE FOR EMERGENCY SERVICES (28 hours)

Thursday 8a-5p, Friday 8a-5p, Saturday 8a-5p, Sunday 8a-12p

This course prepares first responders for small Unmanned Aircraft Systems/Drone flight operations. This class meets the requirements for students to sit for the FAA Part 107 Remote Pilot Knowledge Test and NCDOT UAS Operator permit. The required study guide for this class is Remote Pilot Test Prep 2019 Edition, ISBN-10-1619546663. Class limited to 20 students. Instructor: Blue Mountain Drones

3. LIVE FIRE LEADERSHIP (16 Hours)

Friday 6pm-10pm, Saturday 8am-5pm, Sunday 8a-12p

This hands-on class designed for company officers involves scene size up, fire scene decision making, and fireground operations. Learn to make the right decision on the fireground. Seating limited (25).

4. FF GENERAL AND COMMUNICATIONS (24 hours)

This block of instruction covers orientation and fire service communications.

5. FF FIREGROUND OPS 2 (24 hours)

Friday 1pm-10pm, Saturday 8am-6pm & Sunday 8a-4pm

This block of instruction covers firefighter personal protective equipment.

Needs: Full PPE

6. FF FIREGROUND OPS 4 (24 hours)

Friday 1pm-10pm, Saturday 8am-6p, & Sunday 8am-4pm

This block of instruction covers tools, forcible entry and loss control.

Needs: Full PPE

7. FF FIREGROUND OPS 5 (24 hours)

Friday 1pm-10pm, Saturday 8am-6pm & Sunday 8am-4pm

This block of instruction covers ladders and ventilation.

Needs: Full PPE

8. FF FIREGROUND OPS 6 (24 hours)

Friday 1pm-10pm, Saturday 8am-6pm & Sunday 8am-4pm

This block of instruction covers ropes, knots and search and rescue.

Needs: Full PPE

9. FF FIREGROUND OPS 7 (24 hours)

Friday 1pm-10pm, Saturday 8am-6pm & Sunday 8am-4pm

This block of instruction covers water supplies.

Needs: Full PPE

10. FF FIREGROUND OPS 8 (24 hours)

11. MAYDAY AND SAFETY AND SURVIVAL (24 hours)

This block of instruction covers the criteria for Mayday and firefighter safety and survival.

Needs: Full PPE

12. FF/TR EMERGENCY MEDICAL CARE (12 hours)

Friday 630pm-1030pm & Saturday 8am until 5pm

This block of instruction covers the medical requirement for firefighter and technical rescuer.

TECHNICAL RESCUER CERTIFICATION

Students must provide appropriate personal protective equipment for all classes.

13. TR RESCUE OPERATIONS (14 hours)

Friday 7pm-10pm., Saturday 8am-4pm & Sunday 8am-12pm

This course will present the Technical Rescuer (TR) with the requirements for pre-planning, scene size-up, and hazards assessment for incidents involving rope rescue. This course will also introduce the Technical Rescuer to applicable standards addressing rope rescue, Personal Protective Equipment (PPE), accessory gear, rope software, and rope hardware. NFPA 1006 Chapters 5 and 6.

14. TR ROPE BASICS (14 hours)

Friday 7pm-10pm., Saturday 8am-4pm & Sunday 8am-12pm

This course will present to the Technical Rescuer (TR) safe and effective methods of rescue in elevated and below grade environments using ropes, knots, and rope related equipment. Mechanical advantage, anchors, anchoring techniques, and stress loads will be covered. NFPA 1006 Chapters 5 and 6.

Needs: Full Extrinsication PPE

15. TR VEHICLE VICTIM MANAGEMENT (16 hours)

Friday 630pm-1030pm, Saturday 830am-530pm & Sunday 8am-12pm

The course will present to the Technical Rescuer (TR) the safe and effective methods of rescuing a victim from a vehicle using multiple scenarios. NFPA 1006 Chapters 5 and 6.

Needs: Full Extrinsication PPE

16. TR MAG MACHINERY AND AG BLOCK (40 hours)

Wednesday 1pm-10pm, Thursday 8am-6pm, Friday 8a-6pm, Saturday 8am-6pm & Sunday 8am-1pm

REPORT DIRECTLY TO THE EMERGENCY SERVICES TRAINING CENTER

*****Class is limited to 30 students*****

This block course will present the Technical Rescuer with the knowledge, skills, and abilities to satisfy the requirements of Chapter 19 (Machinery) of NFPA 1006: Standard for Technical Rescue Professional Qualifications. In addition, this course covers agricultural-related emergencies and how to mitigate those responses.

NOTE: A NC FIRE AND RESCUE COMMISSION CERTIFICATION FOR THIS CLASS WILL ONLY BE GIVEN TO THE STUDENT WHO CURRENTLY HOLDS A TR VEHICLE AND TR ROPES CERTIFICATION.

17. PUMPS INTRODUCTION AND BASIC OPERATIONS (30 hours)

Thursday 1pm-10pm, Friday 8am-5p, Saturday 8am-5p & Sunday 8am-3pm
This block of instruction covers basic pump operations and how pumps work.

18. EMERGENCY VEHICLE DRIVER (24 hours)

Friday 1pm-10pm, Saturday 8am-6pm & Sunday 8am-4pm
This block of instruction covers classroom instruction and practical driving evolutions/
Pre-requisite: A copy of your valid driver's license must be given to instructor in class

19. PUMPS HYDRAULICS AND WATER SUPPLY (30 hours)

Thursday 1pm-10pm, Friday 8am-5p, Saturday 8am-5p & Sunday 8am-3pm
This block of instruction covers water flow and water sources.

20. PUMPS SPRINKERS, STANDPIPES AND MAINTENANCE AND TESTING (28 hours)

Thursday 1pm-10pm, Friday 8am-5pm, Saturday 8am-5p & Sunday 8am-12pm
This block of instruction covers building standpipe and sprinkler systems.

21. MOBILE WATER SUPPLY (28 hours)

Thursday 1pm-10pm, Friday 8am-5pm, Saturday 8am-5p & Sunday 8am-12pm
Don't have access to a hydrant? This block of instruction covers techniques of getting water to a fire as well as the use of dump tanks.





HAZMAT CERTIFICATION

22. HAZARDOUS MATERIALS OPERATIONS (40 hours)

Wednesday 1pm-10pm, Thursday 8am-6pm, Friday 8a-6pm, Saturday 8am-6pm & Sunday 8am-1pm

This course meets OSFM's training requirements for the Hazardous Materials Operations credential. Course content includes lecture and practice activities needed to perform the following tasks safely and effectively: (1) implement standard operating procedures in the current edition of the DOT Emergency Response Guidebook; (2) analyze hazardous materials/WMD incident; (3) plan an initial response to a hazardous materials/WMD incident; (4) implement the planned response for a hazardous materials/WMD incident; (5) evaluate the progress of the actions taken at a hazardous materials/WMD incident.

Needs: Full PPE

23. NIMS 300 (21 hours)

Wednesday 1pm-10pm, Thursday 830am-530pm & Friday 830am-230pm

This course is for persons at mid-level management serving as command staff, section chiefs, strike team leaders, task force leaders, unit leaders, division/group supervisors, branch directors, and multi-agency coordination system/emergency operations center staff.

24. NIMS 400 (15 hours)

Saturday 830am-530pm & Sunday 830am-1630pm

This advanced Incident Command System (ICS) course is designed to explain how major incidents engender special management challenges, describe the circumstances in which an Area Command is established, and describe the circumstances in which multi-agency coordination systems are established.

SPECIALTY CERTIFICATION

25. CHIEF 101 (8 hours)

Saturday 830am – 530pm

This class will satisfy the 9S inspection criteria as specified by the North Carolina Administrative Code. The primary objective of the course is to inform current and future chief officers of the various aspects and complexities surrounding the operations and organization of North Carolina fire departments. Emphasis will be placed on ratings and inspections, NFIRS reporting, prevention and grant programs, basic line-of-duty death information, financial considerations, and an overview of the various expectations facing a chief officer.

26. CHIEF 101 REFRESHER (4 hours)

Friday 600pm-10pm

Refresher course for those who have already taken the full 8-hour course.

27. FIRE OFFICER I (40 hours)

Wednesday 1pm-10pm, Thursday 8am-6pm, Friday 8a-6pm, Saturday 8am–6pm & Sunday 8am–1pm

This course identifies the performance requirements necessary to perform the duties of a first line supervisor. This course introduces the student to the basic concept of management and supervision. Upon completion, the individual will be able to supervise, instruct, and direct members of the fire department in both emergency and non-emergency situations.

Needs: Company Officer Sixth Edition IFSTA

28. FIRE OFFICER II (32 hours)

Thursday 1pm-10pm, Friday 8a-6pm, Saturday 8am–6pm & Sunday 8am–3pm

This course will present the knowledge, skills and ability to satisfy the requirements of the Chapter V of the NFPA 1021: Standard for Fire Officer Professional Qualifications. This course is designed to meet the needs of the mid-level officer/supervisor.

Needs: Company Officer Sixth Edition IFSTA

CODE ENFORCEMENT CERTIFICATION

29. LAW & ADMINISTRATION (15 hours)

Friday 7pm-10pm., Saturday 830am-5pm & Sunday 8am-1pm

This course is designed to provide a basic understanding of the governmental and legal system with which every code enforcement official works. The course satisfies the training requirements to gain admission to the state qualifying exam. Students are to furnish their own textbook "Administration Code and Policies" of the North Carolina State Building Code, latest edition.

NON-CERTIFICATION

30. EXPLOSIVES, BOMBS & BOOBY TRAPS (15 hours)

Friday 7pm-10pm., Saturday 830am – 500pm & Sunday 800am-1pm

This class takes Emergency First Responders (EMS, Fire, Law Enforcement, and Rescue) through basic understandings of explosives, explosive environments and understanding how they function. The latest Improvised Explosive Devices (IEDs) being employed overseas and domestically, how they are constructed, the damage they can cause, and how they are being used by terrorists against first responders. Also, what first responders can do to ensure their safety against this new threat. The course will take the students through bomb threats, searches, and booby traps, all of which they may encounter in their jobs. It will also discuss ways to discover terrorist methods, activities and the latest cases and ways they can help stop future events in the U. S. This course will be presented through classroom instruction and practical exercises including bomb searches, booby trapped trails, and live explosive demonstrations.

31. FATAL FIRE INVESTIGATIONS (12 hours)

Saturday 830am – 500pm & Sunday 800am – 1pm

This course aids in all parts of fire and law enforcement investigations into any type of fatal fire and will go over many avenues of responsibility of each party and will help everyone with the scene and follow up.

32. NFPA 1403 ACADEMY (22 hours)

Friday 1pm-10pm, Saturday 8am-6pm & Sunday 8am-1pm

This course is designed for the firefighter with little or no experience. Basics to be covered include fire streams, SCBA, hose practices, building construction, ladders and fire behavior. Practical applications will be used. This class meets the minimum qualifications for NFPA 1403.

Needs: Full PPE to include SCBA and spare bottle.

33. LAND NAVIGATION (20 hours)

Friday 6-10 p.m., Saturday 8 a.m. – 7 p.m., & Sunday 8 a.m. – 2 p.m.

This class will consist of the use of GPS and compass over terrain and how to determine your location while on a mission. There will be practical exercises for the student to become familiar with both of these tools for search activities.

Needs: Compass

34. NC RATING RESPONSE SYSTEM (12 hours)

Saturday 830am – 500pm & Sunday 800am-1pm

A representative from the NC Department of Insurance will discuss the new rating response system program and how it relates to the ISO system. Learn how your department will be rated in the future.

Needs: Calculator, paper, No. 2 pencils, map of your service area with all hydrants, and apparatus inventories on all trucks in your department.

35. RESCUE SCUBA DIVER (22 hours)

Friday 6pm-10pm, Saturday 8am-9pm & Sunday 8am-3pm

This rescue diver certification is designed to develop the knowledge and necessary skills for an individual to effectively perform diver rescues and assists.

Note: Class will meet on main campus Friday evening and be at off site locations Saturday and Sunday.

36. FIRE AND EMS TRACK (FOUR CLASSES AT FOUR HOURS EACH)

Friday 6pm-10pm Traffic Incident Management Systems (41a)
Saturday 8a-12p Fire and Ambulance Driver Simulator (41b)
Saturday 1p- 5p Hazardous Materials Refresher/Blood Borne Pathogens Refresher (41c)
Sunday 8a-12p Electric Vehicles Presentation (41d)

Note: You can register for the entire block of classes, or register only for the class you need. There is only one registration fee if you take the block. Registration fee still applies if you take only one or two of these classes.

37. EXTRICATION 101 (14 hours)

Friday, 6p-8p, Saturday 8a-5p, Sunday 8a-12p

This is a hands-on class which new techniques are taught regarding vehicle stabilization and extrication.

Needs: Full Extrication PPE

38. THE FIRST DUE TRUCK COMPANY (14 hours)

Saturday 8a-5p, Sunday 8a-3p

This class covers strategies and tactics of the first due truck on working fires. Topic includes scene size-up, forcible entry, search and rescue, ladders and ventilation.

Needs: Full PPE to include SCBA and spare bottle.
