Per your request, we inspected the roof at the above address. The membrane is a modified bitumen roofing system on the flat areas and composition shingles on the walls and steep roofing sections. Buildings A, C, D, and G DO NOT have a coat of coating. Buildings B, E and F HAVE a coat of coating on the flat areas and roof walls. The roof is in poor condition. See below different available solutions. All work shall be in conformance with this contract, local building codes and the manufacturer's installation guidelines.

## **OPTION 1:**

## FLAT ROOF - CERTAINTEED FLINTLASTIC 2-PLY TEAR-OFF 12 YR MATERIAL WARRANTY

Tear-off the 1 layer of the existing roofing and haul away.

Check the roof deck for defects and rotten wood. Extra charge item \$150.00 per sheet plywood applied, if needed.

Install polyiso board insulation, 1" thick on the entire flat area roof surface. R-Value 5.7.

All standard penetration flashings and scupper drains will be replaced with new to match the existing.

Mechanically fasten a 28# fiberglass base sheet to the roof deck with 1-1/4" square head roofing nails.

Install 1 layer of Flintlastic GTA Class B fire-rated APP modified bitumen cap sheet.

All corners laps, wall transitions and parapet tops are made watertight with a three-course application of urethane roof coating and polyester fabric. Matching roofing granules are broadcast in for durability.

#### **Parapet wall - Composition Shingle Roof**

Install 1 Layer of DiamondDeck synthetic roof underlayment on the entire roof surface.

Install Landmark roofing Certainteed composition shingles with roofing nails according to manufacturers specifications. Weave shingles in all valleys and flashing tie-ins.

The parties agree that arbitration must be initiated within one year after the claimed breach occurs and the failure to initiate arbitration within the one-year period constitutes an absolute bar to the institution of any proceedings.

ATTORNEY'S FEES: In the event that it is necessary for either party to engage the services of an attorney regarding the breach of this Agreement by the other, the enforcement of the terms hereunder, or a declaration of the rights and duties hereunder, the prevailing party, in addition to the other rights it may have, shall be entitled to all costs incurred in connection therewith including actual attorney's fees and costs of action "Prevailing party" is defined as the party with the net monetary recovery, a defendant in whose favor a dismissal is entered, and a defendant where neither plaintiff or defendant obtain any relief
