Minutes of the prior month's meeting were distributed by email to the general membership about one week prior to the General Meeting. Minutes were approved by Angie Jones and Dan Greenzweig.

Treasury –Harold Jones provided the Treasurer's Reports for the months of June and July 2023, given we did not meet in July. The club started the month of June with a balance of \$7,599.35. We finished the month of June with \$7,249.09, and we finished the month of July with a balance of \$6,981.21.

The income over the last two months can be summarized as \$175 in membership dues and \$144 in clothing special orders. The expenses over the last two months can be summarized as \$711.14 in clothing special orders and \$226 for the USPS post office box rental. In theory, the clothing specials orders should balance out when all is said and done, but we did order some extra men's and women's jackets based on club member demand and expect to fully recoup that money in the next couple of months.

This month (August), the club has already paid \$241 for the club liability insurance annual premium and paid the \$10 filing fee for the annual report that was due to the Arizona Corporation Commission. The current club balance is \$6,681.77.

The cost has increased to \$30 per person and will include raffle prizes, a DJ, a dance floor, a white elephant gift exchange and homemade desserts.
