

## TERMS OF USE

Thank you for visiting our website [www.beachhousemanagementnj.com](http://www.beachhousemanagementnj.com) (the "Site") owned and operated by Beach House Management LLC ("Beach House Management," "we," "us," or "our"). Except as otherwise noted herein, these terms and conditions ("the Terms") govern your use of the Site and our mobile application. Please read these Terms carefully, because your use of the Site constitutes your agreement to follow and be bound by these Terms. If you do not agree to these Terms, you should not access or use the Site. Beach House Management reserves the right to make changes to the Site and to these Terms from time to time. When we make changes, we will post them here. For this reason, we encourage you to review these Terms whenever you use our Site because by visiting the Site, you agree to accept any such changes. Beach House Management provides you with access to and use of the Site subject to your compliance with the Terms.
