1. Policy Statement

At **Seren Kids Ltd**, we are committed to providing high-quality childcare in a safe, nurturing, and stimulating environment for children aged **4 to 11 years**. Although we operate outside of normal school hours, we fully support the principles and requirements of the **Statutory Framework for the Early Years Foundation Stage (EYFS 2024)**.

Our provision focuses on:

- Promoting children's well-being, safety, and happiness.
- Supporting their **personal**, **social**, **and emotional development**.
- Providing **play-based experiences** that complement, not duplicate, school learning.
- Working closely with parents, carers, and schools to ensure continuity of care and development.

2. EYFS Exemption Statement

Seren Kids Ltd operates as an **out-of-school and holiday childcare provider**. As defined in the **EYFS 2024 framework (section 1.5)**, we are **exempt from the Learning and Development Requirements** of the EYFS because:

- We provide care only before and after school and during school holidays.
- The children we care for **normally attend a maintained school or other early years setting** during term time.

Therefore, we are **not required to deliver or assess** the EYFS learning and development requirements, such as planning for the seven areas of learning or completing EYFS profiles.

However, Seren Kids Ltd **fully implements the Safeguarding and Welfare Requirements** of the EYFS to ensure that:

- Every child is cared for in a **safe**, **secure**, **and inclusive environment**.
- Our activities support social, emotional, and physical development through play, exploration, and relaxation.
- Staff maintain positive relationships with parents and schools to support children's overall well-being.

3. Aims and Objectives

Seren Kids Ltd aims to:

- Offer a **relaxed**, **inclusive**, **and enriching play environment** for all children.
- Encourage **choice**, **independence**, **and cooperation** through varied activities.
- Promote **healthy lifestyles** through active play and nutritious snacks.
- Ensure all staff understand and implement **EYFS safeguarding and welfare** requirements at all times.

4. Supporting Children's Development Through Play

Our provision complements, rather than replicates, school-based learning. We promote learning through **play**, **social interaction**, **and exploration**.

Prime Areas	How We Support
Communication and Language	Encouraging conversation, storytelling, and group discussions during free play and snack times.
Physical Development	Offering outdoor play, sports, arts, crafts, and movement games that promote coordination and fitness.
Personal, Social and Emotional Development	Supporting friendships, teamwork, and self-confidence through cooperative play and daily reflection.

Specific Areas	How We Support
Literacy	Providing books, reading corners, story sessions, and writing materials.
Mathematics	Engaging children in counting, measuring, cooking, and problem-solving games.
Understanding the World	Exploring nature, celebrating cultural events, and themed holiday activities.
Expressive Arts and Design	Encouraging creativity through arts, crafts, music, dance, and imaginative play.

5. Safeguarding and Welfare

Seren Kids Ltd follows the **Statutory Safeguarding and Welfare Requirements** of the EYFS and our own **Safeguarding and Child Protection Policy**.

We ensure that:

- All staff hold **enhanced DBS checks** and appropriate safeguarding training.
- At least one **Paediatric First Aider** is present at all times.
- Staff-to-child ratios meet or exceed EYFS requirements.
- Children are safely signed in and out by authorised adults.
- Allergies, medical needs, and dietary requirements are clearly recorded and respected.

6. Inclusion and Equal Opportunities

Seren Kids Ltd welcomes all children and families.

We value diversity and ensure that every child feels included, respected, and supported. Reasonable adjustments are made to meet individual needs, and we work with parents, carers, and external professionals when necessary.

Adjustments are made where needed, and we work with parents and professionals to meet individual needs.

7. Partnership with Parents and Schools

We recognise parents and carers as children's **first educators**.

- We maintain **open communication** through daily feedback, newsletters, and displays.
- We **liaise with schools** to ensure our activities complement children's learning and personal development.
- Parents are encouraged to share information about their child's interests, achievements, or any additional needs.

8. Behaviour and Emotional Well-being

We promote positive behaviour by encouraging respect, kindness, and cooperation. Staff act as role models and use praise and encouragement to reinforce good behaviour. Where necessary, behaviour is managed calmly and consistently, in line with our Behaviour Management Policy.

9. Staffing and Training

Our staff team is committed to providing a **safe, caring, and stimulating** environment. All staff receive induction and ongoing training, covering:

- EYFS principles and statutory requirements
- Safeguarding and child protection
- Behaviour management
- Health and safety
- Food hygiene

We actively encourage **continued professional development** to ensure best practice

All staff receive induction and CPD covering EYFS principles, safeguarding, behaviour management, health & safety, and food hygiene.

Georgina McCoy is Head of EYFS Policy and training and oversees the development of policy and operational decisions and development in regards to EYFS provision at Seren Kids Ltd. Hannah Clifford, Managing Director will oversee the operations of any policy implementation within settings.

Each EYFS-aged child (under 5) has a key person recorded in their file and shared with parents. This will usually be someone who they can have a continuous point of contact with ie Hannah Clifford or Omar Green.

However, due to the fluctuating irregular nature of after school clubs and holiday camps each day will also have a dedicated person named for the day to be in charge of overseeing care of EYFS children and communication with parents at the door. This will be made known to parents via a "EYFS worker today" sign post at the drop off and collection point.

10. Monitoring and Review

This policy will be reviewed annually or sooner if guidance changes.

Staff qualifications and ratios

We adhere to statutory EYFS ratios and ensure at least one member of staff with a full and current Paediatric First Aid qualification is present at all times.

Suitable premises, environment, and equipment

Our facilities are safe, secure, and appropriate for the ages of children attending. Daily risk assessments are carried out, and play areas are inspected before use.

Health and safety

A Health and Safety Policy governs cleaning, food hygiene, illness management, and accident procedures.

Our **Behaviour Management Policy** encourages respect,

All accidents and incidents are recorded and shared with parents
on the same day. Records are retained and reviewed for patterns.

Medication and

Medication is only administered with written consent. Medical

Snacks are healthy, balanced, and appropriate to dietary

requirements. Fresh water is available at all times.

Premises security and collection Children are signed in and out. Only authorised adults can collect, and late/non-collection procedures are in place.

Key persons ensure children feel safe, valued, and included during sessions. They share daily updates with parents.

New staff complete a structured induction and are supervised until competent. Supervisions and appraisals support ongoing quality

and well-being.
