

This document has been drawn-up to establish confidentiality over information and processes shared in the pursuit of *change* for the client, hereafter referred to as the receiving Party. The receiving Party accepts and agrees that signing this document is confirmation of absolute and complete acceptance of the terms of disclosure as in the sharing of information and processes as detailed below.

It is further acknowledged by the Receiving party that they grasp in some way, the reasoning and high importance of this agreement, based on the understanding that IT will ensure the necessary building of the foundation of understanding in relation to the Divine Nature of Process and the Truth of who You are.

This establishes the direction and path way of personal growth. As desired by the Receiving Party.

## Non-Disclosure Agreement (NDA)

This Non-Disclosure Agreement (the "Agreement") is entered into as of [ ] , by and between:

- **Disclosing Party:** Truth Love Happiness, operating through truthlovehappiness.com, with its principal place of business at [Insert Address if Known; Otherwise, Omit or Use Registered Address] (hereinafter referred to as the "Disclosing Party"), and

## Recitals

WHEREAS, the Disclosing Party offers a program known as the TLH Programme, which is a Spiritual Hypnotherapy program designed to facilitate holistic awareness, personal change, and mental well-being through hypnosis, sessions, and related practices, as described on the website truthlovehappiness.com;

WHEREAS, the Receiving Party wishes to participate in the TLH Programme and, in connection therewith, will have access to certain Confidential Information (as defined below);

WHEREAS, the Disclosing Party desires to protect such Confidential Information from unauthorised disclosure or use;

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

## 1. Definition of Confidential Information

"Confidential Information" shall mean any and all information, in any form or medium, disclosed by the Disclosing Party to the Receiving Party in connection with the TLH Programme, including but not limited to:

- All content, materials, teachings, and resources provided as part of the TLH Programme;
- All practices, techniques, methods, and processes utilised in the TLH Programme, including hypnosis sessions, group or private interactions, and any philosophical or therapeutic approaches;
- The fact of the Receiving Party's enrolment, participation, or involvement in the TLH Programme;
- Any other proprietary information related to the Disclosing Party's operations, clients, or the delivery of the TLH Programme.

Confidential Information shall not include information that: (a) is or becomes publicly available through no fault of the Receiving Party; (b) is rightfully received by the Receiving Party from a third party without restriction on disclosure; or (c) is independently developed by the Receiving Party without reference to the Confidential Information.

## 2. Obligations of the Receiving Party

The Receiving Party agrees:

- a. To hold the Confidential Information in strict confidence and not to disclose, communicate, publish, or otherwise make available any part of the Confidential Information to any third party, in whole or in part, without the prior written consent of the Disclosing Party. This prohibition expressly includes any mention of enrolment or participation in the TLH Programme.
- b. To use the Confidential Information solely for the purpose of participating in the TLH Programme and not for any other purpose, including personal gain, commercial exploitation, or sharing with others.
- c. To take all reasonable measures to protect the secrecy of and avoid disclosure or unauthorised use of the Confidential Information, including measures at least as protective as those used for the Receiving Party's own confidential information of similar importance.
- d. To immediately notify the Disclosing Party in writing of any actual or suspected unauthorised use or disclosure of the Confidential Information.

## 3. Duration

The obligations under this Agreement shall remain in effect indefinitely, or for as long as the Confidential Information remains confidential and proprietary to the Disclosing Party, whichever is longer.

## 4. No License or Ownership

Nothing in this Agreement grants the Receiving Party any right, title, or interest in the Confidential Information. All Confidential Information remains the exclusive property of the Disclosing Party.

## 5. Remedies

The Receiving Party acknowledges that any breach of this Agreement may cause irreparable harm to the Disclosing Party for which monetary damages may be inadequate. Accordingly, the Disclosing Party shall be entitled to seek injunctive relief, in addition to any other remedies available at law or in equity, without the need to post a bond.

## 6. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with all jurisdictional laws adhered to by the Disclosing Party (truthlovehappiness.com), which the Receiving Party hereby accepts and honours without exception. The Receiving Party irrevocably submits to the exclusive jurisdiction of the courts in the jurisdiction(s) where the Disclosing Party operates or adheres to such laws for any disputes arising out of or related to this Agreement.

## 7. Miscellaneous

- a. **Entire Agreement:** This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements.
- b. **Amendments:** No amendment or modification shall be effective unless in writing and signed by both parties.
- c. **Severability:** If any provision is held invalid, the remainder shall continue in full force.

d. **Assignment:** The Receiving Party may not assign this Agreement without the Disclosing Party's written consent.

e. **Counterparts:** This Agreement may be executed in counterparts, each of which shall be deemed an original.
