#### **Approval of Minutes - Jean**

Rob made a motion to accept the minutes from the August Board meeting. Paul seconded and the minutes were approved unanimously.

#### **Treasurers Report - Steve**

CV account balance on September 30, 2025 was \$11,491.57.

Expenses for August and September included \$200 for the club luncheon at Brent's house in July, \$50 for the Gordy Ride, \$200 for 4 gift cards to be raffled at the club luncheon at Eureka Restaurant, \$544 to

Eureka Restaurant for luncheon, \$1117.00 for the kit subsidy to Zoca, and a \$3500 donation to Ride the Point. There was no charge for the September Pit Stop.

#### Membership - Nancee

#### **Advocacy Report - Paul**

San Diego bicycle Club (SDBC) is changing their position on bikes. They have recently passed new club rules allowing bikes under certain conditions.

E-motorcycles masquerading as e-bikes have become more prevalent and police departments in many San Diego County cities are starting to ticket riders and confiscate vehicles that are on the road illegally. There are very few of these vehicles that can be licensed for use on the road, and California does not license any. One brand, Surron, is being produced with a VIN number and the capability to be made road legal. Currently there may be a few states that are licensing them.

# **Clothing Report - Rob**

Rob reports that in the last order there were a few items that had issues. Returns to Zoca for repairs did not go as well as Rob had hoped they would. Considering that issues with Zoca continue to be a problem, the club is still considering changing to a new supplier.

#### **New Business**

**Ron Guitard**, a long time San Diego cyclist, died unexpectedly in his sleep on September 21, 2025. Ron was active in many aspect of cycling. He was a member of SDBC and SDVA, a licensed cycling instructor (LCI), and cofounder of ReBIKESD, among other cycling related activities. His generosity and kindness will be missed.

1. Nominations Committee for 2026 CV Board - David While our bylaws state that a nomination list is to be presented to the board no greater than one month prior to the expiration of the fiscal year (5.1), I have not yet heard of any potential board members for 2026. Voting for the 2026 board will take place at our January regular membership meeting & lunch. It is requested that all members of the current board state their intent for 2026. In the event that there are not at least 5 nominees, specifically including a nominee for president & treasurer (4.1) we need to have a discussion of options moving forward. There is also a need for a letter to be drafted & sent to the general membership stating these options.

Steve indicated that he would run for treasurer for 2026.

Armen indicated that he would run for the sponsorship position for 2026.

David will write a letter to be sent to the general membership asking for candidates and explaining that if Board positions can not be filled for 2026, then the club will disband. If that turns out to be the case, David asked how many of the current Board members would be willing to stay on in 2026 to close the club. All present agreed to stay on until the club is officially disbanded.

# 3. Ride the Point - David
