### **Secretary's Report**

Minutes from June 10, 2024 and July 08, 2024 meetings were approved unanimously following motions by Bruce, with seconds by Paul.

### **Treasurer's Report**

Stu reported an account balance on August 31, 2024, of \$13,087. Stu offered his resignation, effective October 1, 2024. Don made a motion to have Steve Schmidt fill the interim treasurer position until the end of the year. Paul seconded. The motion passed unanimously and Steve accepted the nomination.

### **Membership Report**

David reported that the club currently has 78 members.

### **Bike Coalition Report**

Paul reported that he is no longer a Board member of SDCBC and, therefore, is not as actively involved in the Coalition. He also believes SDCBC is not a good fit for many bicycle clubs, including Cyclo-Vets. Having said that, Paul thinks that Cyclo-Vets should pressure SDCBC to advocate for clean bikeways. Steve reported that he observed a bikeway cleaner on the I-15 bike path. Paul believes that the California Association of Bicycle Organizations (CABO) represents the interests of Cyclo-Vets better. Cyclo-Vets is currently a member of CABO.

### **Clothing Report**

Rob reported that he needs sponsor logos for 2025 clothing. David suggested that the 2024 jersey design be used for 2025. Don suggested that a white jacket and vest with logos be included for 2025 so they can be used for more than one year. It was suggested that sponsors not be included on the jacket or vest.

David reported that Selle Atomica is organizing a ride through Poway on October 20. At this time, there are two routes planned - 22 and 35 miles.
