

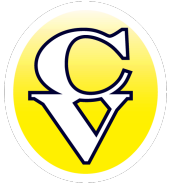

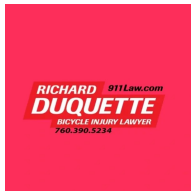

Approval of Minutes - Jean

Nancee made a motion to approve the minutes from the February 10, 2025 BOD Meeting. Steve seconded and the motion passed unanimously.

Treasurer's Report - Steve

Steve reported a balance of \$15,973.36 on 03/31/2025. Detailed accounting sheets were emailed to all Board members prior to the meeting. Eight new renewals were received, along with \$500 from sponsor Pemberley Reality. \$396 was spent on the UPS Store annual mailbox rental.

Clothing Report - Rob

Rob asked if the club would be offering a 25% discount to members who purchase clothing when the store opens in June. Following discussion, Jean made a motion to offer a 25% discount to members who order club clothing in June 2025. Mary Jo seconded the motion and it was passed unanimously.

Rob reported that since Karla left Zoca, he has been very disappointed with his interactions with her replacement, Sebastian. Sebastian has been slow in responding to Rob's contacts and has not followed up on the markups. Rob will continue to work with Zoca and try to get the order ready for the June store. Rob will email the two latest designs to the Board for review.

Membership Report - David

David reported 53 members plus sponsorship memberships as of April 14, 2025.

Zoom abruptly ended our meeting. David was able to start a new meeting by 6:26 PM. Steve will check the CV Zoom account to see if it is still active.

Bike Coalition Report - Paul

Paul reported that the cleaning of bikeways continues to be an issue. Cyclo-Vet members can report dirty bikeways and other road issues at getitdone.sandiego.gov or on the Get It Done App. Paul reported that Governor Newsome has signed the complete streets bill, which cities are required to follow. David reminded Board members that Class IV bikeways are not part of the street and not covered in this bill.

New Business

Steve reported that Leon Sowers, a longtime Cyclo-Vet, is home from the hospital following mini strokes and an infection that damaged the heart valve he had replaced a number of years ago.
